I am 22 years old and was born on [REDACTED], I live at [REDACTED]

I have been informed that under the penal code of the State of Texas, Section 37.02: A person commits the offense of perjury if, with intent to deceive and with knowledge of the statements meaning: he makes a false statement under oath or swears to the truth of a false statement previously made, and the statements is required or authorized by law to be made under oath.

I was at ACATV and was leaving when 4 or 5 men aged from 19 to 23 got in my face and started taunting me calling me punk and jar head. They looked like counter culture generation x types. They were dressed differently. Some were wearing suits, one was green, one was wearing black. There were two dressed in jogging suits. I believe the jogging suits were grey green and blue. I said why do you call me at home and on the air and say you want to kill me. The leader said yea jar head it is me. I'm not a dumb ass like you. I don't put myself out in front. I'm hidden. No one knows who I am. I can do what I want and get away with it. I was trying to get to my car, and they followed me. I put my video camera in the car and turned to face them. The largest of the attackers was wearing the grey green jogging suit. He hit me in the nose with his right hand with no warning. He was a large latin anglo mix type about six feet two inches and 180 pounds. I did nothing because I saw that to his left the ring leader with the strange eyes had a double edged military type killing knife. He had it about half way out of his suit pocket. I knew who he was because of what he said, how he said it and because he calls on the live tv shows on ACTV and talks about how he wants to kill me and how I am a fucking piece of shit etc. etc.

I have been told and have seen him call "night talk" a TV show on Thursday nights and say that his is coming to my home to kill me. This happened about one month ago. But back to the assault I saw that the ring leaded had very large knife. The thug that had already hit me was hopping around and calling me a pussy and I said "What is your problem I have done nothing to you." That is when he struck me the second time. Blood was flying and streaming from my nose and mouth.. I then realised that they were encircling me and the others were coming closer. I ran back across the parking lot and the person that hit me twice came out from his gang. People were coming out in numbers from the ACAC TV studio and I said lets get their tag number. The tag number is [REDACTED]. The perpetrators were starting to get in the astro type van. W came about 35 feet from it to see the tags and the big man who had hit me came running up and hit me again. I defended myself. I hit him in the face, he came forward to hit me again and I hit him one more time I believe. He fell to his knees, I then was going back to the building when Charly, a person who had joined them in taunting me came up and was laughing at me say you got your ass kicked. Bob that runs ACAC at night came out and I said call the police they have a knife and charly said you are a liar. He had nothing defending his buddy or what ever they were. I then said fuck you liar and blood spray and saliva spewed on him. He then hit me. I hit him back. Bob told me he saw this and that he told the police this but the police put in in the report that I was assaulted and that then I hit Charly without provocation. This is not true. Charlys girl friend was in the main building so he went in to get her and when the police came he told them bull that I had hit him first but the mutual witness said that he hit me first but that was still not put in the report. I was very scared, shook up and angry by this time. My lip was busted, my nose was bleeding

oobiously and my cheeks and jaws were swollen and bruised. The ring leader goes by Clayton or Steve, He is the one that has called me at home and told me graphically that he wants to kill me. I have made a complaint when this has happened informally a number of times and we have contacted the FBI. He has harassed many people over the past years. His voice is very easy to remember It is I would say a houston type accent. He is very strange looking. He has eyes that look like a goats. He has dark brown hair. that is shoulder length. He was wearing a dark green suit with a grey overcoat hanging open. He is the one who brandished the knife when big on was hitting me. He has pasty white green skin. I did not pay much attention to the other two. This person takes hours and hours to hassle me. He is obscessed with me. I am not an easy person to scare but I believe that he bears me incredible malice. I am in fear of losing my life. My father Dr David R Jones screens calls for me and he recognizes this persons voice and mode of action. He has made death threats about me to my father. He has said he would like to sodomise my mother. He has he is coming to my house to slit my throat and has told me what I drive and where I live and now he has actually shown me the weapon. This has been escalating for six months and I am really worried. I have been told that his web site name is anathema. Please stop this individual or he will hurt me and others.
