This forensic hardware and software product is specifically for mobile devices such as cell phones. This product provides a quick and secure transfer of mobile data for storage, physical data extraction, including the recovery of deleted messages. This system extracts data from around 2,000 devices and is one of the leading cell phone extraction tools.
