## AFFIDAVIT AND REQUEST FOR ARREST WARRANT

## TO ANY JUDGE OF THE DISTRICT COURT OR COMPLAINT JUSTICE

I, Detective Michael V Bickford, a duly sworn and authorized police officer, say that I am a Deputy Sheriff for the County of Kennebec, and that I have probable cause and do believe, based on information and belief that:

On, BUBAR, SCOTT ALLEN date of birth 05/13/1977 did commit the crime of Aggravated Reckless Conduct with a Dangerous Weapon (Title 17A Sec. 213) in the State of Maine, County of Kennebec, Town of \*\*\*\*\* Belgrade us

Your affiant believes that probable cause exists based upon the following information in which your affiant believes to be true.

- 1) On 05/19/2017 at approximately 2135hrs Patrol Deputies received a call from the Regional Communications Center advising they had received a call stating neighbors can be heard fighting and the caller states the "son" is beating on his Father's car.
- 2) Approximately 2143hrs the caller reported hearing a gun shot.
- 3) Approximately 2157hrs Sgt Jacob Pierce of the Kennebec County Sheriff's Office arrives on scene and reports two people are inside the residence located at 1003 Oakland Rd in Belgrade and states they are barricading the house.
- 4) Approximately 2200hrs Pierce states he sees an individual come to a window carrying a rifle or shotgun. Pierce advises the individual is making threats then breaks the window and threatens to shoot. At this time the State Police Tactical Team is notified.
- 5) Approximately 2207hrs Pierce states at least 2 individuals are inside the residence and claims they are barricading doors and windows and states one of the individuals made a reference to "going down in a blaze of glory".
- 6) Approximately 2218hrs it is reported that hollering from inside the residence can be heard then gun shots are heard from inside the residence.
- 7) At this time officers on scene begin evacuating nearby residence's then again at 2224hrs more gun shots are heard. 2225hrs again gun shots are heard from inside the residence of 1003.

- 8) During this time multiple gun shots can be heard from inside the residence then a female can be heard crying also from inside the residence then a male screaming. The female from inside the residence then calls in to the RCC and states someone had been shot. The female identifies herself as Jenny Shorey. Shorey states there are 3 people in the home, 2 males and 1 female and says that she is bedridden in the living room area of the home. Shorey also tells RCC the males are Scott and Roger Bubar. Shorey states "Scott" has been shot but can be heard making noises. Shorey states both Scott and Roger are in the "left side" of the trailer.
- 9) Shorey continues to pass information from inside the residence and states Scott claims he cannot move then stops answering questions or responding to her. A short time later Shorey reports Scott is bleeding badly and claims both Scott and Roger have been shot. Shorey states Roger is not responding to her and claims Scott is now yelling again.
