THERE IS A COURT ORDER FROM THE PROBATE DIVISION OF MIAMI-DADE COUNTY CIRCUIT COURT (FILE NO. 12-4330-GD) TITLED "ORDER AUTHORIZING HOSPITAL VISITATION BETWEEN THE WARD AND THE PETITIONER" IN PLACE. THE COURT ORDER GRANTS ONLY VISITATION BETWEEN THE VICTIM AND THE VICTIM'S DAUGHTER (DEFENDANT, BARBARA STONE) AND ONLY DURING SPECIFIED TIMES. THE ORDER PROHIBITS THE DEFENDANT FROM "IMPEDING, INTERFERING OR DISRUPTING THE HOSPITAL/REHABILITATION FACILITIES STAFF'S ABILITY TO PERFORM THEIR DUTIES AND TREAT H [REDACTED] S [REDACTED]". THE COURT ORDER APPOINTS TWO CO-GUARDIANS FOR THE CARE OF H [REDACTED] S [REDACTED]. ADDITIONALLY, H [REDACTED] S [REDACTED] HAD 24 HR. AIDES TO ASSIST IN HER CARE. ... H[REDACTED] S[REDACTED] HAS NUMEROUS MEDICAL CONDITIONS TO INCLUDE [REDACTED].  ON TODAY'S DATE AT APPROXIMATELY 1030 HRS., THE DEFENDANT ENTERED THE PALM GARDENS NURSING HOME TO VISIT HER MOTHER. DURING A PERIOD OF TIME THAT THERE WERE NO AIDES PRESENT, THE DEFENDANT TOOK THE VICTIM OUT OF THE NURSING HOME WITH A WHEEL-CHAIR AND PLACED THE VICTIM INTO HER VEHICLE AT APPROXIMATELY 1110 HRS. THE DEFENDANT THEN LEFT THE PROPERTY OF THE NURSING HOME IN AN UNKNOWN DIRECTION. THIS WAS IN DIRECT VIOLATION OF THE COURT ORDER.  THIS PLACED THE VICTIM'S LIFE IN JEOPARDY AS SHE REQUIRES NUMEROUS MEDICATIONS AND HAS TO BE FED VIA THE FEEDING TUBE WITH A PRESCRIPTION.  INVESTIGATORS WITH THE AVENTURA POLICE DEPARTMENT LOCATED THE VICTIM AND THE DEFENDANT AT THE COMFORT SUITES HOTEL, 1800 S. FEDERAL HIGHWAY, FT. LAUDERDALE. THE VICTIM WAS CLEARED VIA FIRE-RESCUE AND SUBSEQUENTLY TRANSPORTED TO THE AVENTURA HOSPITAL FOR A MEDICAL EVALUATION AND THEN TO BE ULTIMATELY RETURNED TO THE PALM GARDENS NURSING HOME.  THE DEFENDANT VOLUNTARILY CAME BACK TO THE AVENTURA POLICE DEPARTMENT TO BE INTERVIEWED. THE DEFENDANT READ, SIGNED AND WAIVED HER RIGHTS PER FORM. THE DEFENDANT ADMITTED [REDACTED] [REDACTED]  THE DEFENDANT WAS PLACED UNDER ARREST FOR THE ABOVE CHARGES AND TRANSPORTED TO T.G.K.
