



**AMENDED NOTICE OF OPPOSITION**

Dear Sir or Madam:

Opposer, Sisco Textiles N.V., a Curacao corporation, believes it will be damaged by registration of the mark shown in U.S. Trademark Application Serial No. 87023698 (“the Application”) filed May 3, 2016 by Thaddeus O’Neil LLC (“Applicant”), and therefore opposes the same. A description of the Application is as follows:

 Alleged Date of First Use: Intent to use for Class 18; November 27, 2012 first use and May 23, 2013 first use in commerce for Class 25

As grounds for opposition, it is alleged:

1. Since at least as early as 1957, decades prior to the filing date of Applicant's Application and prior to Applicant's alleged date of first use, Sisco, its predecessors-in-interest, licensees and affiliates (collectively "O'Neill"), have designed, developed, marketed, manufactured, promoted and sold a variety of products and offered a variety of services in connection with the well-known name and mark O'NEILL and other marks containing or consisting of the terms O'NEILL (collectively, the "O'NEILL Marks") throughout the United States.

2. Among the goods and services that O'Neill has offered or is offering in connection with the O'NEILL Marks are clothing, apparel, footwear, headwear, surf apparel and gear, snowboarding and skiing apparel and gear, surf equipment and other sporting equipment and sporting goods, sports protective gear, lifestyle wear, swimwear, beach wear, goggles, sunglasses and eyewear, bags, backpacks, luggage, wallets, purses, totes, duffle bags, paper products and stickers, towels, jewelry and personal ornaments, key chains, various other related goods, accessories and parts for all the foregoing goods, videos, bars and restaurants, servicing and repairing the aforementioned goods, online social media, online forums and social networking, retail and online retail store services, customer services, advertising and promotion of competitions and events, sporting, education, fundraising and entertainment events, activities, demonstrations and competitions as well as sports teams and the sponsorship of sporting and athletic events and athletes (hereinafter collectively referred to as "O'Neill's Goods and Services").

3. O'Neill is the owner of and relies on United States Trademark Registration No. 1,069,298 (the "'298 Registration") for the mark O'NEILL for diving suits, wet suits and dry suits in International Class 9, water skisuits in International Class 25, surf boards in International Class 28 which was registered on the Principal Register on July 12, 1977. The '298 Registration is based on

an application filed in the PTO on May 23, 1975 and claims a date of first use of 1975 in International Classes 9 and 28 and December 9, 1973 in International Class 25. Thus, the dates of first use, application, and registration of the mark shown in the '298 Registration are all prior to the date Applicant filed Applicant's Application and Applicant's alleged date of first use. By virtue of O'Neill's compliance with the provisions of 15 U.S.C. § 1065, O'Neill's right to use the mark shown in the '298 Registration is incontestable. A true and correct copy of the specifics of the '298 Registration obtained from the PTO's TSDR database is attached hereto and made of record.

4. O'Neill is the owner of and relies on United States Trademark Registration No. 1,183,040 (the "'040 Registration") for the mark O'NEILL for sports Clothing-Namely, Shirts, T-Shirts, Trousers and Jackets in International Class 25, which was registered on the Principal Register on December 22, 1981. The '040 Registration is based on an application filed in the PTO on January 25, 1980 and claims a date of first use of February 27, 1976. Thus, the dates of first use, application, and registration of the mark shown in the '040 Registration are all prior to the date Applicant filed Applicant's Application and Applicant's alleged date of first use. By virtue of O'Neill's compliance with the provisions of 15 U.S.C. § 1065, O'Neill's right to use the mark shown in the '040 Registration is incontestable. A true and correct copy of the specifics of the '040 Registration obtained from the PTO's TSDR database is attached hereto and made of record.

5. O'Neill is the owner of and relies on United States Trademark Registration No. 1,339,268 (the "'268 Registration") for the mark O'NEILL for hats, caps and gloves in International Class 25, which was registered on the Principal Register on June 4, 1985. The '268 Registration is based on an application filed in the PTO on April 27, 1984 and claims a date of first use of July 1979. Thus, the dates of first use, application, and registration of the mark shown in the '268 Registration are all prior to the date Applicant filed Applicant's Application and prior to Applicant's alleged dates of first use. By virtue of O'Neill's compliance with the provisions of 15 U.S.C. §

1065, O'Neill's right to use the mark shown in the '268 Registration is incontestable. A true and correct copy of the specifics of the '268 Registration obtained from the PTO's TSDR database is attached hereto and made of record.

6. O'Neill is the owner of and relies on United States Trademark Registration No. 1,367,364 (the "'364 Registration") for the mark O'NEILL and Design for wetsuits, water ski suits, shirts, and jackets in International Class 25, which was registered on the Principal Register on October 29, 1985. The '364 Registration is based on an application filed in the PTO on April 27, 1984 and claims a date of first use of July 1979. Thus, the dates of first use, application, and registration of the mark shown in the '364 Registration are all prior to the date Applicant filed Applicant's Application and prior to Applicant's alleged dates of first use. By virtue of O'Neill's compliance with the provisions of 15 U.S.C. § 1065, O'Neill's right to use the mark shown in the '364 Registration is incontestable. A true and correct copy of the specifics of the '364 Registration obtained from the PTO's TSDR database is attached hereto and made of record.

7. O'Neill is the owner of and relies on United States Trademark Registration No. 2,204,582 (the "'582 Registration") for the mark O'NEILL and Design for athletic bags, backpacks and wallets in International Class 18, wetsuits, hoods for water sports, wearing apparel, namely, shirts, pants, shorts, jackets, hats, caps and skiwear, namely, pants, jackets in International Class 25 which was registered on the Principal Register on November 17, 1998. The '582 Registration is based on an application filed in the PTO on November 13, 1995 and claims a date of first use of January 1, 1997. Thus, the dates of first use, application, and registration of the mark shown in the '582 Registration are all prior to the date Applicant filed Applicant's Application and prior to Applicant's alleged dates of first use. By virtue of O'Neill's compliance with the provisions of 15 U.S.C. § 1065, O'Neill's right to use the mark shown in the '582 Registration is incontestable. A true and correct copy of the specifics of the '582 Registration obtained from the PTO's TSDR



database is attached hereto and made of record.

8. O'Neill is the owner of and relies on United States Trademark Registration No. 2,425,804 (the "'804 Registration") for the mark O'NEILL for retail store services featuring wearing apparel and products for use in aquatic sports such as surfing, swimming, water skiing and diving in International Class 35 which was registered on the Principal Register on January 30, 2001. The '804 Registration is based on an application filed in the PTO on May 7, 1999 and claims a date of first use of 1958. Thus, the dates of first use, application, and registration of the mark shown in the '804 Registration are all prior to the date Applicant filed Applicant's Application and prior to Applicant's alleged dates of first use. By virtue of O'Neill's compliance with the provisions of 15 U.S.C. § 1065, O'Neill's right to use the mark shown in the '804 Registration is incontestable. A true and correct copy of the specifics of the '804 Registration obtained from the PTO's TSDR database is attached hereto and made of record.

9. O'Neill is the owner of and relies on United States Trademark Registration No. 3,939,936 (the "'936 Registration") for the mark O'NEILL for Substances for laundry use, namely, laundry detergent; cleaning, polishing, scouring and abrasive preparations; soaps; perfumery; essential oils; cosmetics; dentifrices; sun tanning oils and sun tanning creams in International Class 3, surfboard accessories, namely, sails, sail bags in International Class 6, Apparatus for recording, transmitting and or reproduction of sound or images; magnetic recording media, namely, video cassettes, audio CDs, CD-ROMs, CD-Is, laser, optical disks and CDs for photographs; sound recording disks; automatic vending machines and mechanisms for coin-operated apparatus; cash registers, calculating machines, data processing and computer equipment; fire-extinguishers; sunglasses; spectacles; spectacle frames and accessories not included in other classes, such as lenses for sunglasses, spectacle cords and cases; diving suits; diving goggles and masks for underwater sports; wet and dry suits for diving and underwater swimming; underwater breathing apparatus;

protective clothing for aquatic pursuits; protective helmets; gloves for protection against accidents; diving gloves; emergency life-saving and teaching apparatus, namely, lifejackets in International Class 9, Precious metals and their alloys and goods in precious metals or coated therewith, namely, jewelry, watches and key rings; jewelry; precious stones; horological and chronometric instruments; clocks, watches in International Class 14, Paper, cardboard and goods made from these materials, namely, stickers; bookbinding material; photographs; stationery; adhesives for stationery or household purposes; paint brushes; plastic materials for packaging, namely, plastic bags; printers' type; printing blocks; playing cards; books in the field of surfing, watersports and skiing; newspapers; time planners; calendars; posters; posters/bills; writing pads; note books; pencils; pens; pen cases; printed matter, namely, advertising materials in International Class 16, Leather and imitation leather and goods made thereof, namely, luggage, suitcases, travel bags, shoulder bags, handbags, purses, wallets and belts; bags, namely, backpacks, rucksacks, duffle bags, fanny packs, athletic bags, shoulder bags, handbags, book bags, shopping bags of leather, imitation leather and textile; suitcases; travel bags; sports bags; beach bags; banana pouches; rucksacks and shopping bags; umbrellas and parasols; pocket wallets and purses; animal skins and hides; trunks; walking sticks; whips and saddlery in International Class 18, Clothing, namely, shirts, t-shirts, pants, jackets, skirts, shorts, board shorts, swimwear, swimming trunks, swimsuits, sweatshirts, sweaters, socks, scarves; footwear; snow boots; sports shoes; leisure shoes; booties for water sports; oriental slippers; slippers; sandals; headgear, namely, hoods, caps, cap peaks and hats; sports and leisure wear, namely, wetsuits, dry suits, gloves, wetsuit boots, and skiwear, namely, coats, jackets, pants, gloves and boots; protective clothing for surfing, windsurfing and water skiing, as well as for other water sports, namely, wetsuits, dry suits, wetsuit boots and gloves; rash guards in International Class 25, Surfboards and accessories therefor, namely, sails, sail battens, tensioning apparatus for sails, sail bags, masts, mast feet, booms, fins, fin cases, trapezes, surfboard leeboards, surfboards leashes,

The '936 Registration is based on an application filed in the PTO on December 11, 2009. Thus, the dates of application, and registration of the mark shown in the '936 Registration are both prior to the date Applicant filed Applicant's Application and prior to Applicant's alleged dates of first use. A true and correct copy of the specifics of the '936 Registration obtained from the PTO's TSDR database is attached hereto and made of record.

10. O'Neill is the owner of and relies on United States Trademark Registration No. 4,251,127 (the "'127 Registration") for the mark O'NEILL HYBRID for Clothing, namely, t-shirts, shorts, board shorts, swimwear, swimming trunks, swimsuit in International Class 25, which was registered on the Principal Register on November 27, 2012. The '127 Registration is based on an application filed in the PTO on September 6, 2011 and claims a date of first use of December 25, 2007. Thus, the dates of first use, application, and registration of the mark shown in the '127 Registration are all prior to the date Applicant filed Applicant's Application and prior to Applicant's alleged dates of first use. By virtue of O'Neill's compliance with the provisions of 15 U.S.C. § 1065, O'Neill's right to use the mark shown in the '127 Registration is incontestable. A true and

correct copy of the specifics of the '127 Registration obtained from the PTO's TSDR database is attached hereto and made of record.

11. O'Neill's Federal Registrations are derived from applications filed in the PTO on dates prior to the filing of Applicant's Application. O'Neill's Federal Registrations are valid and subsisting. In view of the substantial similarity of the respective marks and the related nature of the goods and services of the respective parties, it is alleged that the mark in Applicant's Application so resembles the registered marks in O'Neill's Federal Registrations, previously used in the United States and not abandoned, as to be likely to cause confusion or to cause mistake or deceive.

12. O'Neill's use of the O'NEILL Marks has been valid and continuous since at least as early as the dates of first use indicated above and have not been abandoned. The O'NEILL Marks are symbolic of extensive goodwill and consumer recognition built up by O'Neill through time and effort in advertising and promotion.

13. In addition to providing various products, O'Neill also offers live and prerecorded videos, photographs and other information and materials about O'Neill's Goods and Services on its website [www.oneill.com](http://www.oneill.com).

14. O'Neill also has a Youtube channels located at <https://www.youtube.com/user/TeamONEill> on which it promotes and advertises O'Neill's Goods and Services. Further, O'Neill uses various forms of social media, including, but not limited to, Instagram, Tumblr, Twitter and facebook to promote O'Neill's Goods and Services. O'Neill has over 2 Million followers.

15. Since at least as early as the dates of first use alleged above, O'Neill has consistently used the O'NEILL Marks in interstate commerce. The O'NEILL Marks, by virtue of substantial use, have acquired great value as an indicator of O'Neill and O'Neill's Goods and Services, and distinguish them from the goods and services of others.

16. Since at least as early as the dates of first use stated above, O'Neill has used the O'NEILL Marks in connection with the sale and promotion of O'Neill's Goods and Services. Such use has been valid and continuous, and has not been abandoned.

17. Since the dates of first use stated above, O'Neill has used the O'NEILL Marks. Such use has been valid and continuous, and has not been abandoned. The public has come to associate O'Neill with the O'NEILL name and mark.

18. Since a date well prior to the filing date of Applicant's Application, O'Neill has used the O'NEILL Marks. Such use has been valid and continuous, and has not been abandoned. As a result of this use, well prior to the filing date of Applicant's Application, the public has come to associate O'Neill with the O'NEILL Marks.

19. O'Neill has invested substantial amounts of time, effort and money in the O'NEILL Marks throughout the United States. By reason of O'Neill's widespread and continuous use of the O'NEILL Marks, in addition to the protection afforded by the federal registrations and applications, O'Neill has extensive, non-registered statutory and common law rights in the O'NEILL Marks.

20. O'Neill has long owned and used the O'NEILL Marks. O'Neill, through substantial expenditures of time and efforts as well as sales, advertising, marketing and the promotion of O'Neill's Goods and Services under the O'NEILL Marks for decades prior to the filing date of Applicant's Application, O'Neill has built up valuable and extensive consumer recognition and goodwill symbolized by the O'NEILL Marks.

21. O'Neill's Goods and Services have been provided to a wide range of consumers.

22. O'Neill's Goods and Services have received widespread success.

23. Throughout O'Neill longstanding and extensive use of the O'NEILL Marks in connection with O'Neill's Goods and Services, the O'NEILL Marks have become exclusively

associated with O'Neill and O'Neill's Goods and Services.

24. Throughout O'Neill's longstanding and extensive use of the O'NEILL Marks in connection with O'Neill's Goods and Services, the O'NEILL Marks have become well-known and famous for O'Neill's Goods and Services.

25. In view of the substantial similarity of the respective marks and the related nature of the goods and services of the respective parties, it is alleged that Applicant's mark so resembles the O'NEILL Marks previously used in the United States, and not abandoned, as to be likely to cause confusion, or to cause mistake or deceive.

26. If Applicant is allowed to register the mark in Applicant's Application, Applicant's corresponding prima facie exclusive right to use the mark O'NEILL nationwide will conflict with O'Neill's lawful and prima facie exclusive right to use the O'NEILL Marks nationwide.

27. Applicant is the owner of Applicant's Application.

28. Applicant's Application was filed on May 3, 2016.

29. Applicant's Application claims a date of first use of November 27, 2012 for the goods in Class 25.

30. Applicant's Application claims a date of first use in commerce of May 23, 2013 for the goods in Class 25.

31. The goods in Class 18 in Applicant's Application are based on Applicant's bona fide intention to use the mark in commerce.

32. The filing date of Applicant's Application is well after O'Neill date of first use alleged above.

33. The filing date of Applicant's Application is after the dates of first use claimed in O'Neill's Federal Registrations detailed above.

34. The date of first use claimed in Applicant's Application is well after O'Neill date

of first use alleged above.

35. The date of first use in commerce claimed in Applicant's Application is after the dates of first use claimed in O'Neill's Federal Registrations detailed above.

36. In view of O'Neill's prior rights in the O'NEILL Marks, Applicant is not entitled to registration of the mark THADDEUS O'NEIL pursuant to Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

37. Applicant's mark THADDEUS O'NEIL is likely to cause confusion with the registered marks identified above. Additionally, Applicant seeks registration for goods identical or closely related to O'Neill's Goods and Services, as well as the goods and services identified in O'Neill's registrations, detailed above. As such, when the mark THADDEUS O'NEIL is used on or in connection with the goods identified in Applicant's Application, it is likely to cause confusion, or to cause mistake or to deceive within the meaning of Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

38. Applicant's mark THADDEUS O'NEIL is likely to cause confusion with the registered marks identified above. Additionally, Applicant seeks registration for goods that are identical to or closely related to some of O'Neill's Goods and Services, as well as the goods and services identified in O'Neill's registrations, detailed above. Applicant's THADDEUS O'NEIL mark and use thereof is likely to cause confusion in, or to cause mistake by, or to deceive the trade and purchasing public into believing that Applicant's goods originate with O'Neill or are otherwise authorized, licensed or sponsored by O'Neill.

39. Applicant's mark THADDEUS O'NEIL is likely to cause confusion with the O'NEILL Marks. Applicant seeks registration for goods closely related to O'Neill's Goods and Services. As such, when the mark THADDEUS O'NEIL is used in connection with the goods identified in Applicant's Application it is likely to cause confusion, or to cause mistake or to deceive

within the meaning of Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

40. The mark in Applicant's Application is likely to deceive by falsely suggestion a connection with O'Neill.

41. The mark in Applicant's Application is likely to deceive by falsely suggestion a connection with O'Neill's Goods and Services.

42. The mark in Applicant's Application is likely to deceive by falsely suggestion a connection with the goods and services in O'Neill's Federal Registrations.

43. The mark in Applicant's Application is likely to cause confusion with the O'Neill portion of the mark in O'Neill's Federal Registrations.

44. The mark in Applicant's Application is likely to cause confusion with O'Neill's Goods and Services.

45. The mark in Applicant's Application is likely to cause confusion with the goods and services in O'Neill's Federal Registrations.

46. The mark THADDEUS O'NEIL is substantially similar in commercial impression to the marks in O'Neill's Federal Registrations.

47. The mark THADDEUS O'NEIL is substantially similar in commercial impression to the O'NEILL Marks.

48. The term O'NEIL in the mark in Applicant's Application and the O'Neill mark are similar in sight and sound.

49. Applicant's "brand builds a unique appreciation for American fashion through the oceanic bohemian lens of surfing."

50. Founder and Creative Director, Thaddeus O'Neil, was raised surfing on Eastern Long Island. Thaddeus O'Neil, the founded of Applicant, main source of inspiration and creative release is still surfing off the beaches of Fire Island, NY and the surrounds.



51. Founder and Creative Director, Thaddeus O'Neil, designs with the abandon and rebellion customary of surf culture.

52. The top photograph on the website printout attached hereto as Exhibit A shows a surfboard.

53. The photograph attached hereto as Exhibit A is a true and correct copy of a page from Applicant's website.

54. The video "SS'14 Trailer" posted on Applicant's website shows surfboards, wave and people carrying and driving with surfboard.

55. The video "AW '14 Trailer" posted on Applicant's website shows waves and people surfing.

56. The video "Sea Vision" posted on Applicant's website shows waves and people surfing.

57. Applicant uses images of waves to promote its goods.

58. Applicant uses surf boards to promote its goods.

59. Applicant uses surfers to promote its goods.

60. Applicant uses images of people with surf boards to promote its goods.

61. Among the consumers of Applicant's goods are surfers.

62. Applicant's goods are directed towards people that surf.

63. The term O'NEIL in the mark in Applicant's Application and O'NEILL Marks are similar in sight and sound.

64. The term O'NEIL in the mark in Applicant's Application and term O'Neill in O'Neill's Federal Registrations are similar in sight and sound.

65. Based on the goods identified in Applicant's Application, Applicant's goods will be competitive with O'Neill's Goods and Services.

66. Based on the goods identified in Applicant's Application, Applicant's goods will be competitive with the goods and services in O'Neill's Federal Registrations.

67. Based on the goods identified in Applicant's Application, Applicant's goods will be related to O'Neill's Goods and Services.





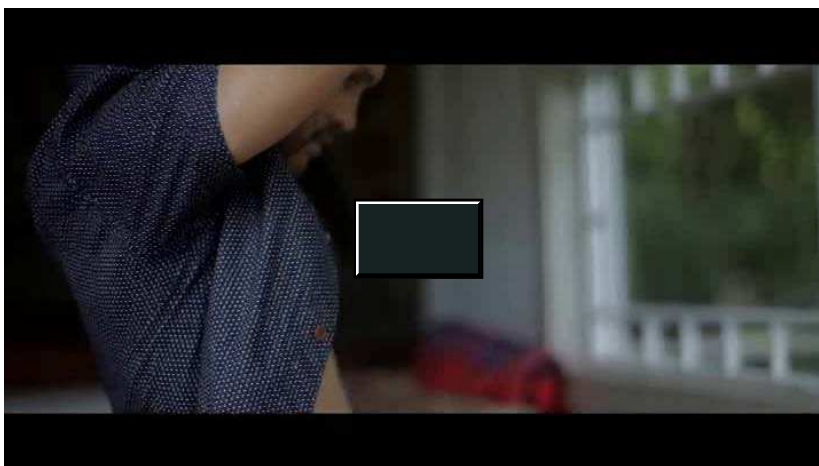
