Expenses calculated based on receipts and submitted and divided by two trucks and also attributed to Mario Alba, not secondary drivers.]

The penalties are based on Plaintiffs JOSE ALBA and MARIO ALBA'S per diem wage rate. This per diem rate is then multiplied by the number of days of nonpayment following the date the wages became due, up to a maximum of 30 calendar days. *Mamika v. Barca* (1999) 80 Cal.Rptr.2d 175. Here, since payment still has not been made, the per diem rate is multiplied by 30 days for a total of \$8,648.10 owed to Plaintiff JOSE ALBA and \$5,067.90 owed to Plaintiff MARIO ALBA on section 203 penalties.
