Dear Mrs. Stettin, ATTN: Mr. Sewell, I am requesting under FSS. 119:

- 1) Copies of the total amount of billing to date, whether filed/invoiced or not, related to the representation of Murguido in this defamation per se case. These records are not exempt under any provision of FSS. 119. If you need help finding case law since apparently Zeskind does, I will provide it for you.
- 2) All records/statutes/contracts that allow you to accept Homestead tax dollars to represent Murguido in his individual capacity in this defamation case. The statute Zeskind argued in the FSS. 119 lawsuit, i.e. FSS. 111.07, does not apply.
