Officers responded to 9917 Capstan Drive for the report of person(s) shot. Upon my arrival, there were multiple people out side screaming for help and stated the shooter's had run south on Redskin Drive. I made entry into the house and discovered nine adults and children had been shot. The victims where lying on the floor and on the couch in the front living room of the home. A female victim was seated on the couch and appeared to be deceased. I confirmed the suspects had fled and requested mutilple squads to respond. I then requested additional units to provide a perimeter and canine units responded to the scene. The scene was taped off with crime scene tape and secured. Medics arrived on scene and began to move the victims outside to treat them. One female victim was pronounced deceased on the scene. The remaining victim's where transported to University of Cincinnati Medical Center and Cincinnat Childrens Hospital. Officer's then responded accordingly to the hospitals. I then contacted Detectives to respond to the scene for the investigation and evidence processing. Upon further investigation, a pistol was located in the front yard of the home, it was later discovered that it belonged to the homeowner. Multiple descriptions were given of the shooter's. At this point the investigation was turned over to Detectives.

First, on behalf of Colerain Township, I want to express our deepest sympathies for the victims and families involved in last night's tragedy.

At 11:21pm last night, the Colerain Police Department responded to a call for shots fired in the 9900 block of Capstan Drive. Upon arrival, our officers discovered 9 people who had been shot inside a residence.

The Colerain Township Department of Fire and Emergency Medical Services, along with assistance from other local partners, transported the victims to area hospitals. Sadly, one victim was pronounced deceased at the scene.

The victims included three children, ages 8, 6 and 2 who were taken to Children's Hospital and have non-life threatening wounds. The conditions of the other 5 victims at this time are all believed to be non-life threatening

Our Criminal Investigative Unit is working hard to follow up on leads and interview witnesses. At this time we have no suspect information to pass along. This will obviously be our entire focus moving forward.

I would like to thank the surrounding police and fire departments for their assistance last night, and especially the Cincinnati Police Department who continues to be a tremendous partner whenever we need assistance.
