C – No, (confirming address)

D – (Address), your husband was just shot?

C – No, my boyfriend, he was just shot, oh please help him.

D – Are you saying he was just SHOT?

C – Yes, Yes, he’s shot, just shot him.

D – Ok

C – He just shot him.

D – Ok, is the person that... is he still there?

C – No, he just left, honey, honey, honey.

D – What’s the phone number you are calling from in case we get disconnected?

C – Um, on my cell. (confirms number).

D – The person that just shot him, are they there now?

C – They left in a truck.

D – Ok, which way did they head, north or south?

C – I don’t know, down the street to the right I think, I don’t know.

D – Do you know what it was for a vehicle description?

C – (Unable to translate beginning of response) Hurry, please, please, oh my God, Honey stay with me.

D – Do you know who it was?

C – I am not from here; I'm from (Location).

D – He left in a truck?

C – Yes, have you got somebody coming here?

D – Yes, my partners are starting everyone. Answering these questions will only help you and will not delay the response, do you understand? Now, like I said, my partners are starting everyone, ok? I am trying to get a description so we can catch this guy. Do you know what color it was for a vehicle?

C – Silver Truck

D – What kind of truck? Do you know if it headed towards Skowhegan or Madison?

(Pause)

D – Do you know if it headed towards Skowhegan or Madison?

C – What?

D – The truck, did it head towards Skowhegan or Madison?

C – I don't know which way, I don't know which way.

D – You don't know which way he went?

C – No, I don't know which way he went.

D – Ok, how old is your boyfriend?

C – Um, he's (Confirms age).

D – Alright, is he awake?

C – No

D – I'm sorry.....

C – No, he's bleeding.

D – Is he breathing?

C – No he's.... what?

D – Is he breathing?

C – No, yeah, it's hard to, I don't know.

D – Ok

C – No, honey, don't leave me.

D – Is there serious bleeding?

C – It's all around, yes (expletive) Oh, honey.

D – Ma'am, is there anyone else there with you?

C – No. No, his heart is not moving.

D – Alright, I need you to do CPR. Can you listen to my instructions?

C – Yes

D – Alright, I need you to lay him flat on his back.

C – He's on his back.

D – Put the heel of your hand on his breastbone right between the nipples. Push down hard with your hand, ok? So put one hand right on his chest between the nipples and the other hand on top of it, ok? Pump the chest hard and fast twice per second, 2 inches deep.

C – I can do this honey, got to get all this blood out of here.

D – (To another dispatcher in the room) all I have is a Silver Pickup Truck, no other information.

D – (To caller) can you give me anything else about the Silver Pickup Truck? Any stickers or anything you saw on it?

C – No, that's it. You want me to do chest compressions?

D – Yes

D – Do you know if it was a white male or black male or what the guy might have looked like?

Call Number 2 (0748 hrs.)

Dispatcher (D) – 911, what is the address of the emergency?

Female Caller 1 (F1) – (talking to someone in the background), what is the address?

F1 – (address), my daughter just came back

D – Alright, what is the address that you are at?

F1 – I am at (address), my daughter just got here.

D – (Confirming address) ok in what town?

Unknown party in background at residence shouts the address of the reported incident.

F1 – (confirms what was said) they are not here, they are on the (address) but he just killed his family. My daughter's boyfriend's father just killed them. My daughter got out of there. She just got here and is telling us right now.

D – Ok and you are at (address)?

F1 – Yes, this happened on the....

D – Ok, I am listening to that.....

F1 – I don't know what's going on

D – Ok, please stop talking for a second; you are at (address of caller)?

F1 – Yes, Sir.

D – Ok, (caller address confirmed) and this is about an incident at (confirm incident location)?

F1 – I guess so, that's where my daughter just came from.

D – Ok, ok and was she a witness to the shooting?

F1 – (caller to person in background) was you a witness, did you see it?

Background – the is so unreal

D – Ok, yes or no answer.

F1 – Yes

F1 - (to person in the background) he got him?

D – OK

F1 – Oh my (expletive). Wow

D – Ok, who did the shooting?

F1 – They're, (name)

D – (Confirms name)

F1 – Yeah

D – Where is he right now?

F1 – From what my daughter tells me, he's there and was going to kill himself.

D – He was still at the residence when she left?

F1– Yes, he told her he wasn't going to hurt her and she got out of there.

D – Ok and what is your daughter's name?

F1 – (caller gives daughter's name)

D – Ok and what is her first name?

F1 – (Caller spells first name)

D – Ok and what is her date of birth?

F1 – (Caller gives daughter's date of birth)

D – Ok and she saw the shooting?

F1 – Yeah, he shot her boyfriend in the head with her laying right beside him. (Caller to someone in the background) You'll have to tell the Detectives.

D – Who is the person shot?

F1 – (Caller to someone in the background) what is his Mom's name?

F1 – (Caller gives names of persons shot)

D – (Second victim's name) was also shot?

F1– Yeah (Male voice in background – No, the girl was not shot)

D – (First victim's name) was the only one shot?

F1 – (Caller talking to multiple people in the background)

D – Ok let me talk to your daughter please.

F1 – Ok hold on.

F2 – Hello

D – Hi, ok how many people were shot?

F2 – 2 when I left and he said he was going to kill himself

D – Ok, 2 were shot (First victim's name) and who else?

F2 – (Caller gives second victim's name)

D – Did you see her get shot?

F2 – No, I didn't, but I heard it. That's the only reason me and my boyfriend were sleeping and then his Mom starting running through the house screaming and that's when jumped up and he didn't even make it out the bedroom door.

D – Ok (Caller's name) you are not injured right now?

F2 – No.

D – My partners are talking with the people in Madison on the other end, that's why there will some pauses, but we're trying to get further information. You're safe right there where you are?

F2 – Yes

D – And, (Suspect's name) did he say where he was heading? He said he was going to shoot himself?

F2 – Yeah, I walked out the door and I think he was headed to his bedroom.

D – He was headed towards his bedroom? He lives there also?

F2 – Yeah

D – (To another dispatcher in the room) (Suspect's name) lives there also.

D – (To caller) Do you know what (Suspect's name) drives for a vehicle is he left?

F2 – He has a black truck and a blue Mustang and (Second victim's name) has a silver Jeep.

D – Ok he has a black truck and blue Mustang?

F2 – Yeah

D – Ok and (Second victim's name) has a silver Jeep?

F2 – Yeah

D – Ok what is the phone number you are calling me from right now?

F2 – (Caller gives phone number)

D – OK just want to make sure that's right because I am going to have people getting in touch with you, ok? If you would stay there, ok, where you are, you're safe and just keep your doors locked and if for any reason you see (Suspect's name), or for any reason he should come there call us back immediately, ok?

F2 – Ok

D – I am going to have people get in touch with you. They are at the scene on the other end right now and they are going to take care of that end, ok?

F2 – Ok

D – Alright, so (Caller's name), you just stay there and stay safe. Like I said, keep an eye out until we get hold of you, ok?

F2 – Ok

D – Alright then, bye now.
