THIS MATTER comes before the Court on Plaintiff's Motion for Finding Defendant in Contempt of Court. The Court has considered the plaintiff's motion, the defendant's response (if any), the plaintiff's reply (if any), and all supporting declarations and exhibits.

Based upon the foregoing and pursuant to RCW 7.21.010(1)(b) and RCW 7.21.030(2)(c)-(d), the Plaintiff's motion is hereby GRANTED. The Court ORDERS, ADJUDGES and DECREES that:

1. The Defendant is found in contempt for disobeying the Order dated October 27, 2015, by not removing the following three (3) web addresses containing the unlawful contents:

3 2. The Defendant is further found in contempt of Court for publishing the following  
4 additional false and libelous blog posts, which are nearly identical to the ones in the  
5 previous Order, against the Plaintiff in December 2015 and January 2016 in the  
6 following five (5) web addresses:

15 their contents in their entirety, and refrain from republishing them anywhere in the  
16 future.

17 4. The Defendant will no longer be found in contempt of court if she removes the  
18 <sup>four (3)</sup> ~~eight (8)~~ above web addresses and their contents and refrains from republishing  
19 them.

20 5. Because this court expressly finds that any viable sanction would likely be  
21 ineffectual to terminate the continuing contempt of court by the Defendant due to her  
22 residing out of the State, it is ordered that the entity that owns or operates the digital  
23 platform(s) used by the Defendant to publish the unlawful contents cooperate with  
24

1 this Order and take action to remove the above eight (8) web addresses from Internet  
2 search results.
