

DECLARATION OF CAROLINE HELDMAN

1 I, CAROLINE HELDMAN, hereby declare as follows:

2 1. I am an Associate Professor of Politics at Occidental College in Los Angeles and
3 was a regular guest commentator on Fox Broadcasting and Television Network when Woody
4 Fraser was an Executive Producer there. The following facts are within my personal
5 knowledge and if called as a witness, I could and would competently testify thereto, under
6 oath.

7 2. In 2010, Woody Fraser was my mentor at Fox television network. He used coded
8 language (an "arrangement") on three different occasions, once in New York and twice in Los
9 Angeles, that he wanted to have a sexual relationship with me. I repeatedly rejected his
10 advances.

11 3. In a July 4, 2010, in an email regarding a dinner, Mr. Fraser stated "you r [sic]
12 quite a woman. Kindred or not. But I do feel as tho [sic] we have known each other forever."
13 Attached hereto as Exhibit A is a true and correct copy of this July 4, 2010 email.

14 4. Then in a July 29, 2010 email, Mr. Fraser wrote me the following: "Hi. You are
15 amazingly beautiful and so very intelligent. Good thing im [sic] married and you r [sic] taken. I
16 vote for a move East." Attached hereto as Exhibit B is a true and correct copy of this July 29,
2010 email.

17 5. On August 19, 2010, Mr. Fraser and I were corresponding via email. In one of his
18 emails to me, he wrote "too bad you don't like older guys anymore." Attached hereto as Exhibit
19 C is a true and correct copy of this August 19, 2010 email.

20 6. On January 15, 2011, in response to an email I sent Mr. Fraser asking for advice on
21 how to become a contributor on Fox, he wrote "Regarding 'Contributors'-we just lopped off
22 over 30. My push is younger-attractive-specifically smart with life expectancy of 5 years on
23 Fox. Gee? I wonder who we know who would fit that description?????? [sic]" Attached hereto
24 as Exhibit D is a true and correct copy of this January 15, 2011 email. Mr. Fraser insinuated on
25 several occasions that a contributorship at Fox was contingent upon me having a sexual
26 relationship with him. Even though I was a popular guest with numerous appearances and high
27 ratings (according to Mr. Fraser), I was not offered a contributorship because I rebuffed Mr.
28 Fraser's sexual advances.

7. On June 21, 2010, I pitched a show to Mr. Fraser called "The Green Room." He

1 then pitched my show idea to Roger Ailes and it became Fox's show "The Five." We discussed
2 the specifics of the show for nearly a year. In July of 2011, I met with Mr. Fraser shortly after
3 the show was approved to see if I would be hosting the show, which I assumed I would since I
4 came up with the idea. During the meeting, he asked my age, and when I told him I was 38, he
5 made a rude face and told me I was too old to be the host. I pointed out that Kimberly Guilfoyle
6 was 43 and that she was a host. Woody then told me that Eric Bolling was slated to be the host
7 and that I would not be a good match as co-host since I did not have a sense of humor about Mr.
8 Bolling referring to me as Dr. McHottie on the air. I insisted that I could get along with Mr.
9 Bolling on air. Mr. Fraser then told me that he could work something out if we could make an
10 arrangement. I knew that by "arrangement," Mr. Fraser meant a sexual relationship as he had
11 made it clear on a number of prior occasions that he would help further my career if we were to
engage in a sexual relationship.

12 8. I intended to confront Mr. Fraser about his past behavior a few years ago when I met
13 with him on the set of one of the Hallmark Channel's television shows, but did not do so
14 because there were many people around. During this meeting, Mr. Fraser again suggested that
15 he could get me back on Fox if the timing was right which, based on the suggestive nature in
16 which he said this, I understood clearly to mean, "if we had a sexual relationship."
17 I have known Woody Fraser for about 7 years now. Over this time I have observed that Mr.
18 Fraser's interactions in the work place with women, including myself, have been sexually
19 inappropriate in nature. He is a known sexual harasser who makes romantic overtures and has
attempted to solicit sex from me on multiple occasions over the years.

20 I declare, under the penalty of perjury, under the laws of the State of California and
21 applicable law that the above is true and correct to the best of my knowledge.
