24 **NOTICE OF AUTOMATIC STAY PURSUANT TO 11 U.S.C. §§ 362(a) and 901(a)**


25 On September 30, 2017, TULARE LOCAL HEALTHCARE DISTRICT, dba
26 TULARE REGIONAL MEDICAL CENTER, filed a petition for relief under provisions of
27 Chapter 9 of Title 11, U.S.C., Chapter 9 Case Number 17-13797, in the Eastern District
28 of California. As a result of the Petition, certain acts and proceedings against the debtor

1 against the debtor and debtor's properties are stayed as provided in 11 U.S.C. §§
2 362(a) and 901(a). The effect of this stay is generally equivalent to an automatic
3 restraining order against creditors from commencing or continuing any lawsuit, or
4 enforcement of any judgment, or enforcement of any lien against property, without first
5 applying to the United States Bankruptcy Court for relief from the stay.
