EXPLAIN YOUR COMPLAINT

Dr. Brandon Porter was a personal friend of mine who I met through NXIVM?ESP (ExecutiveSuccessPrograms.com). He was the physician of our community. When I got the flu, he was the one who would give me advice and check in on me & my symptoms. He did this for many people and I trusted him as the medical authority, especially in his capacity with ESP. Dr Porter was the main scientist who performed different testing on behalf of ESP. Usually this involved connecting students of ESP to brain wave monitoring equipment while they were attending the ESP personal development trainings. I had been connected to the machine on a number of occasions before the experience I am about to describe, all of which had felt fine - I listened to a lecture by a teacher of ESP curriculum while wearing the head cap and being connected to the machine. Dr Porter would give me directions to just pay attention and give him a signal if I thought I had a new awareness (aka "integration") while I listened so he could make note on the brain waves he was reading from me.

On this occasion, the experience was entirely different. I was asked by the Assistant to Nancy Salzman (the President of ESP) if I would be part of another study. Having had my previous experiences with the ESP studies, I said yes and she gave me my appointment time. At the time of my appointment, Dr Porter came and picked me up from the residence I was staying in during my visit to Albany, NY. He drove me to a nearby office space owned by Clare Bronfman (Executive Board Member of ESP). When I entered the building behind Dr Porter, the usual equipment was there, but there was also a TV. Dr Porter began to connect me to the equipment, without any discussion about what was going to happen or what this "study" was for. I assumed it was the same as it had been the times I had do it with him before, but maybe I'd be watching a filmed lecture rather than a live lecture from a teacher. This is NOT what happened.

When the equipment was all set up, Dr Porter told me that we were ready to start. He explained that he was going to show me some clips and then talk about them each afterwards and that there was a camera that would be filming my reactions. I settled in to watch the what I thought was going to be educational materials and was quickly shocked by what began to play on the TV. Dr Porter showed me many clips of very a graphic nature. Of all that he showed me, I can only distinctly recall the 3 that have stuck with me and haunted me for almost a year now. The first clip I remember was of a caucasian male screaming at a black male to "bite the curb". The footage was dark so I didn't understand what I was watching. Sirens started to blare and the man kept yelling at the man, which I now saw was lying on the ground. The black man eventually did put his teeth on to the curb and then the while man stomped on the back of his head, killing him. I burst into tears and started screaming. I was horrified and confused. I began to shake and could not stop crying while Dr Porter asked me my opinion of the film clip. I later learned this was from the movie American History X, which is an incredibly dark and violent film, which is why I never chose to watch it. Dr Porter continued to play DOH-3867 (7/15) p 2 of 4

more clips on the TV. I believe I was in shock since these seem hard to remember. The next clip I recall he played while I was hooked up to the equipment started with a woman dancing at a dingy bar. The character was played by Jody Foster. In the clip, there were only a few women in the bar and they all slowly left, leaving just Jody in the bar with the man she came with and all the other men who were there too. Soon after she was the only woman left in the bar, the man she came with started to grope her. She tried to get him to stop by asking him, and when he continued to try to have sex with her, she tried to get away. At that point, the man asked another man to "grab her arms" and then he starting raping her on a pin ball machine. I started to cry again and begged Dr Porter to turn off the clip as the other men in the movie began to gang rape Jody. Dr Porter stopped the clip after I had covered my eyes and started to hyper ventilate and bawl. He continued to film my reaction for at least 10 minutes as I just sat there, dry heaving like I was going to puke and crying very hard. As time passed, I started to calm down. He asked me about my experience and reactions. I cried while I spoke. I felt so violated and disgusted. Once I was calm, Dr Porter said "there's only one more clip, but I'm nervous to show it to you because your reactions have been so strong. No one else has reacted like you so I don't know how you'll handle this one". At that point, I felt completely numb. I didn't think anything could be worse than what he had already forced me to see. I told him just to play the clip so we could finish and I could go. Dr Porter started the last clip. It was different than all the rest. The others had very clearly been movies, but this was not. It was real life footage of 4 women kneeling in a corn field. Most were topless and had their breasts exposed. Behind them stood many men, each armed with a large knife or gun. They were wearing masks to cover their faces. One of the masked men started to speak, but it was in Spanish, which I don't speak. I watched motionless - the numbness I had felt was disappearing and being replaced with fear. I didn't understand what was being said by the man in the mask, but I was scared for these women's lives - these were REAL WOMEN, not actors. As the man came to the end of his speech, he gave a signal to the rest of the men. Suddenly they grabbed each of the women by the hair and then slit all of their throats. Some seemed to die instantly while at least one continued to live for a short time. The men started to dismember the body and toss the cut off limbs into a pile. Heads, arms, legs, torsos - all were cut up and thrown into the pile. I watched this take place and I don't think I moved at all. I don't even remember crying. I just every detail of watching these women having their throat split open, blood pouring everywhere, their bodies being turned into parts, the way the flesh on the thigh wobbled in the air as it was tossed and hit the ground. I've had many night mares about the scenes I was shown that night, but this one has stuck with me the most.

After this final clip, Dr Porter got me to share my experience then disconnected me from the machine and dropped my back off			
at the home I was staying in. I was not supposed to tell other people in our community what I had experienced/witnessed, or it			
may have skewed the results of the "study". In my opinion, what Dr Porter did to me that night was not in accordance with his			
oath to do no harm. He didn't tell me what I was going to be subjected to or confirm that any of that had been explained to me			
by the 26 year old girl who was the assistant of the President of the company who was paying him. He had a duty to inform and			
protect me. He had a duty to help me give informed consent. He failed me not only as a friend but as the medical practitioner I			
had trusted on numerous occasions with my health while I was in New York. And worst of all, I was not the only one he did this to.			
I know of at least 4 other women he subjected to this material, but I know that there were many more because the assistant who			
invited me said she was tasked with getting 100 people to take part in it. Please look into this ASAP. This man needs to be stopped.
