This .40 caliber semiautomatic pistol was found in the street near the sidewalk in an empty parking spot. On the west side of the sidewalk along 8th Street, one shell casing was located. Items of evidence were also located in the 700 Block of S Street, NW. Among such items collected were three semiautomatic pistols, as follows: [1] black, Glock 23 semiautomatic pistol; [2] black, Smith & Wesson M&P .40 caliber semiautomatic pistol; [3] silver and black Taurus PT845 .45 semiautomatic pistol. These three pistols were found on the ground in the 800 block of S Street, NW, between the south curb and a parked car. Portions of the guns appeared to be partially underneath the car. The Glock 23 was found near the rear passenger's side wheel; it had apparent blood on it. The Taurus .45 caliber and Smith & Wesson .40 caliber pistols were found near the front passenger's side wheel of the same car. The Smith & Wesson .40 caliber pistol contained apparent blood and had what appears to be a laser site underneath the front of the barrel. SUPERIOR COURT FOR THE DISTRICT OF COLUMBIA CRIMINAL DIVISION UNITED STATES VS. GEORGE EDWARDS

- 1. On November 10, 2015, an arrest warrant was issued for George Edwards (DOB 09-05-1989) for Second Degree Murder while Armed by D.C. Superior Court Judge Irving. Defendant was arrested on this warrant on November 18, 2015, at 6228 North Dakota Avenue, NW, #106, Washington, D.C. At the time of defendant's arrest, another resident of the home stated that IT and the defendant had lived at 6228 North Dakota Avenue, NW, #106, since 2005 or 2006. At the time of defendant's arrest, W-4 was present. While at 6228 North Dakota Avenue, NW, W-4 told Detective Travis Barton that IT had lived at that location for the last three years.
- 2. W-4 spoke to Detective Marvin Washington at the Homicide Branch on November 11, 2015. W-4 stated it is in a romantic relationship with the defendant, with whom she shares a child. W-4 stated that earlier on the day of the homicide at issue, IT had an argument with an individual who assaulted IT. IT stated IT called the defendant, George Edwards, who came over to 1711 8th Street, NW. After seeing W-4's injuries, W-4 said the defendant said he was going to see the person that assaulted W-4. W-4 stated IT discouraged the defendant from doing so. W-4 stated that IT saw the defendant walk out of 1711 8th Street, NW, down the walkway between 1711 and 1715 8th Street, NW, and through the gate on the walkway. IT stated IT then heard gunshots and saw the person that had earlier assaulted IT, run behind a vehicle and shoot from 8th Street, NW, towards the defendant. W-4 stated IT believed there were four people shooting at the defendant. W-4 stated that the defendant did not have a gun.
- 3. Paragraph 21 of the warrant affidavit states, "Investigators asked W5 why IT omitted identifying D1 on the video and W5 was unable to provide a reasonable answer. W5 advised D1 was seated in the rear of the vehicle and that IT did NOT observe..." This partial sentence is unrelated to the instant case; it was inadvertently left in the warrant affidavit form.
- 4. As part of the investigation into the November 7, 2015, homicide of Reginald Perry, members of the Homicide Branch obtained video footage from 1711 8th Street, NW. One of the cameras captured video from the gate on the walkway between 1711 and 1715 8th Street, NW. Upon information and belief, this is the same gate and walkway identified by W-2 as from where the shooter came. It is also the same walkway and gate that W-4 stated IT saw the defendant walk on and through after saying he was going to talk to the person that assaulted W-4. In the video surveillance of this area, the following appears:

- At 11/07/2015 02:22:25 (camera time), a male enters the screen on the walkway between 1711 and 1715 8th Street, NW. The male is walking in the direction of 8th Street, towards the gate. The male appears to be wearing long pants, and a hooded sweatshirt with the hood up. The male appears to either have a dark beard or something dark covering the lower portion of his face. The hood and forearms of the shirt appear lighter than the portion of the shirt over the torso, midsection and shoulders of the male.
- At approximately 2:22:28 the male walks through the gate and towards 8th Street. A few steps past the gate, the male raises his left arm and a gun can be seen at the end of his left arm. A black pistol with an extended magazine can be seen in his right hand by his side. The defendant is holding up his left hand with the gun, and appears to be shooting. As he does so he takes steps forward and back and is standing upright.
- A few seconds later, the male walks towards 8th Street, and out of view of the camera. When the male walks out of camera view, his left arm is still up and extended out as if he were shooting a gun.
- At approximately 2:22:45, the same male reenters the camera view, walking upright, and backwards towards the gate (from where he came). His left arm is still extended with an apparent gun at the end as if were shooting towards 8th Street. An apparent black gun with an extended magazine can still be seen in the male's right hand.
- The male continues to back up towards the gate; his left hand with the gun is still extended and raised. When he gets to the gate, the male lifts his right hand and arm and extends it out; the right hand appears to have a black handgun with an extended magazine.
- Once at the gate, the male turns his back to 8th Street, as if to exit back through the gate. Before attempting to open the gate, the male turns back around, raises his left hand with the gun, and then ducks and begins to move around in a ducked position before jumping into the bushes and disappearing out of the camera view. At one point, the male appears to fall to the ground and get back up. The male remained in a ducked position when he got back up. The bushes are in the direction of the intersection of 8th and S Streets, NW, where police discovered a blood trail as described in the warrant.
