MOTION TO REVOKE SUSPENDED SENTENCE

I, Max Cook, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, show that the above-named Defendant **HAROLD DWAYNE ENGLISH**, on the 16th day of August, 2005 previously:

COUNT 1 ENTERED A PLEA OF GUILTY

to/of the crime(s) of:

COUNT 1 LEWD MOLESTATION ~ 21 O.S. § 1123 a FELONY

FURTHER, THAT on the 16th day of August, 2005, the Court sentenced the above-named Defendant to:

(X) Count 1 Sentenced to a term of 14 years in the state penitentiary, with all but the first 4 years suspended, under the custody and control of the DEPARTMENT OF CORRECTIONS pursuant to the rules and conditions of probation entered by the court.

FURTHER, THAT the said Defendant is in violation of the terms and conditions of probation of said Judgment and Sentence as shown by the Violation Report or Affidavit which is attached hereto, incorporated herein, and marked Exhibit "A" as if fully set out.

That the aforesaid acts violated the conditions and is good cause for the Court to revoke said suspended sentence.

WHEREFORE, THE STATE OF OKLAHOMA requests that the Court set a date for hearing this Petition and that the suspension clause in said Judgment and Sentence be set aside and revoked, and that the sentence be carried out in full, according to its terms.

TYPE OF REPORT: Violation Report

English is in violation of the following rules and conditions:

Rule 12. Offender will not initiate, establish, or maintain any contact with anyone under the age of eighteen (18), or attempt to do so, unless agreed upon by the therapist and supervising officer.

On August 23, 2013, English contacted this officer by telephone. English reported that on August 11, 2013, he went to a luncheon with other church members following church service. After the luncheon, two minor females, ages 4 and 8, asked English to give them a ride in his vehicle. English stated that he could not think of any reason to tell them no without causing a scene, so he took the two minor females for a ride in his car. English denied having any sexual thoughts of the children, or having committed any sexual acts toward them.

Summary and Recommendations: English has been compliant in attendance at sex offender treatment, and is employed full time. His verified residence is 9701 New Sapulpa Road lot 28 in Sapulpa. English has reported to the probation office as directed.


During an office visit with Officer Teri Anderson on May 21, 2013, English admitted he had been masturbating while looking out the window of his trailer and watching children outside his residence. He reported feeling guilty about this behavior, but stated that he could not control his urge to masturbate to fantasies of children. English was directed to stop these behaviors immediately and to cover the windows in his RV. During an office visit with Officer Anderson on June 10, 2013, English again admitted to masturbating in front of his window in the hopes

that someone would see him. He reported fantasizing about other people masturbating in front of their windows at the same time, and fantasizing about children in the RV park where he resides. English admitted he is "on the verge of reoffending", but does not wish to have another victim. On August 23, 2013, English admitted to this officer that he had been alone with two minor females, ages 4 and 8, in his vehicle.

English has violated the terms of his probation and by his actions, has demonstrated that he is a risk to the safety of the community. It is respectfully recommended that an Application to Revoke be filed, and a warrant be issued for English's arrest. It is further recommended that the remainder of his suspended sentence be revoked to incarceration.


