INCIDENT NARRATIVE

On September 5, 2017, I, Officer T. Joseph (Unit 1213 /Vehicle No. 32448) received a call from dispatch to be on the lookout for a green Honda Accord that was possibly involved in a kidnapping from Carrolton County, with the last known location of the vehicle being at 1705 Monroe Dr NE. Upon arrival at the location, I made contact with Unit 1212 and Officer Wadsworth-Unit 6955-X. Unit 6955-X advised that he canvassed the parking lot for the green Honda Accord, but was unable to locate it. Unit 6955-X then stated he was about to check the middle portion of the parking lot. I then advised that I would assist. I parked my vehicle and began walking up the driveway of the location when I noticed a vehicle sitting at the top of the driveway with its

engine running and lights off. Immediately after I noticed the vehicle, the driver, later identified as a black male, with a beard, wearing a white t-shirt, turned the vehicle lights on and almost hit me as he speed towards the exit of the parking lot. During his attempt attempt to exit the parking lot, he collided with a 2004 Acura TSX, turning it sideways into a 2009 Honda Civic, whose impact caused it to hit a 2017 Subaru, causing a four car collision.

After the initial collision, the driver sideswiped the rear bumper of a Toyota Prius as he continued to try to exit the parking lot.

Once I noticed the green Honda Accord turing right, I ran back down the driveway to cut him off. When I got to the bottom of the driveway, the green Honda Civic rammed my parked patrol car and began backing out as Unit 6955-X and myself drew our weapons and advised him to stop. The suspect ignored our commands and continued backing up until he got to the end of the parking lot. Myself and Unit 6955-X gave chase to the green Honda Accord on foot up the driveway. Once the suspect was at the end of the parking lot, he turned his vehicle around and proceeded to drive towards the opposite side of the parking lots exit.

I briefly lost visual of the green Honda Accord when I heard a loud crash. I ran behind the parking lot and saw that the vehicle had crashed and a black female, later identified as Jaila Gladden, was running towards me. I asked Ms. Gladden where did the suspect go and she stated, "He jumped the fence." I ran past the green Honda Civic and noticed a substantial amount of blood on the steering wheel. I then noticed blood on a silver Impala as well as the top of the fence. I then jumped the fence with Unit 1212 to search for the suspect. Unit 6955-X stayed with Ms. Gladden.

Unit 1296 and Unit 1293 arrived on scene, as well as the night commander. Unit 1209 arrived on scene to assist with the search along with Unit 1201 and 1273.

Grady Unit 370 arrived on scene and transported Ms. Gladden to Grady Hospital.

A perimeter was then setup.

The knife the suspect used was found covered in blood in the middle of the parking lot where I initially made contact with the vehicle.

G.I. Unit 4111 arrived on scene as well as the K-9 Unit. Crime Scene Unit arrived and processed the scene.

After several hours we were unable to apprehend the suspect. I left case the numbers on the vehicles that were hit during the suspects escape. The incident escalated so quickly that I did not have time to press record and obtain any footage via my body worn camera.

Driver #1 was travelling Northbound in a one way parking lot. Driver #1 ran his vehicle toward Driver #2 while he was on foot. While almost hitting Driver #2, he proceeded to hit Driver #2, Driver #3, Driver #4, Driver #5, and Driver #6 vehicles.

Driver #2 wasn't inside of his vehicle during the ordeal.

Driver #3 wasn't inside of the vehicle during the ordeal.

Driver #4 wasn't inside of the vehicle during the ordeal.

Driver #5 wasn't inside of the vehicle during the ordeal.

Driver #6 wasn't inside of the vehicle during the ordeal.

I, Officer L. Mitchell along with other Zone 2 Units gave a foot chase behind Driver #1 as he wrecked the stolen vehicle, abandoned the vehicle, and jumped the fence. We lost sight on the suspect and set up a perimeter. K-9 Unit were called but the dogs couldn't pick up on the perpetrator's scent. Crime scene was called to collect evidence. Futo's were called to take Vehicle # 1 from the location. I was unable to make contact with Driver #4. The complex has 24 Hour surveillance. No further information at this time.
