It has come to my attention that Burchett for Congress, the congressional campaign committee for Tim Burchett in Tennessee's 2<sup>nd</sup> Congressional District (FEC ID C00652149), has violated federal law by accepting contributions from corporations during the fourth quarter of 2017 filed on Jan. 31, 2018.

According to the FEC's website, "Campaigns are prohibited from accepting contributions from certain types of organizations and individuals. These prohibited sources: Corporations, including nonprofit corporations."


