GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:									
<p>On November 13, 2015, at approximately 0223 hours, officers assigned to the Metropolitan Police Department's (MPD) Fifth District responded to 1324 Adams Street, NE for a report of the sound of gunshots. Officers arrived at the location and immediately observed Mr. Ray Andre Harrison lying on the ground with his back against the rear passenger door of a gray Toyota Camry. He was suffering from what appeared to be a gunshot wound to the chest. Mr. Harrison was unconscious and unresponsive. District of Columbia Medic #17 responded to the scene and began lifesaving efforts. Mr. Harrison was transported to Washington Hospital Center where he was later pronounced dead at 0255 hours on November 13, 2015. No weapons were found on Mr. Harrison's person.</p> <p>On November 13, 2015, an autopsy was conducted on Ray Andre Harrison, hereinafter referred to as the decedent, by the District of Columbia Office of the Chief Medical Examiner. The cause of death was determined to be a single gunshot wound to the chest. The bullet pierced the decedent's heart and lung. The manner of death was ruled homicide.</p>

During a preliminary crime scene review, MPD members found one shell casing on the landing of the front entryway to 1324 Adams Street, NE, just outside the entry door of 1324 Adams Street, NE. Also located was a bloodstain on the sidewalk in front of 1324 Adams Street, NE. No weapons were found on the crime scene.</p> <p>In the course of that investigation, police spoke to W-1. W-1 stated that IT along with Davon Peyton, hereinafter referred to as the defendant, were inside of 1324 Adams Street, NE, Apartment #1, when IT noticed the defendant's cell phone ringing. W-1 stated the defendant told IT the person calling was "Ray," but never answered the phone.</p> <p>Later, at approximately 0200 hours, W-1 stated there was a knock at the window. <p>walked toward the front door. W-1 stated that IT went towards the front door as well and tried to get to the door before the defendant. W-1 stated the defendant got out the door before IT. W-1 stated that when IT got to the door, the decedent was coming up the steps from the mailbox area.</p> <p>W-1 stated that the decedent said to the defendant: "Why are you carrying me like that," or words to that effect. W-1 said the defendant responded, "You are an Uber driver, we aren't cool like that," or words to that effect. W-1 stated the decedent punched the defendant in the face. W-1 said IT jumped in the middle of the two and was pushed out of the way by the decedent. W-1 stated that the defendant and decedent tussled at which time the gun went off. W-1 stated that IT thought the defendant only meant to pistol whip the decedent, as opposed to shoot him. W-1 stated IT thought shooting the decedent was an accident.</p>

<p>W-1 stated that after getting shot, the decedent stumbled down the stairs, on to the sidewalk, and then collapsed on the ground alongside of a gray Toyota Camry. W-1 stated the defendant followed the decedent off of the landing in front of the apartment building. W-1 stated IT thought the defendant still had the gun out as he followed the decedent.</p> <p>W-1 stated that it heard the defendant ask the decedent, "Ray, why did you come to my house?" W-1 said the defendant was holding the decedent as he asked this.</p> <p>W-1 stated that a day or two before the homicide, the decedent stole a phone from the defendant, but ultimately returned it when he (the decedent) could not use the stolen phone.</p>
