The Commission said they read through his file and noted that he has had opportunities to be in the community and not come back. They asked what would be different this time. Subject said that he has been accepted to the Stewards of Recovery at Grace House in Idaho Falls. The Commission said that they have the Ark in their report, and subject said that the Ark has been sold. The Commission said that the report states that he would go to Integrated Family Services for aftercare programs, and he said that he would plan to go there, as well, since he has a history there. They are recommending an 18-month program there for him. He said that the Stewards of Recovery has mental health and substance abuse treatment. He would be living there and the program goes as long as he needs to be there. The case manager stated that it is an approved facility and is similar to Loyal to One Ministries. Subject said that it has been a long road. He said that he did really well the last time except for the last day when he made the wrong decision and didn't see it coming.

The Commission asked what kind of drinker is he and subject said that he uses alcohol as his medication. He said that he has some mental health disorders. Subject said that he can count on one hand the times he has drank since 2008. The Commission asked if he is a functioning alcoholic and he said, "Yes." The Commission said that he has been to prison before so why doesn't he think before even takes the first drink to make certain that he doesn't drive. Subject has 12 DUIs. The Commission said that he probably has driving many times drunk and not been caught. The Commission said that he has a severe problem of driving after he drinks.

The Commission told subject that he has a \$102 bond (cash only) from Fremont County for Failure to Appear so he needs to get that taken care of or he would be arrested if he is picked up for any reason.

Subject has been back on his mental health medication since returning to prison.

His driver's license is suspended for three (3) years upon release and then he will need to have the breathalyzer machine

on his vehicle after that.

Subject's work history is a fabricator welder. The Commission said that is a good trade to have with all the building going on. Subject said that it's hard when you have felonies on your application when you are 52 years old. The Commission asked if he is healthy and he said, "Yes."

The Commission asked what happened to his eye since he has a bandage on his eyebrow. He said that he got up last night to go to the bathroom and didn't realize that the floor had just been mopped and he fell and hit his head on the toilet and received three stitches on his forehead.

Subject said that he lost his grandmother while he was incarcerated. He stated that his parents are in their 70's and he doesn't want to be incarcerated and not be there for them when they pass away.

The Commission asked if he was always a jerk as he was in his 2008 and 2014 arrests, and he said, "No," but all he can say is that he gets a little ornery when he gets too much in him.

The Commission asked why he wasn't on his mental health medications. He said that he had some health problems he was going through and was scheduled for a colonoscopy and went off his medications to see if that was part of his stomach problems. He was off them for ten days when he was arrested for DUI.

The Commission told him the decision and said that he needed to finish his programming before his release. He will receive the special parole conditions in writing before his release. They told him that they appreciate his good attitude today but that they are setting his tentative parole date to 02/22/2020 which is after he satisfies his 2008 DUI sentence. Subject will have a chance to add two more years to his sobriety. The Commission said that when he is released he won't be allowed to drive so will need to find a job where he won't be driving and can find transportation to and from work.

Special Conditions:

- 1. Take medication as prescribed by a physician and as monitored by supervising personnel.
- 2. May not enter into any relationship until the Parole Officer and treatment provider approves.
- 3. Remain alcohol and drug free, which includes not using marijuana and not having a medical marijuana card. Do not enter any establishment where alcohol is the main source of income.
- 4. Follow the aftercare plan recommended by IDOC.
- 5. Pay restitution as determined by the courts. You must make payment to the sentencing court for fines and other assessments, which were ordered at the time of sentencing. Establish and follow a payment schedule as determined by the Parole Officer.
- 6. The parolee will not associate with known felons (unless specifically allowed by the Commission or supervising personnel); persons involved with illegal activity, or other persons as identified by supervising personnel.
- 7. The Commission will allow the parole officer to use discretionary jail time of ten (10) days for the term of subject's parole.
- 8. While on parole, do not drive, do not have a driver's license, and do not have a vehicle registered in your name.

Complete assigned programming. TPD is after his 2008 DUI is satisfied. No driving on parole; PO should not ask for modification.
