### **Brief Summary of Incident and Action Taken:**

At approximately 0056 Officer Bartlett, Charles #1422 called an emergency in Unit 11 stating that an inmate pushed his cell bottom saying that he and his cellmate got into a fight. A response Team and Medical Response was activated to Unit 11. Officers Bennetch #0117, Bartlett #1422 and Madrid #A220 entered C tier and approached [REDACTED]. A response team entered [REDACTED] and saw Inmate [REDACTED] on the ground unresponsive with blood around him. They also saw Inmate [REDACTED] standing by the light switch in his cell. Inmate [REDACTED] was restrained and escorted to Unit 8 by Officer Madrid. Medical Response Shaffer #C401 entered [REDACTED] and began CPR. Medical Response Shaffer C401 recommended that Ada County Paramedics be activated. At 0100, [REDACTED] was declared a crime scene. Ada County Paramedic arrived at ISCI at 0123 and continued CPR on [REDACTED]. At 0145, [REDACTED] was pronounced dead by Dr. Justin Kornick from Saint Alphonsus. At 0255, Ada County Coroner Brown arrived on scene. At 0356, Ada County Coroner left ISCI with [REDACTED] deceased body. Inmate [REDACTED] will be transported to IMSI after Ada County detectives are finished with their investigation.
