

B1. Probable Cause Statement

04/18 AT 1006 HOURS, ELIZABETH DAUENHAUER AND TAHNEE GONZALES COMMITTED THIRD DEGREE BURGLARY AT THE ISLAMIC COMMUNITY CENTER, LOCATED AT 131 E. 6TH ST., TEMPE. AN INVESTIGATION REVEALED TAHNEE GONZALES AND ELIZABETH DAUENHAUER RECOR-DED THEMSELVES ON A CELLPHONE VIDEO AND UPLOADED IT AS LIVE FEED TO TAHNEE'S FACEBOOK ACCOUNT WHICH SHOWED THAT ON 03/04/18 AT APPROXIMATELY 1006 HOURS, THEY ENTERED THE ISLAMIC COMMUNITY CENTER COURTYARD THROUGH A GATE MARKED WITH A SIGN THAT STATES, "NO TRESPASSING" AND REMOVING SEVERAL EDUCATIONAL FLYERS, PAMPH-LETS, CALENDARS, AIR FRESHENERS, QURANS AND OTHER ITEMS THAT WERE PLACED INSIDE THE COURTYARD OF THE MOSQUE FOR THE MEMBERS OF THE CHURCH. THIS RECORDING WAS OBSERVED BY POLICE AND SAVED. POLICE CONTACTED THE VICTIM, A REPRESENTATIVE OF THE ISLAMIC COMMUNITY CENTER, WHO STATED THE ONLY MOSQUE MEMBERS ARE ALLOWED TO ENTER THE COURTYARD AREA. VISITORS ARE ALLOWED ON PROPERTY, BUT ONLY AFTER THEY REQUESTED PERMISSION THROUGH THE MOSQUE WEBSITE, WHICH IS WHY THE NO TRESPASSING SIGNS WERE PLACED ON BOTH ENTRANCE TO THE COURTYARD. HE FURTHER INFORMED POLICE THAT THE ITEMS TAKEN BY ELIZABETH AND TAHNEE WERE EITHER ITEMS ONLY ALLOWED TO BE TAKEN BY THE ISLAMIC COMMUNITY CENTER STAFF OR BY MEMBERS OF THE MOSOUE. HE CLARIFIED AND STATED THE PAMPHLETS AND AIR FRESHENERS WERE ONLY ALLOWED TO BE TAKEN BY MEMBERS OF THE MOSQUE AND NO ONE WAS ALLOWED TO REMOVE THE COMMUNITY FLYERS EXCEPT FOR THE ISLAMIC COMMUNITY CENTER STAFF. HE INFORMED POLICE THAT THE OURANS AND OTHER SCRIPTURE REMOVED BY THE FEMALES WERE DONATE BY MEMBERS OF THE MOSQUE AND THAT NO ONE WAS ALLOWED TO REMOVE THE ITEMS. HE ALSO STATED THAT ELIZABETH AND TAHNEE ARE NOT MEMBERS OF THE MOSQUE OR ISLAMIC COMMUNITY CENTER. POLICE PERFORMED A WALKTHROUGH OF THE ISLAMIC COMMUNITY CENTER COURTYARD AND OB-SERVED THAT IT WAS COMPLETELY SURROUNDED BY A FENCE AND ON THE ENTRANCES TO THE FENCE THERE WERE "NO TRESPASSING" SIGNS THAT WERE VISIBLE. THE QURANS WERE LOC-ATED IN A WHITE BIN ON THE WEST SIDE OF THE COURTYARD. THE PAMPHLETS AND ADVERT-ISEMENT FLYERS WERE LOCATED IN THE COURTYARD AS WELL. POLICE REVIEWED VIDEO SUR-VEILLANCE FROM THE ISLAMIC COMMUNITY CENTER AND WERE ABLE TO OBSERVE TAHNEE AND ELIZABETH IN THE SOUTH PARKING LOT OF THE ISLAMIC COMMUNITY CENTER ON 03/04/18 AT 1016 HOURS. ELIZABETH WAS PLACED UNDER ARREST AT 1500 HOURS AT 3315 E. WIND-SOR AVE., PHOENIX. SHE WAS TRANSPORTED TO TEMPE CITY JAIL, WHERE SHE WAS BOOKED AND HELD TO SEE A JUDGE. SHE WAS CHARGED WITH 3RD DEGREE BURGLARY. TAHNEE WAS PLACED UNDER ARREST AT 1422 HOURS AT 5501 W. GARDINA, GLENDALE. SHE WAS TRANS-PORTED TO TEMPE CITY JAIL, WHERE SHE WAS BOOKED AND HELD TO SEE A JUDGE. SHE WAS CHARGED WITH 3RD DEGREE BURGLARY AND DISORDERLY CONDUCT.
