## B1. Probable Cause Statement

ON 040318 AP RICARDO COMMITTED THE OFFENSE OF ATTEMPTED SECOND DEGREE MURDER WHEN HE STABBED HIS WIFE OF 40 YEARS 79 TIMES. RICARDO STATED UNDER MIRANDA THAT HE AND ANNA MADE A VOW 40 YEARS AGO IN THE CHURCH TO BE FAITHFUL TO EACH OTHER AND SINCE SHE WAS NOT HONORING HER SIDE OF THE PROMISE HE INTENDED TO KILL HER AND HIM SELF. RICARDO STATED THAT HE GAVE HER SEVERAL OPPORTUNITIES TO BE HONEST AND TELL HIM THE TRUTH BUT SHE CONTINUED TO LIE TO HIM. HE WAS GOING TO LEAVE THIS WORLD KNOWING THAT HE FULFILLED HIS SIDE OF THE VOW. AFTER STABBING HER 79 TIMES RICARDO THOUGHT SHE WAS DEAD WHEN SHE WENT OUTSIDE. HE THEN STABBED HIMSELF IN THE LEG AND CHEST AREA. HE STATED THAT IF HE WAS NOT ABLE TO HAVE HER IT WAS BETTER THAT NEITHER OF THEM LIVED. ANNA WAS STABBED NUMEROUS TIMES IN THE CHEST AND LEFT ARM AREA. SHE STATED THAT HER HUSBAND OF 40 YEARS WENT NUTS AND BEGAN TO STAB HER. SHE RELATED RICARDO IS USING DRUGS AND HAS BECOME VERY JEALOUS AND ACCUSES HER OF CHEATING AND TALKING TO OTHER MEN. ANNA STATED THE ALLEGATIONS WERE FALSE AND SHE WAS SCARED OF HIM. TODAY HE ACCUSED HER OF CHEATING ON HIM AND JUST WENT NUTS. HE GRABBED A KNIFE AND BEGAN TO STAB HER. SHE GOT AWAY FROM HIM AND WENT OUTSIDE. AS SHE GOT OUTSIDE THE POLICE ARRIVED AND RICARDO WAS STILL IN THE HOUSE. HE WAS TAKEN INTO CUSTODY AND SHE WAS TRANSPORTED TO THE HOSPITAL. ANNA SUFFERED NUMEROUS STAB WOUNDS TO HER CHEST AND LEFT ARM AREA. ON APRIL 3, 2018 AT APPROXIMATELY 0610 HOURS, I RECEIVED A PHONE CALL FROM SERGEANT CALDWELL 6537 OF THE PHOENIX POLICE DEPARTMENT FAMILY INVESTIGATIONS BUREAU DOMESTIC VIOLENCE UNIT. SERGEANT CALDWELL ADVISED THEY HAD RICARDO POBLETE IN CUSTODY FOR AN INCIDENT WITH HIS WIFE REFERENCE REPORT 201800000578055, AND DURING THEIR INVESTIGATION THEY FOUND RICARDO WAS AN OUTSTANDING SUSPECT OF ENDANGERMENT REFERENCE MY CASE. UPON REVIEWING THE CASE, OFFICERS DETERMINED RICARDO THOUGHT HE SAW SOMEONE STANDING OUTSIDE OF HIS WINDOW AND SHOT ONE TIME THROUGH HIS WINDOW AT AN UNKNOWN TARGET. THE BULLET TRAVELLED THROUGH HIS TRAILER WINDOW AND STRUCK A NEARBY TRAILER IN SPACE. OFFICERS AND DETECTIVES ATTEMPTED TO CONTACT THE RESIDENT OF TRAILER. NUMEROUS TIMES HOWEVER, THE OWNER WAS NEVER ABLE TO BE CONTACTED. THE REPORT ALSO INDICATED THE RESIDENT OF UNIT WAS NOT HOME AT THE TIME OF THE INCIDENT. BASED ON STATEMENTS TO OFFICERS DURING THE ORIGINAL INVESTIGATION, ALONG WITH THE WITNESS INSIDE RICARDO'S HOME ALSO STATING RICARDO HAD SHOT THROUGH THEIR RESIDENCE WINDOW. RICARDO FAILED TO PERCEIVE A SUBSTANTIAL AND UNJUSTIFIABLE RISK WHEN HE SHOT AT AN UNIDENTIFIED TARGET OUTSIDE OF HIS WINDOW AND WILL BE BOOKED FOR ONE COUNT OF UNLAWFUL DISCHARGE OF A FIREARM. A VIOLATION OF ARS 133107A, A CLASS 6 FELONY.
