ADDENDUM

B1. Probable Cause Statement

ON 4/14/18, THE VICTIM CAME TO THE LOBBY OF THE POLICE DEPARTMENT WITH HER MOTH-ER TO REPORT THAT THE SUSPECT, HER FATHER HAD BEEN SEXUALLY ASSAULTING HER FOR SEVERAL YEARS, MOST RECENTLY WITHIN THE PAST WEEK. THE VICTIM, 10 YEAR OF AGE, BELIEVED THE SEX WAS ANAL SEX, SAYING DAD HAS SEX WITH MY BUTT. THE VICTIM ALSO ADVISED THE SUSPECT HAD THREATENED HER IF SHE EVER TOLD ANYONE, SAYING HE WOULD GO TO JAIL IF PEOPLE FOUND OUT. A FORENSIC INTERVIEW WAS COMPLETED AT PHOENIX CHILD HELP. THE VICTIM DISCLOSED NUMEROUS INCIDENTS OF SEXUAL ASSAULT WITH THE VICTIM. SHE ADVISED IT HAD BEEN SEVERAL TIMES SINCE MOVING TO ARIZONA FROM OK-LAHOMA. SHE WAS ASKED TO DESCRIBE THE MOST RECENT INCIDENT. SHE STATED ONCE MOM LEFT FOR WORK, HER DAD TOLD HER TO COME IN THE BEDROOM. SHE ADVISED DAD LOCKED THE DOOR, TOOK HER PANTS OFF AND TOLD HER TO GET ON TOP OF HIM. SHE THEN STATED HER DAD PENETRATED HER IN HER "FRONT AREA." WHEN ASKED WHAT HE PENETRATED HER WITH, SHE STATED HIS PENIS. VICTIM STATED IT OCCURRED FOR A FEW MINUTES, AFTER-WARDS SHE GOT UP AND WENT TO THE BATHROOM. SHE WAS UNSURE IF THE SUSPECT WORE A CONDOM, OR EJACULATED INSIDE HER. SHE STATED THIS OCCURRED ON HER MOM'S BED, AND BOTH OF HER OTHER SIBLINGS WERE HOME. SHE FURTHER STATED ALL THE PREVIOUS INCID-ENTS WERE ALSO WHEN MOM LEAVES FOR WORK, AND EVERY TIME IT WAS ON THE BED IN THE MASTER BEDROOM. THE VICTIM WAS UNABLE TO BE SPECIFIC ABOUT ANY OTHER INCIDENTS, JUST THAT IT WAS TO MANY TO REMEMBER SPECIFICS. AFTER COMPLETED OF THE FORENSIC INTERVIEW, THE VICTIM WITH THE CONSENT OF HER MOTHER AGREED TO PARTICIPATE IN A SANE EXAM. AFTER SPEAKING WITH THE NURSE, IT WAS DETERMINED THERE WERE NO SIGNS OF ANAL PENETRATION, HOWEVER THERE WAS TEARING OF THE VICTIM'S HYMEN, CONSISTENT WITH FORCIBLE PENETRATION. THE VICTIM WAS NOT CURRENTLY COMPLAINING ABOUT ANY PAIN, BUT DURING THE INTERVIEW STATED IT HURT WHEN THE SUSPECT HAD SEX WITH HER. THE SUSPECT WAS LOCATED AND DETAINED AT HIS RESIDENCE AND BROUGHT BACK TO THE SURPRISE POLICE DEPARTMENT. ONCE IN AN INTERVIEW ROOM, I READ HIM HIS MIRANDA RIGHTS TO WHICH HE STATED HE UNDERSTOOD. THE SUSPECT FIRST STATED HE BELIEVED HE WAS THERE FOR PREVIOUS ALLEGATIONS OF SEXUAL ABUSE TO CHILDREN IN OKLAHOMA. AFTER SPEAKING FOR SEVERAL MINUTES, I ADVISED HIM HE WAS THERE TO TELL ME ABOUT HIS DAUGHTER, AND IT WAS HIS TIME TO TELL ME WHAT HE DID TO HER. THE SUSPECT RE-MAINED SILENT FOR SEVERAL SECONDS, WITH HIS HEAD DOWN, AND THEN TOLD ME HE MESSED UP, THAT HE WAS A SICK INDIVIDUAL. HE STATED HE HAD BEEN HAVING SEX WITH THE VICTIM ON A CONSISTENT BASIS FOR FOUR YEARS, SINCE MOVING TO ARIZONA. HE STATED HE DID NOT KNOW THE EXACT AMOUNT, BUT TOLD INVESTIGATORS IT WAS SEVERAL TIMES A MONTH FOR SEVERAL YEARS. SINCE HE WAS UNABLE TO BE SPECIFIC DUE TO THE AMOUNT, I ASKED HIM TO GIVE ME DETAIL ABOUT THE LAST ASSAULT. HE FIRST STATED IT WAS A FEW WEEKS AGO, BUT WHEN I TOLD HIM IT WAS EARLIER THIS WEEK, HE STATED "YOU'RE RIGHT." HE SAID HE WAITED FOR HIS WIFE TO GO TO WORK, AND AT THE TIME ALL THREE CHILDREN WERE HOME. HE STATED IT WAS IN THE EVENING, AND HE CALLED THE VICTIM INTO HIS BEDROOM. HE STATED HE WAS ON THE BED, TOLD HER TO TAKE HER PANTS OFF AND GET ON TOP OF HIM. HE STATED AFTER SHE DID THAT, HE PENETRATED HER VA-GINALLY WITH HIS PENIS. I ASKED HIM IF HE WORE A CONDOM, HE STATED "NO." HE ALSO STATED HE DID NOT EJACULATE INSIDE THE VICTIM, AND NEVER HAS. HE STATED HE CON-TINUED PENETRATING HER FOR THREE OR FOUR MINUTES, AND STOPPING WHEN THE VICTIM STATED SHE NEEDED TO USE THE BATHROOM. I ASKED HIM WHAT HE SAID BEFORE OR AFTER HAVING SEX WITH HIS DAUGHTER. HE ADMITTED TO TELLING HER NOT TO TELL ANYONE, THAT HE WOULD GO TO JAIL. HE ALSO ADMITTED TO TELLING THE VICTIM THIS WAS THE LAST TIME HE WAS GOING TO HAVE SEX WITH HER, AS SHE DISCLOSED IN HER FORENSIC INTERVIEW. THE SUSPECT CONTINUED SAYING HE WAS A "FUCKED UP INDIVIDUAL", AND HAD NO EXPLANATION FOR HIS ACTIONS. HE STATED HE WAS SELFISH, AND DID IT OUT OF PLEASURE. THE SUSPECT AGREED TO WRITE AN APOLOGY LETTER TO HIS WIFE AND FAMILY. THE SUSPECT ALSO ADMITTED TO MOLESTING SEVERAL OTHER CHILDREN IN OKLAHOMA ROUGHLY FIVE YEARS AGO, ALL FAMILY MEMBERS OF HIS WIFE. HE WAS ASKED AGAIN HOW MANY TIMES HE HAD SEX WITH HIS DAUGHTER, BUT STATED HE COULD NOT COUNT HOW MANY.
