<p>SUMMARY</p> <p>SUMMARY REVIEW OF OFFICER ANTHONY MUNOZ'S FIRST BODY CAMERA VIDEO Wednesday, 05/31/17</p> <p>On the above day and date, I reviewed body camera video which was recovered from West Milwaukee Police Officer ANTHONY MUNOZ's police department issued Taser Axon Flex Body Cam, serial #X78102230. According to the audit trail provided by West Milwaukee Police Chief Dennis Nasci, the video was dated 05/25/17 at 5:02:24AM. The video is thirty minutes and thirty-one seconds in duration.</p> <p>As I began reviewing this video, I could see that the video clips in and of themselves were not date or time stamped. As I began reviewing Officer MUNOZ's body camera video, it depicts Officer MUNOZ arriving on scene. For the first thirty seconds of this video, there is no audio associated with this portion.</p> <p>As Officer MUNOZ exits his squad car and approaches the building, you can clearly see the address of "5410". Officer MUNOZ is let into the apartment building by an unknown female. The female tells him hi, it's up stairs, go right to the end, you'll see the girl trying to talk to him. In the background, you can hear an unknown female voice say open the door. A unknown female voice is heard saying he is not normal and the rest of her statement is covered by the officers radio transmissions. A tenant told Officers that he is going to hurt himself.</p> <p>Officer MUNOZ then walks up the stairs to the second floor. As Officer MUNOZ is walking up the stairs, an unknown female is heard in the background saying, "Open the door". You can hear the female also telling someone to open the door and that we are here to help. As Officer MUNOZ is approaching apartment #21, you can see an unidentified female at the end of the hallway, outside of apartment #21, knocking on the door.</p> <p>Officer MUNOZ makes contact with this woman. This woman says, "I'm worried about him, more than I'm worried about him hurting anybody". This female says that she talked to him previously, a couple of days ago. The female says that the male tenant in apartment #21 said something to her, which I could not understand on the audio recording. This woman also indicates that the person in apartment #21 said he was really sad. She said that he obviously has psychotic issues.</p> <p>Officer MUNOZ asks this female what he (the decedent ADAM TRAMMELL) was doing tonight. The female says that TRAMMELL was in the middle of the hallway</p>

screaming, moaning and moaning. This female again says that TRAMMELL was moaning and moaning and that she came out of her apartment and he was standing there butt naked.

Officer MUNOZ then knocks on the door of apartment #21 and receives no answer. Corporal ROHLEDER and Officer ENGEN have now arrived on scene and officers continue to knock on the door. Officer MUNOZ continues to knock on the door; however, he receives no answer. Officer MUNOZ is identifying himself as a police officer.

Officer MUNOZ contacts his dispatchers and asks if they have information on keys for the apartment manager or possibly keys for the apartment. Officer MUNOZ continues to knock on the door and identify themselves as police, but receive no answer. Corporal ROHLEDER knocks on the door and identifies themselves as police and tells TRAMMELL to open up. Officers continue to knock on the door while identifying themselves and asking him to open up; however, they do not receive any answer. A citizen is heard in the background saying, he won't open the door. Officers continue to knock on the door with no response.

Officers then step out onto the second floor common balcony area in order to see if there is a window that leads into apartment #21; however, Officer MUNOZ says there is no window in the back. Officer MUNOZ then advises dispatchers that TRAMMELL is reportedly flooding out the unit below him. Officer MUNOZ continues knocking. In the background, you can hear a tenant say something to the effect of you need to knock the door down and that he might be in the bathtub drowning. Officer MUNOZ continues knocking on the door, identifying themselves as police, with no answer. Officer MUNOZ says there is water going into the unit below, so we'll have to go in and check on him. He continues knocking and identifying themselves as police over and over again but he receives no answer.

As officers were attempting to make contact, a female tenant is heard saying in the background that he (referring to the person in apartment #21) said he was going to kill himself. Corporal ROHLEDER asks this tenant when he said that. The female tenant said when she was up there and that he also said something to the effect of, "Am I going to go to heaven?". Corporal ROHLEDER then tells Officer ENGEN to get the door thing. Officer ENGEN asks him, "The ram?".

Officer MUNOZ continues knocking on the door of apartment #21, while continuing to identify himself as the police, but no response is received. He continues knocking at apartment #21 and asks, "Can you open up?". He receives no answer and continues knocking on the door to apartment #21, asking TRAMMELL to open up the door, again while identifying himself as the police.

Officer MUNOZ continues to knock on the door and says, "We'd like to

talk to you, open up the door, it's the police", but no answer was received. Officer MUNOZ continues knocking and says, "sir, police department, we'd like to talk to you and make sure you are okay, but no response was received. Officer MUNOZ continues knocking on the door and says, we just have to check on you. We can't leave until you open up the door, but no answer is received.

Officer MUNOZ continues to knock on the door and says, we want to check on you to make sure you are okay, but he receives no answer. He then yells through the door that if he does not open up the door, they are going to have to force their way in and that they do not want to do that. He continues knocking, but did not receive any answer. Officer MUNOZ continues to yell through the door, we got to check on you. We can't leave without checking on you. Open up the door so we can talk to you.

Corporal ROHLEDER then says that if he does not, they are going to have to break the door down. Officer MUNOZ continues knocking on the door, while still identifying them as police, and was saying that they were going to have to force the door open. Officer MUNOZ says that they would prefer him to open it up on his own and that they just want to check on him. Officers continue knocking and do not receive any response.

In the background, you can hear a loud noise, which is believed to be an officer hitting or kicking the door in an attempt to get the attention of the person inside apartment #21; however, no response is received. Officers continue to knock on the door, identifying themselves, saying that they need to check on him. Officer MUNOZ continues to knock on the door and says that he has to make sure that he was okay; however, he receives no response. Officer MUNOZ was asking TRAMMELL to open up the door. Officers say that they just want to check on him and ask him to open up the door, but no response is received. Officers continue to knock and continue to ask TRAMMELL to open the door, saying they need to check on him; however, officers do not receive any response. Officers continue to knock on the door, asking TRAMMELL to open the door; however, no response is received.

Officer MUNOZ then asks, "Do we know this guy's name?". Officer ENGEN then radios out to dispatchers asking for a name and dispatchers reply that from December 2016, they have a name of BRANDON FRANK residing at that apartment. Dispatchers give a description of BRANDON FRANK, identifying BRANDON FRANK as a white male. Officers are then heard saying that they did not know if this was going to be him.

Officer MUNOZ then says, "BRANDON, can you open the door?". A voice is heard in the background and it sounds as if this person is telling the officer that the person in apartment #21 is named BRANDON. Officer MUNOZ continues knocking on the door, but receives no response. Officer MUNOZ then asks other officers if a keyholder is coming and Corporal ROHLEDER says that they are a half hour out. Officers tell BRANDON this is his last chance to open up to

make sure he is okay, otherwise they are going to have to come in.

Corporal ROHLEDER then uses the ram and strikes the door five times, while yelling to BRANDON to step away from the door. As Officer MUNOZ and Corporal ROHLEDER are entering into the apartment, Officer MUNOZ is saying, "BRANDON, we need to see your hands". Officer MUNOZ continues into the apartment while yelling out, "BRANDON, we need to see your hands", "BRANDON I want to see your hands", and, "Hands up!". Corporal ROHLEDER is then heard saying he has got someone in the tub. Officer MUNOZ again says, "BRANDON I need to see your hands" and to come out with his hands up. Moaning can be heard in the background, with officers telling BRANDON they need to see his hands. More groaning is heard in the background.

Officer MUNOZ says that he needs to make sure he is okay and that he needs to see his hands, "BRANDON, let me see your hands", and, "BRANDON we just want to make sure you're okay". While officers are giving commands, they are not receiving any verbal responses from the person in the bathtub. The shower curtain is pulled back and a subject, later identified as ADAM TRAMMELL, is naked and sitting down in the bathtub. TRAMMELL is drinking a clear liquid from a clear plastic gallon container, with water running from the shower head.

As officers are giving commands, TRAMMELL continues to drink from the gallon container and pours water on his head. TRAMMELL then reaches up and puts the gallon container up to the shower head to refill it. Officer MUNOZ is giving commands, telling TRAMMELL to come on out. TRAMMELL replies something inaudible. TRAMMELL takes a drink from the gallon container and again holds the container up to the shower head, with Officer MUNOZ asking him to come out. TRAMMELL, however, does not respond.

Officer MUNOZ says, "BRANDON come on out" and TRAMMELL just shakes his head. Officer MUNOZ asks TRAMMELL what is wrong, as TRAMMELL is holding the gallon container to the shower head, which is still running. TRAMMELL looks stares officers and splashes the liquid from inside the gallon container towards Officer MUNOZ. TRAMMELL stands up and Officer MUNOZ tells him he has got to come out. TRAMMELL is still standing and commands are given to come out; however, TRAMMELL just splashes water from the gallon container, a second time, onto Officer MUNOZ.

TRAMMELL is still standing up in the tub and is filling up his gallon container. Officer MUNOZ is giving commands, telling "BRANDON" that he needs him to come out. TRAMMELL then looks towards the officers. Officer MUNOZ says "BRANDON", and Corporal ROHLEDER says to listen to what he is telling you. As I continued viewing the video, I could see the laser sight on TRAMMELL's chest and the wall. Officer MUNOZ tells TRAMMELL, you're gonna get tased. TRAMMELL is still reaching up to the shower head with the gallon container and TRAMMELL then moves closer towards the wall with the shower

head. TRAMMELL looks at Officer MUNOZ and angles his left arm.

At twelve minutes and five seconds into this video clip, Officer MUNOZ deploys his Electronic Control Device (ECD) and the ECD can be heard cycling. After the ECD completes its five second cycle, TRAMMELL falls down into the tub, into a seated position, with his body facing the shower head. TRAMMELL is still screaming. Officers are then heard saying that now he needs to listen and to just relax. I could also see in the video that the shower was still running. Officer MUNOZ is telling TRAMMELL to relax. Corporal ROHLEDER says, "BRANDON, you don't want to do that again do you?"

Officer MUNOZ says that he needs him to come out slowly, otherwise you're going to get tased again, okay? Officer MUNOZ tells TRAMMELL that he can not have him (TRAMMELL) swinging at him (MUNOZ). At this point, TRAMMELL is laying in the tub on his back with his knees bent. Officer MUNOZ tells him they need to make sure he is okay, but that they need to make sure he (Officer MUNOZ) is okay as well. Multiple commands are given to TRAMMELL to stand up, but no response is received.

Officer MUNOZ is then heard saying, BRANDON, don't pull away, however, I cannot see TRAMMELL's left hand. I can see that TRAMMELL is still laying on his back in the bathtub. Corporal ROHLEDER says, you're going to get it again. Officer MUNOZ tells the suspect that he is going to get tased again, okay? TRAMMELL is now laying flat on his back, while moaning and shaking his head. At twelve minutes and fifty-two seconds into the video, an ECD is deployed and TRAMMELL starts screaming.

Officer MUNOZ is heard saying to relax, at which time the suspect starts screaming again. TRAMMELL continues to lay on his back, screaming. Corporal ROHLEDER tell's TRAMMELL that he needs to listen to them and TRAMMELL continues to lay on his back in the bathtub, shaking his head. Corporal ROHLEDER then advises dispatchers that a taser had to be deployed and that they were trying to get him to cooperate.

TRAMMELL continues to lay in the tub on his back. Officer MUNOZ says to Corporal ROHLEDER that there is no easy way to do this. Corporal ROHLEDER replies something to the effect that no, there isn't, but I would leave it the way it is right now. It appears that they are talking about removing the ECD probes from TRAMMELL.

Corporal ROHLEDER says, "BRANDON, can you listen to us?", and TRAMMELL continues to lay on his back in the tub and shake his head. TRAMMELL's eyes are now closed. Corporal ROHLEDER leans into the bathtub towards TRAMMELL and says, "BRANDON", "BRANDON" and tells him to come on up. Corporal ROHLEDER asks TRAMMELL, "Can you sit up? Can you sit up buddy?". TRAMMELL just continues to lay there on his back in the bathtub and does not respond to commands.

TRAMMELL's head was now canted to the right and TRAMMELL starts screaming and suddenly stands up to his feet. Corporal ROHLEDER yells to hit him again. At fourteen minutes and eighteen seconds into the video, an ECD is deployed and TRAMMELL falls back into the tub and is now laying on his back in the bathtub. According to the ECD report, at fourteen minutes and twenty-four seconds into the video, there is an attempted ECD deployment, but there is no effect. It is unknown if the ECD is malfunctioning or if there is a loose or bad connection with the probes.

At fourteen minutes and twenty seven seconds into the video, Corporal ROHLEDER says, hit him again. According to the ECD report, Officers attempt to deploy the ECD at fourteen minutes and twenty-nine seconds into the video; however, Officer MUNOZ is heard saying, "I'm out". It is believed that for an unknown reason(s) the ECD malfunctioned and/or was not effective during these two deployments.

Video continues to show TRAMMELL still resisting officers. TRAMMELL, who is in a seated position in the bathtub, tries to get up and Corporal ROHLEDER tells him to get down. Corporal ROHLEDER is seen holding his ECD in his left hand, while struggling to maintain control of TRAMMELL, who is trying to get up, by pushing his head down. Officer MUNOZ is then heard saying, "He's got my taser! He's got my taser" and TRAMMELL is now thrashing around the bathtub. TRAMMELL is yelling and blood can be seen on his forehead area. TRAMMELL is told to relax.

TRAMMELL ends up laying on his back in the bathtub and the Officer MUNOZ is heard saying to TRAMMELL to relax. TRAMMELL is laying in the tub groaning but he continues to thrash around. TRAMMELL then sits up and reaches for the shower knobs. An officer is then heard saying to hit him again, hit him again, and asking, "Can you hit him Tony?" MUNOZ says, I need help. I'm out.

While doing this, TRAMMELL is grabbing a shower knob with both hands. TRAMMELL is told to relax. Corporal ROHLEDER says, "BRANDON, I'm going to have to do this, I don't want to taze you again BRANDON". Officer MUNOZ continues to tell BRANDON to relax with BRANDON grabbing at the shower knob. TRAMMELL then tries to get up with him being told to relax and stay down. At fifteen minutes and twenty-six seconds into the video, there is another ECD deployment. TRAMMELL screams and ends up laying on his back, with officers telling him to stay down.

Corporal ROHLEDER then places a handcuff on TRAMMELL's left wrist and then grabs his right hand and places a handcuff on TRAMMELL's right wrist, with both hands handcuffed in the front. Corporal ROHLEDER says, we don't want to do this anymore BRANDON. TRAMMELL then suddenly sits up in a seated position with back to the corner of the bathtub. TRAMMELL then tries to stand

up with Corporal ROHLEDER trying to control him, while Officer MUNOZ is telling TRAMMELL to relax. This is occurring after TRAMMELL has been placed in handcuffs, TRAMMELL continues to scream and be resistive. Officer MUNOZ tells TRAMMELL to relax and they are there to help him, all while TRAMMELL is screaming and ignoring commands.

Officers continue to tell TRAMMELL to relax. TRAMMELL continues to scream. Officers continue to tell TRAMMELL to relax. Officers then yell to "DANI", referring to Officer ENGEN, and say to get the taser in here. Officer MUNOZ and Corporal ROHLEDER are telling Officer ENGEN to collect the tasers and to pick up the two tasers on the floor behind them. Officer MUNOZ tells Officer ENGEN that she is going to have to give them her taser. Officers are telling TRAMMELL to relax. Officer ENGEN then hands off her ECD. TRAMMELL continues struggling and thrashing in the bathtub, while saying, mother fucker. At sixteen minutes and fifty five seconds, an ECD is deployed, with TRAMMELL screaming.

Officers are unable to gain control of TRAMMELL and make a decision to tactically retreat. Before retreating, Officer MUNOZ removes the bathroom door from the hinges. Officers are then heard saying, "Don't move. Don't move." Three seconds later, at seventeen minutes and forty-six seconds, while Officer MUNOZ is attempting to remove the door hinges, TRAMMELL apparently disregards orders and Corporal ROHLEDER deploys the ECD for another five second cycle. As Officer MUNOZ is removing the door, Corporal LOHLEDER is giving commands, don't move now. Don't move.

Officers tell TRAMMELL to stay down and to not move and at eighteen minutes and eight seconds, there is another ECD deployment. TRAMMELL screams and Corporal ROHLEDER tells TRAMMELL not to move and that he does not want to do this again. Corporal ROHLEDER orders TRAMMELL to stop. Command are given to stay down and at eighteen minutes and thirty-five seconds into the video, Corporal ROHLEDER deploys his ECD once again.

The suspect TRAMMELL screams. TRAMMELL attempts to get up again and at a time between eighteen minutes and forty-three and eighteen minutes and forty-five seconds into the video, Corporal ROHLEDER again deploys his ECD. Officer MUNOZ and Corporal ROHLEDER then begin backing out. At nineteen minutes and nine seconds, as officers are backing out of the apartment, you can see the ECD lines still connected to the ECD and TRAMMELL and be seen still in the bathtub.

As Officers retreat out of the apartment a command is given to stay down and you can officers say they don't want him grabbing weapons. Corporal ROHLEDER was holding on the door and watching into the bathroom. At nineteen minutes and thirty-four seconds, you can see TRAMMELL's toes break the bathroom doorway thresh hold. At nineteen minutes and thirty-five seconds, Corporal ROHLEDER again deploys his ECD and officer yells, he's coming

out. Watch it! According to the ECD report at 19:41 seconds into the video, and ECD is deployed again. Officers then retreat to the hallway and hold on the apartment door.

At this time, it appears that at least one West Allis Police Officer is arriving on scene and Officer MUNOZ and Corporal ROHLEDER are briefing him as to what had transpired. Officers are heard saying that they do not know about weapons and Corporal ROHLEDER said that this guy is a "MO". Officer MUNOZ tells the West Allis officer that he (referring to TRAMMELL) is in cuffs, but that they are in front of him and Corporal ROHLEDER is saying that he (TRAMMELL) is really strong. At nineteen minutes and fifty-four seconds into this video, Corporal ROHLEDER, who is holding on the front door, again deploys his ECD, at which time screaming is heard in the background that appears to be coming from within the apartment.

Officer MUNOZ briefs West Allis Police Department officers that TRAMMELL is all wet and very slippery. Corporal ROHLEDER says that they are going to need more bodies, as he (TRAMMELL) is finally out of the bathroom. While West Milwaukee officers appear to be briefing West Allis officers, Corporal ROHLEDER is holding outside the apartment door. Over a squad radio, you can hear a request of at least four more needed here. WAPD officers are advising their dispatchers of what is taking place at that time.

At twenty-one minutes and one second into the video, you can hear TRAMMELL screaming within the apartment. Corporal ROHLEDER is speaking with another officer, when you can hear the screaming in the background and Corporal ROHLEDER says, still in him. Corporal ROHLEDER had deployed his ECD. The ECD wires can still be seen hanging from Corporal ROHLEDER's ECD and are stretched out into the apartment. A WAPD officer says, so long as you can keep him in the bathroom, free from weapons.

Officers from the West Allis Police Department and West Milwaukee Police Department begin communicating among themselves. Portions of these conversations are picked up by Officer MUNOZ's body cam; however, I was unable to hear all of the conversations. At twenty-one minutes and twenty-seven seconds into this video, you hear on the radio someone say something to the effect that tasers are ineffective. At twenty-one minutes and twenty-five seconds into the video, you hear a reply over the radio that tasers are highly ineffective right now. Someone can also be heard radioing out that apparently he is a Chapter 51 of some sort.

Officer MUNOZ then briefs West Allis Police Department officers that the suspect is in handcuffs and that even with his handcuffs on, he managed to pull him down underneath his leg. Corporal ROHLEDER is still holding on the door to the apartment.

Officer MUNOZ briefs the West Allis officers about the dimensions of the bathroom, while also telling them that it was going to be to their right and

that he had removed the door. At twenty-four minutes and fourteen seconds into the video, you can hear someone radio out to just make sure that MFD was enroute. Dispatchers are heard replying that they are staged out front. Corporal ROHLEDER continues to hold on the door, while peeking inside.

Twenty-five minutes and eight seconds into the video, a West Allis Police Department officer is seen arriving with a tactical shield. West Allis officers are now briefing other West Allis officers who are arriving on scene. They can be heard explaining to each other that this is a welfare check and that the suspect is cuffed in front. Officer MUNOZ again explains that the suspect is cuffed in front. WAPD and WMPD Officers are making approach considerations.

Officer MUNOZ told West Allis Police Officers that even though the suspect was handcuffed in front, he (TRAMMELL) still pulled him down. West Allis Police Department officers are briefed on the fact that TRAMMELL was turning on the water and that it is very wet right now. Someone can also be heard saying that he is in the bathtub and he is all wet. At twenty-seven minutes and thirty-five seconds into the video, a West Allis officer points to the brim of his hat, asking if he this this going, referring to the body cam, and Officer MUNOZ is heard saying, "Yeah, yeah". Corporal ROHLEDER tells West Allis officers that there is water everywhere.

West Allis officers are then planning an entry. While doing this, Corporal ROHLEDER is still holding on the door. At twenty-nine minutes and thirty-five seconds into the video, the West Allis officer assigned to the tactical shield walks to the apartment. A West Allis officer is briefing the other West Allis officers, telling them something to the effect of, "Nothing but bodyweight". They say that when we do get him on his belly, to just make sure he can breathe. Officers begin stacking on the door, going over their final briefing. TRAMMELL is seen still in the tub and the water is still running. A WAPD officers says something to the effect of take that out, possibly referring to the ECD lines still in Corporal ROHLEDER's ECD. The video ends at 30:30.

<u>SUMMARY REVIEW OF OFFICER ANTHONY MUNOZ'S SECOND BODY CAMERA VIDEO</u>			
Tuesday, 06/06/17			
<p>On the above day and date, I reviewed a seventeen minute and three second body camera video from West Milwaukee Police Officer ANTHONY MUNOZ's body camera (serial #X78102230). The video begins with West Milwaukee Police Corporal ROHLEDER still holding on the apartment door. West Allis officers are finalizing their approach considerations. Although some of the audio is not clear, West Allis Police Officer KLEINFELDT that Corporal ROHLEDER that this would only agitate him. The decision to enter is then made and Corporal ROHLEDER goes into the apartment first, with a West Allis officer telling Corporal ROHLEDER to turn his ECD off.</p> <p>As they enter into the apartment, Corporal ROHLEDER passes the doorway which leads to the bathroom. The next officer in line is the West Allis officer who is carrying the tactical shield.</p> <p>In order to enter into the bathroom, there is what appears to be a walk-in type closet, which officers will have to enter through before encountering another door, which leads to the bathroom. The bathroom door, however, had been previously taken off by West Milwaukee Police Department officers.</p> <p>The West Milwaukee officer carrying the ballistic shield, identified as Officer FLETCHER, then walks through the walk-in closet and stops where the bathroom door would be. An unknown officer asks, "What's his name?" and Officer MUNOZ yells, "BRANDON". Officers then yell out, "BRANDON! We are coming in! Okay?". Another voice is heard saying, "BRANDON, we are coming in".</p> <p>Officer FLETCHER then enters into the bathroom carrying the ballistic shield. I could see in the video that the curtain was pulled about halfway. TRAMMELL was laying on his back and still had his handcuffs on in front of him. TRAMMELL was holding a plastic gallon container and was moaning.</p> <p>In the background, officers are heard saying, "You're okay. You're alright BRANDON". Officers are then heard saying, "BRANDON, we just want to help you, okay?" Officers then tell BRANDON, "We've got to help you out now".</p> <p>Officer KLEINFELDT then asks, "BRANDON, can you turn over? Stand up for us?" TRAMMELL is then told to roll onto his side. West Allis Police Officer FLETCHER was still covering the lower body of TRAMMELL with the tactical</p>

shield. TRAMMELL is told, "Roll onto your side, dude". TRAMMELL is again told to roll onto his side. While commands were being given, water is heard running.

Officers again command BRANDON to roll onto his side and TRAMMELL mumbles something which sounds like, "No, no". Officers tell TRAMMELL, "We're here to help you", and TRAMMELL responds saying something that sounds like no. Officers tell TRAMMELL, "You've got to roll onto your side BRANDON". TRAMMELL is moaning and someone then says, "I don't think we should take those cuffs off".

The next portion of the video is somewhat inaudible and officers are then heard saying, "Get him onto the rig and strap him down". West Allis Police Officer FLETCHER was still covering the lower half of TRAMMELL's body with the tactical shield. Standing to the right of Officer FLETCHER is Officer KLEINFELDT. The suspect is still moaning at this time and officers are heard saying, "You're going to be okay BRANDON". Another officer says, "BRANDON, you'll be alright". Officer KLEINFELDT then says, "My name is JOHN. We are going to get you out of the tub, BRANDON. Can we help you out of the tub?" TRAMMELL appears to mumble, "No". While reviewing the video, it appears that Officer KLEINFELDT is reaching into the tub to go hands-on with TRAMMELL and TRAMMELL starts resisting. Officer FLETCHER pins TRAMMELL's legs down with the shield.

And unknown officer asks, "Are you pulling or pushing him". TRAMMELL is then pulled out of the tub and his face is face downwards. TRAMMELL's hands are still handcuffed, with his hands now stretched out in front of him. Two officers are grabbing TRAMMELL by his arms and are pulling him out of the bathroom. An unknown officer or officers have TRAMMELL's legs. Officers are telling TRAMMELL, "You're okay". Officer MUNOZ is heard saying, "We're helping you". Officer MUNOZ's body camera then goes out of focus for a few seconds. An unknown officer asks, "We got a cot waiting for him?". Officers are then heard saying, "Hey, have your dispatch get that cot ready from MFD".

Officers move TRAMMELL a short distance and stop and officers are heard saying, "Watch out, he's puking". Officers then ask, "Do you think you can get the cot up here?"

TRAMMELL is breathing and there is an occasion moan and scream coming from TRAMMELL. In the background, voices can be heard, but area very faint. Voices can be heard saying, "You're okay, BRANDON".

TRAMMELL then screams and voices are heard saying, "BRANDON, you're fine". TRAMMELL continued screaming and making guttural noises. TRAMMELL can be heard breathing and moaning, with officers saying, "BRANDON, you're fine". At this point, it appears Officer MUNOZ's body camera is now on the ground. TRAMMELL is heard moaning, at which time someone is heard in the background.

saying, "You want too see if they got ketamine?" Not all of the audio is audible due to background noise. As the conversation continues, there is further talk about ketamine. TRAMMELL continues to scream and moan and officers are telling TRAMMELL, "Breathe, buddy".

Officers are then heard telling TRAMMELL, "You're okay, BRANDON". TRAMMELL then begins screaming something to the effect of, "I bleed the blood of Jesus". TRAMMELL screams this over and over. TRAMMELL continues to scream something that sounded like, "I bleed the blood of Jesus". An unknown person asks, "You guys have any ketamine?". TRAMMELL then screams, "Jesus! Jesus!". A voice is then heard saying, "You want to throw ketamine into him right away?" There is more audio; however, it can not be heard. As the video continues, you can hear someone say, "They won't move him unless you do it". It is unknown who is having this conversation about getting ketamine, administering ketamine, and who made this statement. Unknown persons keep saying, "Keep breathing, BRANDON". A voice is then heard saying they are going to try to give him something to calm him down. TRAMMELL is screaming and screams something that sounds like, "The blood of Jesus! I bleed the blood of Jesus". An unknown person then asks if the apartment is clear. TRAMMELL is still screaming about bleeding the blood of Jesus, over and over again.

In the background, you hear voices talking and someone says, "We have to do it by weight". TRAMMELL yells something about Jesus and continues screaming. While voice are talking and TRAMMELL is screaming, a voice, which sounds like Corporal ROHLEDER, says, "We had three different tasers", at which time another voice is heard saying, "Keep breathing. Deep breaths". A voice believed to be Corporal ROHLEDER then says something to the effect of, "It slows him down and he jumps right back up. We got the handcuffs in the front". The voice also says something about "in the bathtub all wet" and, "It was just me and TONY and there was no room for DANI".

TRAMMELL starts screaming again, something to the effect of "Jesus, I bleed the blood". Someone then tells TRAMMELL to take a deep breath. An unknown person says, "We got a cot downstairs". Someone then says, "You're doing great BRANDON. Take a deep breath". TRAMMELL still sounds agitated and is yelling and screaming. As TRAMMELL is yelling and screaming, a voice in the background is heard saying something about in the shoulder and probably in a minute. Someone then asks for a towel. TRAMMELL is still screaming and making guttural sounds. A voice is heard saying in the background that he may have drank a lot of water. TRAMMELL is still screaming over and over again, "Jesus. Jesus".

At ten minutes and twenty-eight seconds into the video, an unknown person is telling TRAMMELL, "Breathe BRANDON, breathe BRANDON". Someone then asks if there is a way to get the cot up there. At ten minutes and fifty-one seconds into the video, someone says, "It sounds like he is starting to quiet

down a little bit. Yeah, he's puking". TRAMMELL is making noises and there are voices making references about TRAMMELL having drank a lot of water. Unknown persons are telling TRAMMELL, "Breathe BRANDON. Breathe buddy. Breathe". Someone then says, "I think we'll probably tape him and see if he calms down enough and maybe we won't need it". At eleven minutes and fifty-two seconds into the video, an unknown person is saying, "Keep breathing buddy. You'll be okay, BRANDON. Keep breathing". In the background, a person believed to be Corporal ROHLEDER says, "This is like an all-out fight and we weren't winning". At thirteen minutes and thirty-four seconds into the video, someone tells TRAMMELL, "Keep breathing BRANDON. Keep breathing buddy". At thirteen minutes and forty seconds into the video, an unknown person says that he is not breathing anymore. At thirteen minutes and forty-six seconds into the video, an unknown person says that he just stopped breathing. At fourteen minutes and four seconds, Officer MUNOZ's body camera begins to come into focus and you can see that most officers had released their hold and TRAMMELL was now being tended to by the Milwaukee Fire Department. At fourteen minutes and twenty-three seconds, MFD carries TRAMMELL downstairs in a soft cot. Someone is heard saying that he still has a strong pulse. At fourteen minutes and forty-one seconds, someone says, "Let's get a bag mask ready".

TRAMMELL is then carried to the first floor, where he is put onto a cot. Officer MUNOZ asks Officer ENGEN to start taking pictures of the hallway and everything else. West Milwaukee Police Officers then begin releasing West Allis Police Department officers from the scene.
