On Wednesday 05/23/18 at approximately 1531hrs I was working the Watch Office 4545 N. Henry Blvd, Stockbridge, GA 30281. I met with the complainant, Timothy Savage DO[REDACTED], in reference to threats.

Mr. Savage stated that on today's date [REDACTED], at about 1510 hrs he received a phone call from a Mr. James Mason (unknown DOB, phone number: [REDACTED]) and that Mr. Mason had threatened to kill him. Mr. Savage also stated that his daughter (Joycelyn Savage DOB: [REDACTED]) was being held by Robert Kelly (AKA: R. Kelly).

I asked Mr. Savage why Mr. Mason had threatened him and Mr. Savage stated that it was because R. Kelly was holding his daughter. Mr. Savage informed me that he had been attempting to contact his daughter, but had been unable to reach her. Mr. Savage stated that Mr. Mason contacted him because of Mr. Savage attempting to contact Ms. Joycelyn. Mr. Savage stated that Mr. Mason stated " Im gonna do harm to you and your family, when I see you I'm gonna get you, Im going to fucking kill you".

Mr. Savage stated that he had a witness on the phone, during the time that the threats were made. Mr. Savage stated that he had been on the phone with a Mr. Angelo Clary (unknown DOB, phone numbe[REDACTED]), when Mr. Mason called him (Mr. Savage). Mr. Savage stated that he place the phone call to a three-way conversation, and told Mr. Clary to be quiet. Mr. Savage stated that Mr. Clary heard Mr. Mason make the threats.

Mr. Savage stated that his wife, Jonjelyn Savage (D[REDACTED]) had heard part of the conversation. I had Mr. Savage contact his wife by phone and Ms. Savage stated that she had only heard the end of the conversation. Ms. Savage informed me that she had not heard the threats. I made brief contact with Mr. Clary by telephone [REDACTED] but I was unable to ask Mr. Clary any questions, due to Mr. Clary having bad cellphone reception at the time. I attmpted to contact Mr. Clary again at a later time, and was unable to make contact with Mr. Clary. I left Mr. Clary a voicemail stating for him to call me back and provided him the phone number to the Watch Office.

NARRATIVE:

I asked Mr. Savage what he had meant by his daughter being held by Mr. Kelly. Mr. Savage stated that he had not had any contact with his daughter in over two (2) years. Mr. Savage stated that he and his wife had reported Ms. Joycelyn missing from her college in December of 2016. Mr. Savage stated that since that time they have attempted several welfare checks on Ms. Joycelyn. Mr. Savage stated that he believes that Mr. Kelly is running a sex cult and has several other women living with his daughter. I ran Ms. Joycelyn through GCIC and observed that she was not listed as missing.

Mr. Savage's verbal statement was captured on my BWC.

I later spoke with Mr. Savage and Ms. Savage by telephone. I was informed that Chicago PD had made contact with Ms. Joycelyn (since she was reported missing) around September of 2017. Mr. and Ms. Savage stated that they believe that Ms. Joycelyn is still staying in Chicago ( [REDACTED] ). Mr. Savage stated that he believes that someone was standing with Ms. Joycelyn when Chicago PD met with her, and that is why she did not admit to being held.

Ms. Savage stated that she believes that the threats started yesterday, because they have had so much media attention, due to the ongoing situation with Ms. Joycelyn. Ms. Savage stated that R. Kelly has been having things get cancelled, because of the ongoing issues.

I asked the Savages why they believed she was being held against her will and they stated it was because they had not had any contact with her and also because of the other women living in the house. Mr. Savage asked what he needed to do to report Ms. Joycelyn as missing, and I informed the Mr. Savage to contact Chicago PD, since they were the last known persons to have contact with Ms. Joycelyn.

Mr. Savage had no other relevant information to provide at this time.
