

Prairie Village Noise Ordinance Discussion June 18, 2018





Current Noise Ordinance

- "Disturbing the Peace" Section 11-201 of Prairie Village Municipal Code (conflicting language in 2-125 and 8-504 that needs to be cleaned up)
- Applies to all noise within the city such as construction, music, neighborhood parties, etc.
- Noise is permitted at the following times:
 - 7 a.m. 10 p.m. on weekdays
 - 8 a.m. midnight on weekends



Enforcement of the Noise Ordinance

- Majority of complaints are regarding construction starting before 7


 a.m.
- Notice of noise ordinance is provided to all contractors and printed on building permit
- Violations should be reported to Police Department at non-emergency number (complaints often come in hours after the violation occurred, which makes enforcement difficult)





Mission Hills	8 a.m 8 p.m. weekdays, 8 a.m 6 p.m. Saturday; Not permitted on Sunday
Mission Woods	7 a.m 8 p.m. weekdays, 7 a.m. to 5 p.m. Fri & Sat; 12 p.m 5 p.m. Sundays and holidays
Olathe	7 a.m 11 p.m.
Overland Park	7 a.m. – 10 p.m.
Prairie Village	7 a.m 10 p.m. weekdays; 8 a.m midnight on weekends
Roeland Park	7 a.m 9 p.m.
Shawnee	7 a.m 10 p.m. weekdays; 8 a.m. – 9 p.m. weekends
Westwood	7 a.m. to 9 p.m. on weekdays, 8 a.m. to 10 p.m. on weekends
Westwood Hills	8 a.m 8 p.m. Monday - Friday, 8 a.m. to 6 p.m. Saturdays, 10 a.m. to 5 p.m. Sundays













Building Permits Issued by Ward in 2018






2017 Code Enforcement Cases by Ward

 - Staff does not recommend changing the 7 a.m. start time on weekdays; changes would affect Public Works mowing and street crews as well as trash collection
