Writer was in the accompaniment of SA Pete Cunningham, FBI. SA Cunningham had arranged to meet DANNY JAMES HEINRICH, at the Paynesville Police Department approximately 1400 hours.

Approximately 1348 hours, DANNY JAMES HEINRICH, 16021 CR 124, Paynesville, MN, arrived at the Police Department. DOB 3-21-63, home phone Mr. Heinrich arrived in a 1982 Ford EXP, bearing MN lic. #188AOB. Vehicle was blue in color, 2-door. It should be noted that Mr. Heinrich's former address on his drivers license is 121 Washburn Avenue #10, Paynesville, MN.

SA Cunningham fingerprinted and received body hairs from Mr. Heinrich. Mr. Heinrich then signed a consent to search of his vehicle in the presence of this writer. Search was conducted of Mr. Heinrich's vehicle with no items seized. Photographs were taken of the tires which were consistent with those tires found at the scene by gross tread design.

Following completion of the Polygraph examination, SA Larry Brubacher, SA Cunningham and this writer verbally spoke with Mr. Heinrich. See SA Cunningham and Brubacher's reports for the context of that interview. It should be noted that during the interview writer observed Mr. Heinrich's soles of his shoes. Found them to appear to be consistent with the footprint pattern found at the scene of the Wetterling abduction. Mr. Heinrich indicated that he had those shoes for over a year and had purchased them at-
