

Starting off the round of breakfast speakers at LP/10 will be David Friedman, noted authority on libertarian economics. He will provide a libertarian overview on the law and political economy.

Friedman is the author of The Machinery of Freedom: Guide to a Radical Capitalism.

He began his career with a background in the scientific disciplines. He is a 1965 graduate of Harvard University in chemistry and physics: he holds a Ph.D. Degree in physics from the University of Chicago and has done post-doctoral work in physics at Columbia University.

He spent three years at the University of Pennsylvania in post-doctoral study of economics. He has served as assistant professor of economics at Virginia Polytechnic Institute, and is currently professor of economics at UCLA.

He has authored popular and professional articles on libertarianism, law, economics, history, transportation and a wide variety of other subjects.

Also, he has delivered speeches on libertarianism throughout the U.S. and in Australia, England and Iceland.

# "Where Do We Go From Here?"

As we enter our second decade, the Libertarian Party faces some important decisions. Many aspects of party policy and strategy have been hotly debated since the 1980 election campaigns, and now we have reached the point where choices must be made.

David Bergland's Keynote Address will raise some of the issues we face, and perhaps suggest appropriate directions for the future. Following Bergland's remarks, four veterans of the libertarian movement will offer additional insights, in a lively give-and-take exchange of ideas.

David Bergland has served as National Chair of the Libertarian Party for the past four years.

He was the party's vice presidential nominee in 1976, and ran for U.S. Senate in California in 1980, polling some 200,000 votes.

Recently, he established a new organization called Concepts of Liberty, Inc. and is actively working with leaders in minority communities to build awareness and acceptance of libertarian ideas.

### The Draft

With the current Administration's renewed military sentiment, talk is increasingly being heard of reviving the draft to strengthen our military capabilities. The draft is a major issue, not only for students, but for everyone—parents, taxpayers and the population at large.

Our panelists, all anti-draft activists, will discuss their individual approaches to this issue and how they've made these approaches work for them.

Eric Garris, moderator, is a leading member of the LP Radical Caucus and a longtime community activist and organizer in San Francisco.

Bonnie Kaplan is a nationally recognized spokesperson against the draft. She helped form the Chicago Coalition Against Registration and the Draft (CCARD) in 1979 and engaged in a variety of public speaking and publicity activities for that group. She resigned from CCARD in 1980. She is currently a member of the governing body of the Midwest Committee for Military Counseling and is involved with the Ad Hoc Committee to Disseminate Draft Information. She organized and ran a libertarian group for five years, was a delegate to the 1975 national LP convention, and has authored articles for a number of libertarian publications. She is also active in ALF.

### Panel

Jeff Friedman is the national director of Students for a Libertanan Society (SLS), which has been a leader of the anti-draft movement since 1979. Jeff represented the libertanan movement at numerous national meetings of anti-draft forces. He has also been director of Students for Clark, as well as working on the MacBride and Hospers campaigns and writing for Libertanan Review. He is on leave from Brown University.

David Henderson holds a Ph.D. in economics from UCLA. He is currently writing a book opposing the draft, not only from an economic standpoint, but from a civil liberties standpoint as well; he believes the draft is slavery. He testified against draft registration two years ago before the Senate Armed Services Committee He also has engaged in a variety of anti-draft activities, including speeches and articles for a variety of audiences. Most recently, he has written an economists' statement against the draft for Libertarian Review and Inquiry Henderson teaches economics at the University of Santa Clara. He formerly was professor of economics at the University of Rochester. He also served as senior policy analyst at Cato Institute and was editor of Policy Report.

### **Edward Lozansky**

Edward Lozarsky is a physicist at George Mason University and evecutive director of the Sakharov International Committee, Washington D.C.

His work with the Committee involves organizing protests about the repression of Soviet dissidents such as Andrei Sakharov, eviled physicist and human rights activist. The Committee a voluntary organization with members worldwide believes violation or human rights by a superpower such as the Soviet Union represents a major threat to world peace.

Lozarsky will speak on "The Soviet Threat: Myth or Reality" He will discuss some traditional aspects of Russian culture and communist ideology that have led to current Soviet policies which he describes as a "morster." Lozarsky will tell why he believes defense of Soviet dissidents is not only a moral obligation to protect human rights, but also is a necessity for the survival of the free world.

The story of Lozansky's own personal repression has received international attention. He emigrated in 1976 from the Soviet Union where he was a researcher at the Institute of Atomic Energy and physics professor at the military Academy in Moscow. In 1975, he was fired from all his jobs for mentioning Andrei Sakharov's achievements in science to his students. His efforts to free his wife and daughter to join him in the U.S. have been unsuccessful; they are unable to emigrate from Moscow without permission of his wife's father who is a three-star Soviet general.

#### Resources and the Environment

Energy and environmental issues are the focus of this panel. Among the topics on the agenda: the federal government's forced development of energy resources, de-regulation of crude oil and natural gas, abolition of the U.S. Synthetic Fuels Corporation, sale of federal water projects, free-market disincentives for pollution, and protecting the environment through the establishment of private property rights.

loseph Sugarman, president and creative director of [5&A Group, Inc., is considered one of America's top copywriters and mail order entrepreneurs. A real Horatio Alger success story. But there's also a horror story in his life—involving Federal Trade Commission actions against his company.

His trouble began in January 1979 when three blizzards in the Chicago area made it impossible for JS&A employees to get to work. Also, the computer broke down. JS&A was late in shipping products and late in notifying customers their orders would be delayed. (An FTC rule requires that anyone paying by check is entitled to have his purchase shipped within 30 days or he must be notified and given the option to cancel.)

The FTC fined IS&A \$100,000 for infraction of the rule; Sugarman fought back. It was the beginning of a long battle that continues today. Come hear what one man is doing to thwart bureaucratic tyranny.

### The Libertarian Feminist Vision: Liberty, Autonomy, Anti-authoritarianism

The Association of Libertarian Feminists, an independent libertarian organization, will sponsor this session on feminist issues.

Bill Evers ran for U.S. Congress in California in 1980, receiving the second highest percentage of any LP Congressional candidate in the 1980 campaigns. He garnered nearly eight percent of the vote in a three-way race. He also is chair of the California LP.

"The Clark Campaign Considered as a Work of Art" will be the topic of Jeff Riggenbach's talk Sunday morning. He will examine what the arts, especially literature, have to do with politics generally and political campaigns in particular. Why so many movement leaders, in their recent attempts to judge the success and significance of the Clark campaign of 1980, have fallen into the error of judging it as though it were a novel or a film instead of a campaign. And how this has led to unnecessary and self-destructive factionalism in the movement

Riggenbach is west coast editor of the Libertarian Review, a magazine with which he has been closely associated since 1978. He first got into Libertarianism in the mid-60s in Houston, Texas, and has written regularly for movement publications (most notably Libertarian Review, Reason, Inquiry, Frontlines, and the old Academic Associates' Book News and Books for Libertarians) since 1972.

A lifelong career journalist, Riggenbach also writes regularly about books and the arts for a number of newspapers, including the New York Times, the Los Angeles Times and the San Francisco Chronicle, and is heard every Monday on 150 radio stations coast to coast as a commentator on current public issues for the syndicated program "Byline."

Jeff Hummel will present "How to Cut the Defense Budget by 90% in One Year: A Modest Quasi-Libertarian Proposal." He plans to review the U.S. defense budget, discussing exactly what we purchase, and he will compare the budget to the dollar amount we would need if our government were defending only the U.S. He will offer an in-depth analysis of our military's organizational structure and hardware, including nuclear weapons as well as conventional arms. Through his analysis, he plans to show that 90 percent of our military expenditures is unnecessary.

Hummel has been a libertarian since he was in the Army. He served as a Second Lieutenant for two and a half years at Ft. Hood, Texas. During part of his stint, he was a tank platoon leader, commanding five tanks and 20 men.

He has written for a wide variety of Libertarian publications. He is currently working on his doctorate in U.S. economic history at the University of Texas; he also teaches history and does free-lance writing.

He has run for State Representative and U.S. Congress in Colorado and has been a member of the Libertarian National Committee since 1977, John and his wife Sally live in Denver where he practices architecture and she teaches interior design.

After the election of National Chair, we will elect the Vice-Chair, Secretary, Treasurer and At-Large Members of the National Committee.

#### Highlights from LP History

1971

Dismayed by **Richard Nixon's** attacks on civil liberties and economic freedom, five Colorado libertarians led by **Dave Nolan** debate the idea of forming a new, pro-freedom party. After an inconclusive meeting in July, they agree to reconvene a month later. Their next meeting falls on August 15, the day Nixon announces wage-price controls and demonetization of the dollar; this goads them into action.

Throughout the fall, they contact other libertarians and draft a tentative platform. On December 11, at a meeting in Colorado Springs, the original group plus three additional members votes formally to found the Libertarian Party. Membership passes 100.

1972

A survey of the fledgling party's members shows **Murray Rothbard** to be their first choice for a presidential nominee; second is **Alan Greenspan**. The party's first press conference, held in Denver on January 31, receives international news coverage, including a lengthy piece in the *New York Times*.

At a June nominating convention in Denver — held, ironically, the same weekend as the Watergate break-in — 89 of the new party's 800 members adopt a Statement of Principles written by John Hospers and name him as their first Presidential candidate; Tonie Nathan of Oregon is chosen for the VP slot. Susan Nolan is elected Party Chair; Ed Clark becomes Vice Chair.

On the ballot in only two states — Colorado and Washington — the Hospers-Nathan ticket draws about 5,000 votes on Election Day. Six weeks later, on December 18, **Roger MacBride** of Virginia casts an Electoral Vote for the LP slate, making Tonie Nathan the first woman in history to receive an Electoral Vote. MacBride's act triples public awareness of the LP overnight.

The First Ten Years

1973

The LP's second convention, held June 8-10 on the outskirts of Cleveland, Ohio, draws 175 participants. Combined state and national membership passes 3,000. New York Mayoral candidate Fran Youngstein receives 8,800 votes, running fifth in a field of nine and almost outpolling four leftist splinter candidates combined. Gary Greenberg, running for District Attorney in Manhattan, receives 8,300 votes - nearly 3.7% of the total vote cast.

Utah becomes first state where LP 1974 attains ballot status

> Hal Jindrich recens over 200,000 votes for Supermental and Education in California; his record stands until 1978.

Third annual convention in Dallas draws 300. Ed Crane defeats Scott Royce for National Chair by 4-to-1 margin; Andrea Millen is unopposed for Vice Chair. Business conventions are moved to odd-numbered years. Party HQ moves from Denver to San Francisco.

Party fields 32 candidates in November elections. Kay Harroff receives 79,400 votes (nearly 3%) in the U.S. Senate race in Ohio; Jerry Tuccille polls only 10,200 in New York Governor's race. His poor showing is attributed to "stunts". Hospers is a write-in for Governor in California; David **Bergland** runs for California Attorney General. Congressional contenders include Sandy Cohen and Ken Kalcheim (New York), Bob Steiner (New Jersey), Karl Bray (Utah) and Jerry Millett (Louisiana). None fares especially well.

1975

Presidential nominating convention in New York City draws 500 libertarians. Roger MacBride wins top spot in an easy first ballot victory over Kay Harroff and Guy Riggs, but controversy erupts over VP nomination. MacBride vetoes selfproclaimed "tax resister and smuggler" lim Trotter, who is leading after first VP ballot. Second ballot deadlocks. David Bergland, who flies in from California overnight, is chosen the next day. Despite problems most LP members leave with enthusiasm, and news coverage is excellent. Crane and Millen are re-elected to lead party; HO is moved from San Francisco to Washington, DC.

LP candidates enter local races in fall; most ambitious mayoral campaigns are those of **Ray Cunningham** (San Francisco) and **Dave Long** (Boston).

1976

Inspired by tireless campaigners

MacBride and Bergland, over 250
other Libertarians run for office;
Michigan tops the list with 86. Media
coverage accelerates. U.S. Senate
candidate Steve Trotter, running in
Utah, is endorsed by that state's former
Governor. "Pep Rally" convention in
Washington, DC, draws 600. MacBride
and Bergland are listed on ballot in 31
states and DC.

On Election Day, the LP ticket polls 172,000 votes; only one-fourth as many as Independent candidate **Eugene McCarthy**, but narrowly edging out **Lester Maddox** to lead the minor-party pack. Best showing: 6% in Alaska. Many state and local candidates top this mark; **Larry Fullmer** receives 30% in a State Senate race (two-way) in Idaho.

1977

Sixth annual convention, San Francisco, July. Speakers range from Timothy Leary and Robert Anton Wilson to Roger MacBride and Eugene McCarthy; the latter both speak at a banquet of over 1,000 people. David Bergland is elected Chair without opposition; Mary Louise Hanson is chosen Vice Chair, also unopposed.

Elaine Lindsey is elected to the City Council in Circleville, Ohio. David McNeill receives over 27,000 votes (29%) in a six-way City Council race in Phoenix.

1978

Ann Hammond places second in a three-way City Council race, scoring 32%, in Garland, Texas. Barbara Hutchinson polls 118,000 votes running for Assessor in San Diego County — less than 1,000 votes behind the incumbent. Libertarians are active and visible in California's Proposition 13 battle.

A Labor Day Weekend convention in Boston draws only 400, but more than 150 Libertarians run for public office around the country; Arizona has 42, Nevada 23. Combined total vote is 1.3 million. Biggest news: Dick Randolph wins state legislature seat in Alaska, becomes first Libertarian legislator. Ed Clark polls 380,000 votes (5.5%) for Governor in California — the best showing by a third-party candidate since 1946. Gary Greenberg receives 19,000 votes for Governor in New York.

1979

Ed Clark and Bill Hunscher engage in spirited contest for LP presidential nomination; 1,500 turn out for nominating convention in Los Angeles, September 6-9. Clark wins handily; VP slot goes to David Koch of New York, who defeats "None Of The Above" on first ballot. Bergland and Hanson reelected as party Chair and Vice Chair without opposition.

California party activists register more than 80,000 voters as Libertarians by December 31, thereby giving the LP ballot status in that state.

1980

Murray Feldstein wins City Council seat in Flagstaff, Arizona; runs third in a field of six, receiving 2,600 votes. Drive to repeal Alaska state income tax, led by Dick Randolph, is successful. Bill White receives 18,539 votes (12%) in a three-way race for California State Senate. Robert Murphy polls 6% in Tulsa mayoral contest.

Nearly 500 candidates run on LP label. Clark-Koch ticket achieves ballot status in all 50 states plus DC, a feat never before accomplished. Campaign generates feature articles in many publications, disappointingly little national news coverage. Clark and Koch garner 921,000 votes — slightly over 1% of the national total — thus outpolling Eugene McCarthy four years earlier, but getting only one-sixth the vote of Independent entry John Anderson.

Dick Randolph is re-elected in Alaska by a huge margin; a second Libertarian, Ken Fanning, is also elected to the Alaska legislature and Stan Thompson becomes Mayor of Kenai Borough. In California, David Bergland receives 203,000 votes for U.S. Senate, while Dan Mahaffey polls 8.1% in a three-way race for Congress; Mahaffey's raw vote total exceeds that of 22 Republican Congressional contenders. Total vote for all Libertarian candidates tops four million.
