Buckley v. Valeo

Several of the plaintiffs have asked about our disbursements during the case. The total for all such expenditures by the firm is approximately \$39,000. American Conservative Union and the ACU Education & Research Institute have contributed \$6,000, and, in addition, have paid over \$3,000 to Professor Winter for his research assistant and other miscellaneous expenses. Senator Buckley has raised \$7,000, and the New York Civil Liberties Union recently sent us \$5,000. In addition, the NYCLU has met all of Joel Gora's expenses. Representative Steiger has contributed \$250. Another \$2,000 has been received as payment for copies of our briefs or other documents. Both Senator Buckley and Representative Steiger have provided us at various times with a staff member to do statistical research. The remaining unpaid disbursements total almost \$19,000.
