The program will run from 8:45 a.m. to 5:00 p.m. in the Grand Ballroom of the Chicago Standard Club. The panel discussions will be titled:

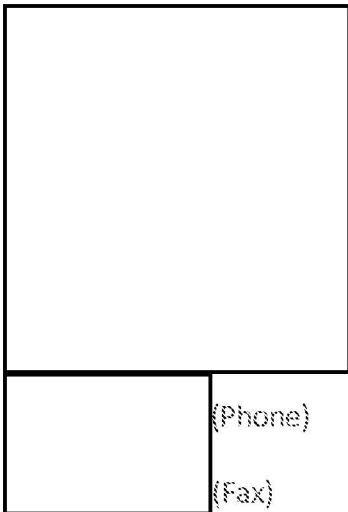
- "The Relationship Between Law Enforcement and the Community";
