3 COUNT I:

4 That in the First Judicial District, State of Alaska, on or about March 6, 2018, at
5 or near Juneau, JAMIE D SINGH knowingly engaged in conduct that resulted in the
6 death of Mary Singh under circumstances manifesting an extreme indifference to the
7 value of human life.

8 All of which is an unclassified felony offense being contrary to and in violation of
9 AS11.41.110(a)(2) and against the peace and dignity of the State of Alaska.

10 COUNT II:

11 That in the First Judicial District, State of Alaska, on or about March 6, 2018, at
12 or near Juneau, JAMIE D SINGH recklessly caused the death of Mary Singh.

13 All of which is a class A felony offense being contrary to and in violation of
14 AS11.41.120(a)(1) and against the peace and dignity of the State of Alaska.

15 COUNT III:

16 That in the First Judicial District, State of Alaska, on or about March 6, 2018, at
17 or near Juneau, JAMIE D SINGH with criminal negligence, caused the death of Mary
18 Singh.

19 All of which is a class B felony offense being contrary to and in violation of
20 AS11.41.130 and against the peace and dignity of the State of Alaska.

22 COUNT IV:

23 That in the First Judicial District, State of Alaska, on or about March 6, 2018, at
24 or near Juneau, JAMIE D SINGH knowingly engaged in conduct that resulted in serious
25 physical injury to Mary Singh under circumstances manifesting an extreme indifference
26 to the value of human life.

1 All of which is a class A felony offense being contrary to and in violation of
2 AS11.41.200(a)(3) and against the peace and dignity of the State of Alaska.

4 COUNT V:

5 That in the First Judicial District, State of Alaska, on or about March 6, 2018, at
6 or near Juneau, JAMIE D SINGH recklessly caused serious physical injury to Mary
7 Singh.

8 All of which is a class B felony offense being contrary to and in violation of
9 AS11.41.210(a)(2) and against the peace and dignity of the State of Alaska.
