VOCATIONAL EDUCATION



We must remove the stigma and shine a positive light on vocational education so we can prepare Ohio's workforce for the future.

By emphasizing vocational education in the schools with inclusion of career certificates as part of high school curriculum, businesses will have an increased pool of skilled employees. Students will embrace greater choice in their career path.

ENERGY



Ohio needs to assure an 'all of the above' energy system, which includes nuclear, coal, oil, gas, wind, and solar.

Our resources are plentiful in oil, gas, coal, and nuclear. We must secure those resources and enhance our grid to include wind and solar to meet energy needs.

MUNICIPAL INCOME TAX



The requirement to file municipal income tax returns everywhere a company does business is costly and impedes growth. By reforming Ohio's municipal income tax laws to become uniform, it will reduce costs on businesses and government waste.

HEALTHCARE

Healthcare costs are skyrocketing. Medicaid Expansion will cost Ohio taxpayers 5.2 billion dollars a year by 2021. One in four employees are currently utilizing Medicaid Expansion, which places the burden on the work force and stymies economic growth. Workers compensation must also be overhauled to meet the needs of Ohio's business community. Ultimately, these reforms will lead to more affordable healthcare for all Ohioans.
