

- B. DETAINEE DISCUSSED ABOUL RAHMAN. ABOUL RAHMAN LIVED IN MASTOON, PARISTAN. DETAINEE STATED THAT ABOUL RAHMAN LOOKS LIKE DETAINEE, BUT HAD WIDER WIDER SHOULDERS AND WAS A LITTLE OLDER THAN DETAINEE. DETAINEE THOUGHT ABOUL RAHMAN DWNED LAND. IDETAINEE COMMENT ABOUL RAHMAN SEEMS WEALTHY.) ABOUL RAHMAN CAME TO ZAHEDAN TWICE. THE FIRST TIME HE CAME FROM QUETTA, PK WITH ONE TURKISH MAN, AND WENT TO DETAINEE'S GROCERY STORE. THE SECOND TIME ABOUL RAHMAN WAS IN ZAHEDAN WITH YUSIF ([LNU]). YUSIF CALLED DETAINEE AND ASKED HIM TO COME TO TO A BAZAAR TO HELP THEM FIND COMB ATTACHMENTS FOR HAIR TRIMMERS. DETAINEE TOLD YUSIF WHERE THEY WERE OVER THE PHONE, BUT YUSIF TOLD DETAINEE TO COME SHOW THEM BECAUSE HE HAD A GUEST, ABOUL RAHMAN. DETAINEE DIDN'T KNOW THE RELATIONSHIP BETWEEN ABOUL RAHAM AND YUSIF.
- C. DETAINEE STATED THAT HE ALSO SAW ABDUL RAHMAN TWICE IN QUETTA, PK. DETAINEE WAS AT HIS BROTHER HAYATULLAHS HOME, AND ABDUL RAHMAN CAME OVER WITH OMAR KANDARI TO HELP MOVE FURNITURE. (FIELD COMMENT THERE IS PRIOR REPORTING FROM BAGRAM THAT DETAINEE AND HIS BROTHER TOOK FURNITURE FROM A HOUSE IN QUETTA, THAT WAS USED TO FACILITATE FAMILIES OF DETAINED AL-QAIDA MEMBERS, AND BROUGHT IT TO HAYATULLAHS HOUSE. DETAINEE TOLD THAT THEY NEVER BROUGHT THIS FURNITURE TO HAYATULLAHS HOUSE. IT WAS ALSO REPORTED IN BAGRAM THAT ABDUL RAHMAN AND OMAR KANDARI CAME TO HAYATULLAHS HOUSE TO PICK THE FURNITURE UP TO BRING BACK TO THE AL-QAIDA HOUSE. DETAINEE TOLD THAT ABDUL RAHMAN AND OMAR KANDARI WERE HELPING HAYATULLAH MOVE HIS FURNITURE. DETAINEE MAY BE TRYING TO HIDE INFORMATION CONCERNING THE VISIT BY ABDUL RAHMAN IN QUETTA.) THE SECOND TIME DETAINEE SAW ABDUL RAHMAN IN QUETTA WAS AT THE FUNERAL OF ABDUL RAHMAN'S BROTHER HAD BEEN IN A CAR ACCIDENT. (DETAINEE COMMENT WHEN ABDUL RAHMAN WAS WITH OMAR KANDARI, IT SEEMED AS IF OMAR KANDARI WAS GIVING A GREAT DEAL OF RESPECT TO ABDUL RAHMAN.)
- D. DETAINEE DISCUSSED ABOUL RAHMANS PERSONALITY AND JOB. ABOUL RAHMAN MADE MONEY FROM USING HIS WHITE SUZUKI TRUCK AS A TAXI. HE DROVE PEOPLE AROUND FOM EVENTS SUCH AS WEDDINGS. DETAINEE STATED THAT ABOUL RAHMAN WAS A SUNNI MUSLIM, BUT WOULD NOT BE A PART OF A SHURA COUNCIL, BECAUSE HE WAS NOT SMART ENOUGH. DETAINEE COMMENT ABOUL RAHMAN WAS A DRIVER, AND A DRIVER WOULD BE CAPABLE OF DOING SHURA COUNCIL.
- ASKED IF DETAINEE KNEW A MAN NAMED ATIYAH. DETAINEE CLAIMED THAT BAGRAM ASKED ABOUT THAT SAME MAN AND SHOWED HIM A PICTURE. BAGRAM TOLD DETAINEE THAT ATIYAH WAS THE SPEAKER FOR USAMA BIN LADEN. (FIELD COMMENT DUE TO THE INFORMATION PROVIDED BY BAGRAM ON ATIYAH, DETAINEE IS CONDITIONED TO GIVE A NEGATIVE RESPONSE TO KNOWING ATIYAH, TO DISTANCE HIMSELF FROM KNOWING HIGH LEVEL INDIVIDUALS.)
- 7. TSTANT COLLECTORS COMMENTS: DETAINEE SEEMS TO HAVE BEEN TOLD MANY THINGS IN BAGRAM. IT SEEMS THAT WHEN BAGRAM TRIED TO EXPLOIT CENTAIN THINGS, THE DETAINEE

GAVE A NEGATIVE RESPONSE, BUT BAGRAM TOLD DETAINEE WRY THEY WERE ASKING, MAKING THE DETAINEE MORE AWARE OF WHAT THE US WAS LOOKING FOR.

B. 13//NET ANALYSTS COMMENTS: DETAINEE APPEARS TO DISTANCE HIMSELF FROM TOPICS AND INDIVIDUALS THAT COULD CAUSE INCRIMINATION. HIS ADMITTED POSITION WITH AQ IN ZAHEDAN PLACES HIM IN RELATION TO AQ LEADERSHIP IN IRAN. 2 IS CONTINUING TO OPEN DOORS OF DATA BY APPROACHING PERSONAL TOPICS WITH THE DETAINEE.

A. 2 GREETED DETAINEE AND SHOOK HIS HAND. 2 STATED THAT DETAINEE SHOULD PICK UP WHERE THEY LEFT OFF THE NIGHT BEFORE. 2 ASKED DETAINEE WH ASKED DETAINEE WHO HE ASSOCIATED WITH AT THE MAKKI MOSQUE. DETAINEE STATED THAT THERE WERE FAR TOO MANY PEOPLE ATTENDING THE MOSQUE TO KNOW EVERYONE WHO WAS THERE. WHEN ASKED DETAINSE ABOUT ABU LUOMAN HAMZA, HE STATED THAT HE DID NOT KNOW ABU LUOMAN HAMZA. TOLD DETAINEE THAT HIS BROTHER KNEW ABU LUOMAN. DETAINEE BECAME VERY ALERT AND VERY CURIOUS, AND ASKED IF HIS BROTHER HAD BEEN ARRESTED. 



THE CIVILIANS DRESSED IN CLOTHING LIKE THE INTERROGATOR, AND NOT IN TRADITIONAL MIDDLE EAST CLOTHING, (FIELD COMMENT WORE KHAKI PANTS AND

LARED SHIRT.



A. 2 GREETED DETAINEE WITH A HANDSHAKE. 2 NOTICED THAT DETAINEE HAD RECEIVED ANOTHER HAIR CUT. 2 ASKED DETAINEE IF HE ALWAYS KEPT HIS MAIR SHORT. DETAINEE STATED HE USED TO GROW HIS HAIR LONG YEARS AGO, BUT SHAVED IT BECAUSE HE HAD PIMPLES ON HIS HEAD. B. DETAINEE GAVE MORE DETAIL ON HIS TRIP TO SARAVAN. DETAINEE STATED THAT THE TRIP FROM ZAHEDAN TO SARAVAN TOOK FOUR TO FIVE HOURS BY CAR OR TAXI DETAINEE AND MULLAH NASIR TRAVELED FROM MAHEDAN TO AN UNIDENTIFIED MOSQUE IN SARAVAN BY TAXI. UPON ARRIVAL AT THE MOSQUE, DETAINEE CALLED HAJI QAYAMUDDIN TO RECEIVE DIRECTIONS TO THE NEXT LOCATION. HAJI QAYAMUDDIN TOLD DETAINEE TO GIVE THE PHONE TO THE DRIVER. THE DRIVER RECEIVED THE DIRECTIONS AND DROVE DETAINEE AND MULLAH NASIR TO A HOUSE OWNED BY A MAN NAMED HAJI ((LNU)). BY THE TIME THE TWO MEN ARRIVED AT HAJI'S HOUSE, EVENING PRAYER HAD ALREADY PASSED. HAJI QAYAMUDDIN, HAJI QAYAMUDDINS BROTHER-IN-LAW, DETAINEE, MULLAH NASIR, AND HAJI WERE ALL SERVED DINNER. AFTER DINNER, HAJI DAYAMUDDIN, HAJI DAYAMUDDINS BROTHER-IN-LAW, DETAINEE, AND MULLAH NASIR WENT TO HAJI QAYAMUDDINS BROTHER-IN-LAW'S HOUSE FOR THE REST OF THE NIGHT. C. DETAINEE STATED THAT THERE WERE POSSIBLY TWO ROUTES INTO PAKISTAN FROM ZAHEDAN. IF ANYTHING, IT WAS LESS CONVENIENT TO GO THROUGH SARAVAN, IT COST ABOUT 3000 TOMAN TO USE THE TAFTAN ROUTE, BUT GOING THROUGH SARAVAN COST ABOUT 6000 TOMAN. D. IN EARLY 2007 DETAINEE TRAVELED TO WAZIRISTAN WITH SAHID ((LNU)). DETAINEE STATED THAT A LETTER FROM ABDUL MAJID NEEDED TO BE DELIVERED TO MIR ALI, PK. DETAINEE AND SAHID TRAVELED FROM ZAHEDAN TO TAFTAN BY TAXI.. DETAINEE PAID THE DRIVER 3000 TOMAN. ONCE IN TAFTAN, DETAINEE AND SAHID RODE A BUS TO QUETTA, PAKISTAN, DETAINEE STATED THAT HE VISITED WITH FAMILY MEMBERS IN QUETTA A SHORT TIME BEFORE CONTINUING ON HIS WAY. DETAINEE AND SAHID RODE ANOTHER BUS TO BANNU, PAKISTAN, TRAVELING THROUGH THE NIGHT. DETAINEE STATED THAT HE NAPPED FOR ONE AND A HALF HOURS WHILE TRAVELING TO BANNU. UPON ARRIVAL IN BANNU, DETAINSE AND SAHID TOOK A TAXI TO A BAZAAR IN MIR ALI, PAKISTAN. ABDUL MAJID HAD GIVEN DETAINEE AND SARID A LETTER WITH RHALID ((HABIB'S)) NAME WRITTEN ON THE OUTSIDE. THE LETTER WAS FOLDED AND TAPED INTO THE FOLDED POSITION. ABOUL MAJID INSTRUCTED DETAINEE TO GO TO THE -MIHABARAT COMMUNICATIONS- PHONE SHOP INSIDE THE MIR ALI BAZAAR. UPON ARRIVAL AT THE PHONE SHOP, DETAINES NOTICED THREE MEN INSIDE, DETAINEE SAW TWO PHONES IN THE SHOP, AND THE THREE MEN WERE MAKING PHONE CALLS AND BEING VERY LOUD. 



ABBULLAH IMPORTED AND EXPORTED VEHICLES FROM UNITED ARAB EMIRATE TO SYRIA. DETAINEE STATED ABBULLAH MOST LIKELY DID NOT SELL CARS TO HIS TRANIAN ASSOCIATES BECAUSE TRANIANS DID NOT DRIVE JAPANESE MADE CARS. DUBAT, UAE WAS A PRIME USER OF JAPANESE AND KOREAN MADE VEHICLES. THE PREVIOUS DAY. DETAINEE STATED THE SHOP ONLY SOLD PHONES, THEY DID NOT SELL INDIVIDUAL SIM CARDS. DETAINEE STATED THE PARTNERSHIP WAS FOR SEVEN MONTHS BETWEEN DETAINEE, YACOUB, AND HAJI MIRULLAH. DETAINEES JOB WAS TO GO AROUND THE BAZAAR AND SELL PHONES TO THE OTHER SHOP OWNERS. THE PHONES WERE BROUGHT IN FROM BANDAR ABBAS, IR AND THEN FIXED ON THE COMPUTER TO WORK IN IRAN. THERE WAS NO PROFIT MADE ON SIM CARDS AS FAR AS DETAINEE KNOWS. DETAINEE STATED HE WORKED ON THE SECOND FLOOR. DETAINEE STATED THE PHONES WOULD COME TO THE FIRST FLOOR WHERE EACH PHONE WOULD BE MATCHED UP WITH A SIM CARD. THE SIM CARDS WERE IRANIAN BUT THE PHONES WERE NOT SO THE INTERNAL SERIAL NUMBER ON THE PHONES NEEDED TO BE CHANGED USING A COMPUTER TO MATCH THE IRANIAN SIM CARDS. ONCE THE PHONES WERE MATCHED UP WITH SIM CARDS THE PHONES WOULD BE SENT UP TO DETAINEE WHERE HE WOULD THEN TAKE THE PHONES OUT INTO THE BAZAAR TO SELL THEM TO OTHER SHOP OWNERS.

- C. DETAINEE DISCUSSED THE CHANCE OF THE SHOP BEING MOVED. DETAINEE STATED THE PRIMARY OWNER OF THE SHOP, HAJI MIRULLAH, WAS ANGERED ABOUT THE HOURS OF THE SHOP. DETAINEE STATED THE BAZAAR SET THE SAME HOURS FOR ALL THE SHOPS INSIDE THE BAZAAR. THE HOURS OF THE BAZAAR ARE 0900-1300, BREAK FOR AFTERNOON, AND THEN 1500-2000. THESE HOURS WERE NOT GOOD ENOUGH FOR BUSINESS SO HAJI MIRULLAH DISCUSSED MOVING THE SHOP TO A PLACE WITH BETTER HOURS OR A PLACE WHERE HAJI MIRULLAH CAN SET HIS OWN HOURS. (COLLECTORS COMMENT -- THE DETAINEE EXPLAINED SELLING PHONES TO OTHER SHOP OWNERS IN A WAY WHICH MADE IT SEEM LIKE HE COVERED ALL THE SHOP OWNERS IN THE BAZAAR THE SHOP WAS LOCATED IN. IT IS POSSIBLE THAT MOVING THE SHOP TO ANOTHER BAZAAR IS A STRATEGY THEY WILL USE TO GAIN RAPPORT WITH NEW SHOP OWNERS AND HAVE MORE CUSTOMERS AT THE SAME TIME CHANGING THEIR DISPOSITION FOR SECURITY BEASONS.)
- D. DETAINEE DESCRIBED THE RECORD KEEPING SYSTEM OF THE SHOP. DETAINEE STATED THERE ARE TWO BOOKS WHICH RECORDS ARE KEPT IN, DETAINEE USES A SMALL ONE WHILE HE IS OUT SELLING PHONES WHERE HE RECORDS THE MODEL NUMBER OF THE PHONES SOLD, THE DATE OF SALE, AND THE PRICE IT IS SOLD FOR. ONCE DETAINEE RETURNS TO THE SHOP FOR THE NIGHT, HE TRANSFERS THE SAME DATA INTO A LARGER BOOK WHICH IS KEPT AT THE SHOP.
- E. DETAINEE DISCUSSED THE SETTING OF THE PRICES IN THE SHOP. DETAINEE STATED THERE IS CONSTANT RESEARCH DONE TO FIND THE MARKET VALUE OF THE PRONES IN THE SHOP. THE PRICES DETAINEE WOULD SELL THE PHONES FOR CHANGES ALMOST DAILY. DETAINEE STATED IT IS VERY HARD TO HAVE SET PRICES.
- F. DETAINEE DISCUSSED ILLEGAL TRANSPORTATION OF PHONES. DETAINEE STATED TRANSPORTING ILLEGAL PHONES IS A TASK. IF THE POLICE CATCH A PERSON TRANSPORTING ILLEGAL PHONES, THEY WOULD FINE THAT PERSON AND CONFISCATE THE PHONES. DETAINEE STATED YACOUB WOULD HAVE RANDOM TRUCK DRIVERS TAKE ABOUT 25 PHONES AT A TIME FROM BANDAR ABBAS TO ZAHEDAN. THE TRUCK DRIVERS WERE ALWAYS DIFFERENT, BUT THEY WERE USUALLY IN ROUTE TO PAKISTAN. THE DRIVERS WOULD NORMALLY STOP IN ZAHEDAN IN ROUTE TO PAKISTAN BECAUSE THE BUSINESS THEY HAVE INVOLVES MANY STOPS. - G. DETAINEE DISCUSSED PARISTAN. DETAINEE STATED THAT LIVING IN PARISTAN IS NICE, QUETTA IS SAFE AND PEACEFUL. EXPLAINED THAT IN THE U.S. THERE ARE MANY PLACES WHICH PEOPLE AVOID DUE TO COMMON KNOWLEDGE OF THAT PLACE BEING BAD. STATED THERE IS A PLACE IN THE U.S. CALLED LOS ANGELES THAT MOST PEOPLE. It was further explained that the team had met and talked with ISN 10028's interrogation team prior to the interview after flying down from Washington DC. As is standard practice at JTF-GTMO, the detained was free to refuse to answer questions or end the interview should be decide to do so. ISN 10028 explained he understood JTF-GTMO's rules and was willing to discuss his file. The team spent some time talking with ISN 10028 about his family to build rapport before addressing substantive parts of the detainee's file. The detained acknowledged using the name Naji Hasim but denied using any other name, ISN 10028 was confronted with the fact that many other people had identified him as using other names, but ISN 10028 continued to deny the fact he used those names, ISN 10028 denied being captured with the spreadsheet which has been tagged as documents ISN 10028 had. in his possession at his time of capture, but ISN 10028 did admit to having the business license to do business at a market in Kandahar which he was also captured with ISN 10028 explained that he needed the AF business license to facilitate his ability to get an AF passport to do business in Iran, ISN 10028 explained that his mobile phone business in Iran was being given a hard time by the Iranian government for not having the proper papers to do business in Iran. It was that difficulty that prompted ISN 10026's travels from Iran to AF to get the necessary paperwork. ISN 10028 went on to state that while in AF he stayed for one night at the home of an Haji Achmed (phonetically pronounced "eighmed") who was imprisoned with ISN 10028 in Bagnram. Haji Achmed's 5 brothers were also arrested with Haji Achmed and ISN 10028. According to ISN 10028, Haji Achmed was introduced to ISN 10028 by an Abdullah (NFI) at a mosque (NFI) in Kandahar. ISN 10028 stated he only spent one night at Haji Achmed's home before being captured there with Hall Achmed's family. ISN 10028 also derified his business ventures to the interview team. For the year ISN 10028 lived in Iran he had a general store that he ran by himself for the first six months. In the latter 6 months ISN 10028 ran a mobile phone store with two other business partners. As part of a business trip to Iran for the mobile phone shop ISN 10028 says he met a Yusif Kurdi via his mobile phone business partner "Schuwayn". While on that trip ISN 10026 stated he mel an Abu Sulayman at Yusif Kurd's bicycle shop in the Toop Hanah part of Tehran (NFI). According to ISN 10028 this event took place 4-5 months before his capture. Over the course of the interview ISN 10028 continued to advocate his innocence saying he was just a shop owner: ISN 10028 stated he never killed anyone and was just a business man. The team told ISN 10028 that everyone knew ISN 10028 was more than just a shop owner. The team told ISN 10028 that the U.S. government had been learning about the detained since 2001 and that the US government was not in the business of randomly arresting businessmen. ISN 10028 was reminded AF was full of business men and that ISN 10028's capture was not by mistake. 





THIS IS THE 72ND SESSION THIS INTERROGATOR HAS HAD WITH ISN-10028 INAYATULLAH AL-AFGHANI. THE PURPOSE OF THE INTERROGATION WAS TO SERVICE ANY REQUIREMENT LEVIED AGAINST DETAINEE, AND BUILD AN UNDERSTANDING OF WHAT TEAM EXPECTS FROM DETAINEE WHILE USING A 'WE KNOW ALL' APPROACH. COLLECTOR STATED THAT IN LIFE, EVERYONE IS IN THE SAME PURSUIT, WHETHER AMERICAN OR AFGHAN, MUSLIM OR CHRISTIAN, EVERYONE IS IN THE PURSUIT OF HAPPINESS. NOW IT IS THE DECISIONS WE MAKE ALONG THE WAY IN LIFE THAT GET UP TO TRUE HAPPINESS. NO ONE CAN BE HAPPY IN PRISON BECAUSE IT IS NOT A HAPPY PLACE; IT REPRESENTS ALL THE BAD CHOICES. COLLECTOR STATED THAT THOSE CHOICES CAN BE FIXED AND THE PURSUIT OF HAPPINESS CAN BE REINSTATED IN GTMO. DETAINEES NEW PURSUIT OF HAPPINESS IS GETTING OUT OF GTMO. DETAINEE STATED THAT HE UNDERSTANDS BUT EVERYTHING THAT HE EVER SAID WAS A LIE. DETAINEE STATED THAT EVERYTHING COLLECTOR HAS EVER TOLD HIM WAS A LIE ALSO.
