Hi Jimmy and Brian:

I am writing to let you know that FEMA has granted a 9 month extension to WV to exercise the option to utilize Section 428 authorities – the Public Assistance Alternative Procedures Program. As you know, this option was set to expire December 26, 2017.

WV will now have until September 25, 2018 to exercise this option.

The Governor requested a six month extension of the December 26, 2017 deadline on September 8, 2017. However, following our meeting this week, the Agency determined it is beneficial to allow more time to accomplish both the mediation and the development of the negotiated scope of work.

I will be sending a letter to the Governor regarding the disposition of his request and I will have that completed before our December 21, 2017 meeting with the State and Nicholas County Boards of Education.

First of all, thank you and Chief of Staff Hall for your time meeting with us on Wednesday to discuss our various items and concerns. Here is a brief synopsis of our actions:

- The Governor will sponsor the consensus building effort that was started on Wednesday, the 11th of October. Key dates upcoming include:
 - Preliminary Assessment and development of participant list – now through the 27th of October
 - Assessment in West Virginia – 30 Oct – 10 Nov
 - Final Report to Governor's Office – week of the 4th of Dec
 - **Key Ask:** to insure there is no confusion as the team starts their assessment, we recommend an announcement by the Governor's office regarding the initiative despite the Superintendent of Schools announcement. I have attached a draft press release for your consideration.
- The Governor will sponsor the Disaster Recovery Summit on the 7th of November. As discussed, this will be a small group of decision makers plus one to craft the overarching, unified strategy that multiple state and federal agencies will use to guide recovery funding decisions related to the June 2016 flood event strategy.
 - A "Save the Date" has been sent to the principals,
 - **Key Ask:** it would be very helpful if the Governor's Office reinforced the importance of the meeting by sending the invite to the key decision makers.
 - A more detailed discussion of the goals and event details is attached.

Governor to Sponsor Consensus-Building Project on School Consolidation

Charleston, W.Va. — Gov. Jim Justice announced today a first step in a state-sponsored project to build consensus on the way ahead for the three Nicholas County schools destroyed by the June, 2016 floods.

“We’ll seek the skills of a neutral facilitator to build consensus on the location of the school buildings,” said Gov. Justice. “Consensus will be the key to coming to agreement on a workable solution that will meet the needs of Nicholas County students as well as effectively using federal dollars to rebuild these schools.”

The announcement was made after the West Virginia Supreme Court of Appeals ruled in favor of the West Virginia State Board of Education in their rejection of the Nicholas County Board of Education’s plan to consolidate Summersville Middle School, Richwood High School and Richwood Middle School into a single campus.

Federal dollars to rebuild the schools will come from the Federal Emergency Management Agency’s Public Assistance Program with the non-federal match supported by the State. The state works with FEMA to administer the program.

This first phase of the state’s initiative will include an assessment of the current situation, engagement with key stakeholders from all sides of the discussion, and presentation of possible options for moving forward with a consensus-building process. These options will be presented to state, local and federal leaders as recommendations that could best assist them in meeting the needs of Nicholas County students and effectively delivering disaster assistance funds.

Delivery of the report is expected to be two months after the project start and is planned by mid-December.

“This initiative is important to the state, to the Nicholas County schools, but above all, to the students who attend those schools,” said the Governor.

West Virginia Governor's Disaster Recovery Summit

Purpose

To develop an overarching, unified strategy that multiple state and federal agencies will use to guide recovery funding decisions related to the June 2016 flood event. This unified strategy should enable informed decision-making by senior leadership at all levels: local, state, and federal. As a first step in creating this unified strategy, this summit will convene senior level state and federal officials to build consensus on strategic priorities, a framework for the strategy, and a path forward and timeline for the strategy's development. While the summit will focus on how to maximize almost \$700 million in funding available following flooding in June 2016, this approach can be applied to future resource allocation and funding decisions that will enhance the West Virginia's resilience while also spurring economic development and creating jobs.

This acknowledges receipt of your June 28, 2018 letter to President Trump requesting a major disaster declaration for the State of West Virginia as a result of flooding, landslides, mudslides and wind damage in May and June 2018. You specifically request the implementation of all categories of Public Assistance for Berkeley, Grant, Hampshire, Hardy, Jefferson, Mineral, Morgan and Pendleton Counties; and Hazard Mitigation for the entire state in accordance with the Stafford Act.

I am writing to inform you of some important information regarding the State of West Virginia's Hazard Mitigation Plan, which will expire on October 17, 2018.

The Federal Emergency Management Agency's (FEMA's) standards contained in the 44 Code of Federal Regulations, Part 201.3(c)(1), Part 201.3(c)(3), Part 201.4(a) and Part 201.4(d) require that State Mitigation Plans (SMPs) be updated and resubmitted to FEMA for approval every five (5) years.

Please be aware that the State must have an updated, FEMA-approved SMP in order to be eligible to apply for and/or receive the following types of FEMA assistance:

- Public Assistance Categories C-G (PA C-G)
- Fire Management Assistance Grants (FMAG)
- Hazard Mitigation Grant Program (HMGP)
- Pre-Disaster Mitigation (PDM)
- Flood Mitigation Assistance (FMA)

To maintain its eligibility for these grants, regulations require that the State must have an approved SMP at the time it receives the grants. Therefore, if your plan expires before you have an updated SMP approved by FEMA, the State will no longer be eligible for, and FEMA will not award, any of the above grants. This is not a permanent stop to and loss of funding, but it is a temporary hold on awards and funding until the updated SMP is approved.

Failing to have an approved updated SMP will affect funds for which you are applying, including proposals under consideration, under any annual FEMA mitigation grant program (except PDM planning grants). It also will affect awards and obligations of Public Assistance Categories C-G, Hazard Mitigation Grant Program (HMGP), and Fire Management Assistance Grants (FMAG) available under declarations that were made before your plan expired.



In the event that the State receives a new declaration under the Stafford Act while your SMP is lapsed, these forms of assistance will not be authorized unless and until the State submits an updated SMP that meets FEMA requirements within 30 days of the disaster declaration. The State must also formally adopt within 45 days of FEMA's notice that the plan meets all requirements. Individual Assistance and Public Assistance Categories A-B are not affected.

FEMA Region III will continue to provide technical assistance to your staff with the goal of approving your updated SMP as soon as possible or no later than October 17, 2018, when your current approved SMP will expire.

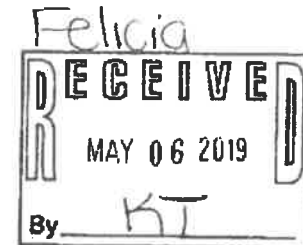

Dear Governor Justice:

On behalf of the Federal Emergency Management Agency, I am sending this letter in regard to the floodplain management requirements for state-owned properties located within Special Flood Hazard Areas (SFHAs). The National Flood Insurance Program (NFIP) is a voluntary program under which federal flood insurance is made available to participating communities in exchange for a commitment by those communities to adhere to sound floodplain management practices.

In order for a community to participate in the NFIP and obtain the benefit of federal flood insurance, it must adopt and enforce adequate land use and development criteria that are consistent with the minimum standards established by the NFIP at Code of Federal Regulations 44 (CFR) § 60. States are considered communities under the NFIP, and to be eligible to purchase federal flood insurance for state-owned structures or their contents, a state must adhere to the same NFIP minimum standards as other communities.

The regulations that specify the minimum criteria for community floodplain management regulations are outlined in 44 CFR § 60.3 (flood-prone areas), § 60.4 (mudslide-prone areas), and § 60.5 (flood-related erosion-prone areas). Pursuant to § 60.12(a), states must either 1) Comply with the floodplain management requirements of all local communities participating in the program in which state-owned properties are located; or (2) Establish and enforce floodplain management regulations which, at a minimum, satisfy the criteria set forth in §§ 60.3, 60.4, and 60.5.

Pursuant to § 60.12(c), if a state-owned property is located in a non-participating local community, then the state must establish and enforce its own regulations that satisfy the NFIP minimum criteria. States that fail to adopt or enforce sufficient floodplain management regulations may be placed on probation or suspended from the NFIP, and may become ineligible for some types of federal assistance in areas of identified flood risk.

Therefore, pursuant to 44 CFR § 60.11, within six months from receipt of this letter, I am requesting that your state provide documentation on state legislative language and authorities adopted to ensure compliance with minimum NFIP standards and the administration of existing floodplain management programs (i.e. responsible state agencies, program structure and program implementation). I have attached a summary of these requirements and benefits of compliance factsheet to this letter for your use.

I have included your State NFIP Coordinator on this solicitation. While your State NFIP Coordinator is tasked with supporting delivery of the NFIP at the local level, we believe he or she could also serve as a valuable resource as the state navigates data collection in order to respond to this request. However, please note that fulfillment of this request may require coordination with multiple state agencies. Additionally, coordination with state agencies on adoption and implementation of state executive orders and regulations that meet the NFIP regulations for state development in the SFHA is listed as an eligible activity under the FY18 Notice of Funding Opportunity (NOFO) for the Community Assistance Program-State Support Services Element (CAP-SSSE) program and will remain an eligible activity under the FY19 NOFO. CAP-SSSE funds at least a portion of the activities implemented by your State NFIP Coordinator's Office.

Finally, please note that FEMA is planning to schedule two informational webinars between May and June 2019 to coordinate with states about this request and answer any questions they may have. We will provide information about these webinars to Governor's Offices via email as well as the NFIP State Coordinating Offices.

Summary of Information Required for NFIP-Participating States on Floodplain Management Regulations for State-Owned Properties

States must provide Requirements 1 & 2 if they administer their own program for state-owned property or in reference to state-owned properties located in non-participating local communities; States must provide Requirement 3 in reference to state-owned properties in which the state adopts and enforces the floodplain management requirements of all local communities participating in the program; All states must provide Requirement 4.

1. Citations to state and local statutes and regulations authorizing actions regulating land use and copies of the local laws and regulations cited;
2. A copy of the floodplain management regulations the state has adopted to meet the requirements of the National Flood Insurance Program (see §§ 60.3, 60.4 and/or § 60.5). This submission may include copies of any zoning, building, and subdivision regulations, health codes, special purpose ordinances (such as a floodplain ordinance, grading ordinance, or flood-related erosion control ordinance), and any other corrective and preventive measures enacted to reduce or prevent flood, mudslide (i.e., mudflow) or flood-related erosion damage;
3. State regulations requiring the state to adhere to local floodplain management regulations and permitting and procedures by which the state applies for local permits for development to satisfy the minimum National Flood Insurance Program standards.
4. An executive-level summary concerning state administration of floodplain management regulations, including program structure and implementation. The summary should address details such as:
 - (i) Which state agencies are involved in Floodplain Management;
 - (ii) Whether there is a central agency or POC for coordination within the state;
 - (iii) If and how permits are issued for development in the Special Hazard Flood Areas (SFHAs);
 - (iv) How compliance is tracked; and
 - (v) How violations are identified and addressed.

BENEFITS OF THE STATE ASSESSMENT

The following describes the financial and non-financial benefits of compliance with the State Assessment:

- **The entire nation must work as a team to increase pre-disaster mitigation in communities. By coordinating with the states to put an emphasis on their own regulations for floodplain management, states will gain a better understanding of the risks to properties in flood-prone areas and the responsibility the state has to manage that risk. This will help to improve the state's overall flood preparedness and reduce losses from flooding.**
- **The minimum National Flood Insurance Program standards for floodplain management are intended to prevent loss of life and property, as well as economic and social hardships that results from flooding. Nationwide each year, NFIP-based floodplain management regulations help prevent more than \$1 billion in flood damages.**
 - **For floodplain management practices to make a positive impact in creating loss-avoidance, communities (including states) must take a holistic approach to application of floodplain management regulations.**
 - **Adopting and enforcing floodplain management practices result in lower disaster relief costs, as well as reduced insurance rates, due to projected lower losses from flood risks.**
 - **Responses will help states identify gaps within their existing floodplain management programs and policies to ensure they are managing their risk and upholding their vital responsibility to protect life and property of their citizens.**
- **Through this State Assessment, FEMA intends to identify opportunities for improvements to floodplain management programs that will be necessary in several states. Strengthening floodplain management programs will help to better protect the federal investment that is routinely made in state buildings located in Special Flood Hazard Areas, particularly post-disaster.**
- **Collection and analysis of this information will assist FEMA to:**
 - **Optimize its technical assistance engagement strategy through prioritization of states that require technical assistance, strategic planning, and other support activities to better reduce the risk of current and future flooding, resulting in more resilient communities.**
 - **Identify and prioritize best opportunities for state and local investment in floodplain management and mitigation.**
 - **Streamline the process for providing post-disaster Public Assistance grants to eligible states based on compliance with the National Flood Insurance Program minimum criteria.**
