## TARGETED OPERATIONS

CPD and the ATF conduct targeted operations in high-crime neighborhoods with an emphasis on:

- Removal of drugs and illegally possessed / used firearms
- Intelligence gathering and prosecution of gangs
- Unsolved homicides and armed robberies

This area will be subject to enhanced, joint law enforcement activities until recent violent crime trends diminish.

Offenders may be subject to Federal prosecution for firearms violations and other offenses.

Violations of Federal firearms laws often result in longer sentences and higher fines than state law violations.

Gun Control Act of 1968 and National Firearms Act of 1934.

## HIGH VIOLENT CRIME AREA

The Cincinnati Police Department (CPD) and the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) have designated the neighborhood of Avondale as a high violent crime area due to the excessive number of shootings and shots fired incidents that have recently occurred.

## RECENT AVONDALE ARRESTS AND CONVICTIONS



In August of 2017, the Cincinnati Police initiated a targeted investigation into criminal activity involving Mr. Caedon Short. As a result of this investigation, Mr. Short was arrested and charged with felony drug and weapons charges. In December of 2017, Mr. Short was convicted and sentenced to 6 years in prison.



In September of 2018, the Cincinnati Police conducted a targeted investigation into ongoing criminal activity involving Mr. Kevin Casey. As a result of this investigation, Mr. Casey was arrested and charged with felony drug and weapons charges. In February of 2018, Mr. Casey was convicted and sentenced to 6 years in prison.

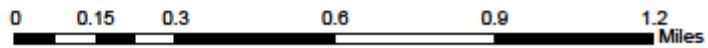
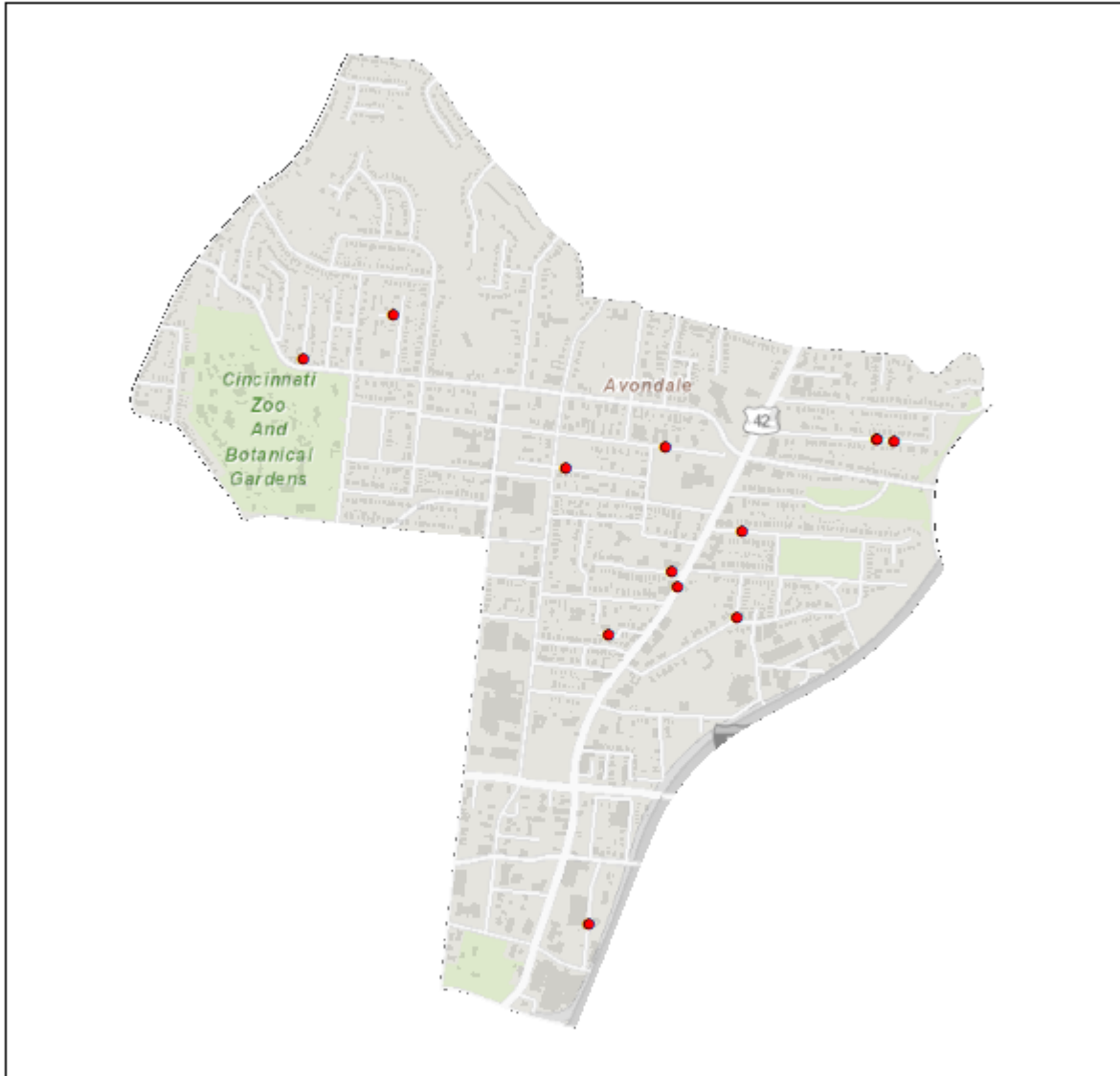
