Pennsylvania Nonprofit Corporation Law of 1988 (as amended). The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the Pennsylvania Nonprofit Corporation Law of 1988 (as amended). The corporation is a Pennsylvania not-for-profit trade organization, organized in accordance with Section 501(c)(6) of the Internal Revenue Code, dedicated to promoting, advancing, and supporting a single, viable professional women's ice hockey league in North America that showcases the greatest product of women's professional ice hockey in the world.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its directors or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its exempt purposes.


- 4. <u>Nonprofit</u>. The corporation does not contemplate pecuniary gain or profit, incidental or otherwise.

8. <u>Dissolution</u>. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the exempt purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable purposes which at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Code, as the Board of Directors shall determine. Any assets not so distributed by the Board of Directors shall be distributed by the Court of Common Pleas of the county in which the corporation's principal office is then located exclusively for the corporation's exempt purposes. The use of any surplus funds for private inurement to any person in the event of a sale of the assets or dissolution of the corporation is expressly prohibited.
