Quality & Sustainable Community Schools in every Neighborhood:

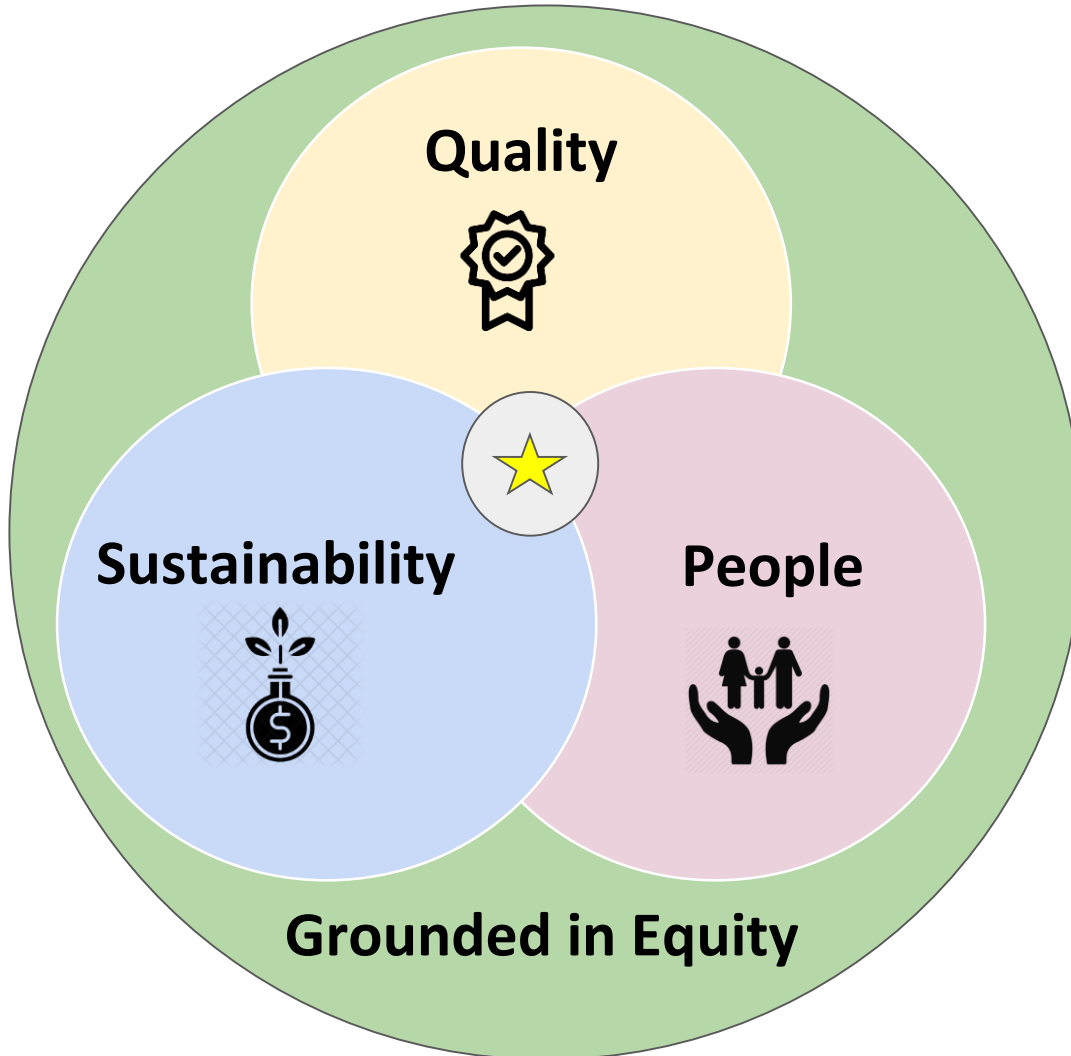
- Safe, engaging and clean learning environment

Quality, Sustainability and People



★ **North Star** can only happen by having a citywide focus on all three: quality, sustainability, and people.

Blueprint is ONE of Multiple Strategies



Quality

- Expanding quality schools
- Merging and consolidating schools to provide better resourced, higher-quality options
- Redesigning underperforming or under-enrolled schools



Sustainability

- Concentrate resources in fewer schools.
- With fewer schools, central office supports and services will be more efficient and leaner.
- Unused facilities can be leased to generate revenue.



People

- With fewer schools, OUSD would be better positioned to recruit, retain, and support high-quality site leaders.
- Larger schools provide opportunities for teachers to collaborate and support one another,
- Improve transparency about the decision-making, more opportunities for staff and families to give input before a decision is made.

- Families are voting with their feet.

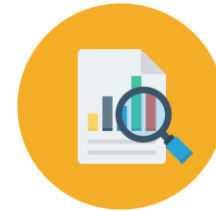

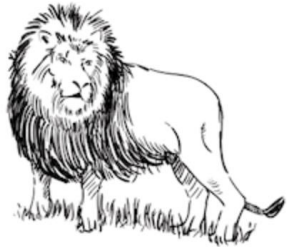
The Design Team has:

K-5 - Oakland, CA

Two areas of focus for the CUES/Futures merger Design Team are (1) STEAM, and (2) making decisions about dual language programming as the two schools prepare to fully merge in Fall 2020.

The two schools have already begun working collaboratively in many ways:

- Teachers work together in PLCs
- Shared schedule
- One afterschool partner
- Shared Professional Development
- Shared COST and Attendance teams
- Aligned Math Instruction (Eureka K-2 and Swun 3-5)
- SSCs meet at the same times
- Shared focus on family engagement

MetWest Expansion





Ericka Huggins Campus
opening at Westlake in August

- Satellite expansion campus will open in August 2019
- Forty additional ninth graders enrolled
- Over the next four years, MetWest will double in size
- The MetWest design team has examined their achievement data to make improvements to the instructional program

CCPA Expansion & Roots Closure Update

Expand CCPA	Roots Closure
<ul style="list-style-type: none">● Expanded program for the 2019/20 school year● 64 more 6th graders enrolled for Fall 2019● Approximately 8 more students being served within the Special Ed department	<p><u>Support for Students & Families</u></p> <p>136 students from the Roots closure have been placed in other OUSD schools with the ROOTS student transition plan in place to support these students through the fall.</p> <p>→ 61.6% (85 students) placed in their 1st CHOICE → 26.1% (36 students) placed in their 2nd CHOICE → 2.2% (3 students) placed in their 3rd CHOICE</p> <p><u>Support for Staff</u></p> <p>School Closure Talent Process developed and implemented. 9 out of 10 core teachers, and 2 out of 3 PE teachers are continuing in OUSD schools</p>

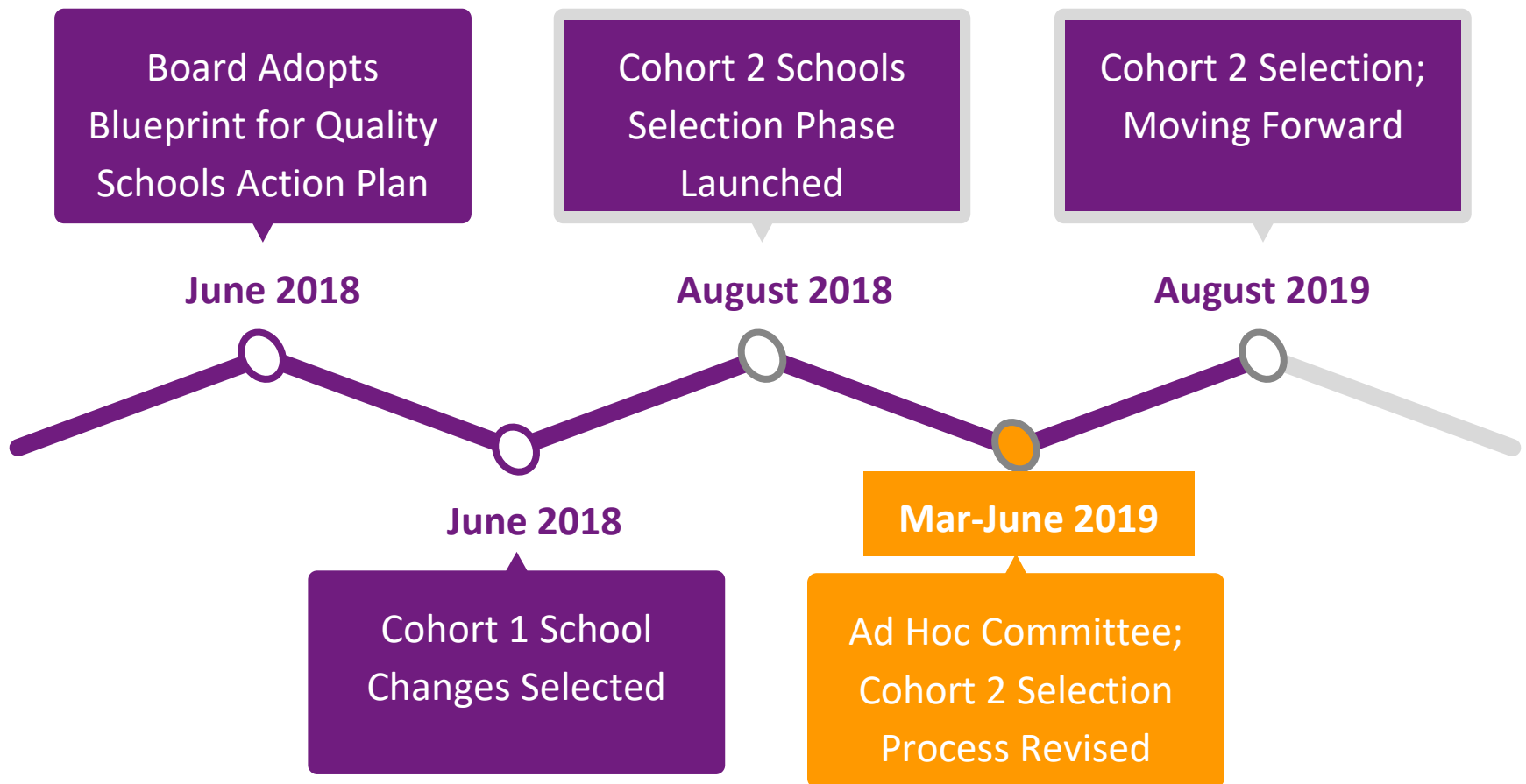

Proposed Revisions to Work Plan Phases

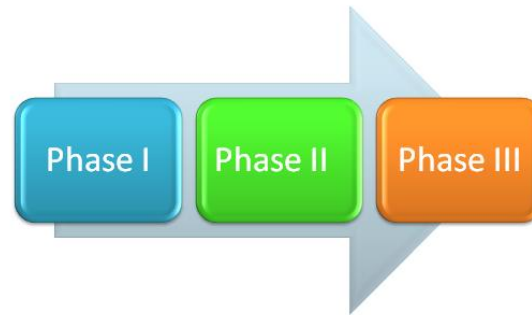
NEW: Pre- Selection Phase (Ongoing)

Purpose: Community Education: Quality & Sustainability

→ **Citywide and regional analysis** of quality and sustainability

→ **Individual schools** engage in an ongoing analysis of **quality**

→ Identify school communities that demonstrate **capacity for change**



Existing Phases

1. Selection Phase
2. Planning Phase
3. Implementation Phase

NEW: Post- Implementation Phase (Ongoing)

Purpose: Evaluation & Learning


→ Student, family, and staff **feedback**

→ **Care management** plan for students who are impacted by the school change


→ Ongoing evaluation and **data collection**

Proposed Revisions to Data


Considerations: Quantitative Data

Consideration	Key Question(s)
<p>School Quality: California School Dashboard Data</p> 	<p>*NEW: Additions to our analysis of school quality: Prioritize analysis of the performance and growth of the most marginalized subgroups of students in measuring school quality Include CORE growth data as an additional metric for analyzing school quality</p>

Proposed Revisions to Data Considerations: Qualitative Data

Consideration	Key Question(s)
<p>*NEW: Lived Experience Data</p> 	<p>*NEW: In measuring and analyzing school quality, collect data on the lived experience of members of the school community. Conduct focus groups, interviews, and/or observations to collect data.</p> <p>*NEW: Bring back a School Quality Review (SQR) process similar to the one implemented in OUSD during the years 2011-2014. The SQR provides a vehicle to incorporate family and staff interviews and student voice into the assessment of school quality.</p>

Proposed Revisions to Data Considerations: Citywide Data

Consideration	Key Question(s)
Environmental Stress Factors 	*NEW: Consider incorporating new indicators related to safety and students' mental health needs

Proposed Revisions to Blueprint Guiding Principles

3. Every school change is informed by the needs of the school community, *as determined through both community engagement and central office data reviews.*

4. *Protect and expand high quality schools*, especially those that serve our historically underserved students.
