20-21.10(f)	Temperature and pressure measuring devices. Indicating thermometers required for immersion into food or cooking media shall be of metal stem-type construction, numerically scaled, and accurate to $\pm 2^{\circ}\text{F}$ in the intended range of use if scaled only in Fahrenheit. Provide numerically scaled metal stem indicating thermometer accurate to $\pm 2^{\circ}\text{F}$ when scaled in Fahrenheit only. (TO TEST INTERNAL FOOD TEMPERATURE) New Violation.	06/17/2019
20-21.11(a)(07)	Cleaning frequency. Nonfood-contact surfaces of equipment not cleaned as often as is necessary to keep the equipment free of accumulation of dust, dirt, food particles, and other debris. OBSERVATION: ORANGE SODA HAS SPILLED ON THE FLOOR AND RACKS IN THE DRY FOOD CLOSET. BEANS ON THE FLOOR IN THE DRY FOOD CLOSET. OLD RODENT DROPPINGS ON THE FLOORS NEAR THE POTS AND PANS, RACKS. CORRECTIVE ACTION NEEDED: WASH, RINSE AND SANITIZE POTS AND PANS/CLEAN FLOORS AND RID OF ALL RODENT DROPPINGS. New Violation.	06/17/2019
20-21.21(a)(03)	Controlling pests, generally. The presence of insects, rodents, and other pests shall be controlled to eliminate their presence within the physical facility and its contents and on the contiguous land or property under the control of the permit holder by using appropriate methods of pest control, such as trapping devices or other means of pest control as specified under section 20-21.27 of this code. OBSERVATION: RODENT DROPPINGS AND NO PEST CONTROL PAPERWORK. FLIES/GNATS IN THE KITCHEN AREA ESPECIALLY AROUND THE PLANTAINS AND 3 COMPARTMENT SINK. CORRECTIVE ACTION NEEDED: PEST CONTROL MUST BE CALLED IMMEDIATELY AND THE RECEIPT MUST BE RETAINED. FAILURE TO DO SO SHALL RESULT IN A MUNICIPAL COURT CITATION. New Violation.	06/17/2019
21-244(a)	"NO SMOKING" signs or the international "NO SMOKING" symbol not clearly and conspicuously posted in a public place where smoking is prohibited Post a 'NO SMOKING' sign or symbol at every entrance to establishment. Repeat Violation.	06/17/2019
