The event will feature a long list of speakers and activities for the whole family. There will be a survival scenario exercise for the children as well as Highland games for adults.

According to open source information, the Stormfront site was created in 1995 by [redacted] [redacted] also known as [redacted] This site is a forum that white supremacist use to blog with one another. The forum has an exclusive portion just for Latin America and a sub section relating to Brazil. As of March 23, there were roughly 208 pages worth of discussion threads each containing posts written in Portuguese from individuals who post their location as either Brazil, Portugal, or Italy. Each user likely has a profile, but only registered members are able to view that information. The moderator for the Brazilian section is [redacted] There are numerous other usernames on the forum.

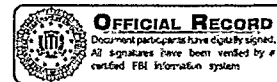

First off they discussed that Kansas does not have a Hate Crime Law, additionally they discussed the fact that if there was a Hate Crime Law it would only have added a few years to there sentence. The ADA then went on to explain that the crime was not motivated by Race, but it was motivated by Greed so there was no reason for Race to be a Factor in

So in my mind I thought that I could use my time in a more productive manner, so I left early and got some fliers and business cards out of my truck and distributed them on the windshields of the cars in the parking lot. I did however run out before I got the lot done but I got out about 45 fliers and 20 business cards. So hopefully I will have reached someone that was there."

**Synopsis:** The purpose of this communication is to request the opening of captioned investigation, in order to determine the subject's possible involvement in violent crimes related to domestic terrorism.

**Details:** On 04/14/2000, Denver reported to Newark that a reliable Denver source had information regarding possible skinhead violence in the area of Hackettstown, New Jersey.

On 04/12/2000, the source was participating in a chat room conversation on the racist web site, "Stormfront," when an individual using the screen name [REDACTED] attempted to recruit persons for a "beer and queer bash" in honor of Hitler's birthday. The "bash" was to take place on 04/15/2000, in the Budd Lake area, near Hackettstown, New Jersey. Hitler's birthday is 04/20/1889. People interested in attending the event were directed to contact telephone number [REDACTED] for additional information.

Denver's source, through his experience with the white supremacist movement, understood that a "beer and queer bash" referred to a common skinhead practice of congregating with other skinheads to get intoxicated and then driving around to look for minorities and/or gays to assault.

Newark utilized the [REDACTED] to determine that [REDACTED] was registered to [REDACTED] located at [REDACTED] New Jersey.

On 05/02/2000, Newark performed a spot check of that location. There was a business at that location, which was identified by a sign as [REDACTED]. There was also a neon sign in the front window, which indicated that the telephone number was [REDACTED]. The business appeared to be closed; however, there were two vehicles in the parking lot, New Jersey plates [REDACTED]. There were two other businesses that were part of the same building as [REDACTED]. Signs identified them as [REDACTED] and [REDACTED] telephone number [REDACTED]. Those businesses appeared to have separate entrances, however.

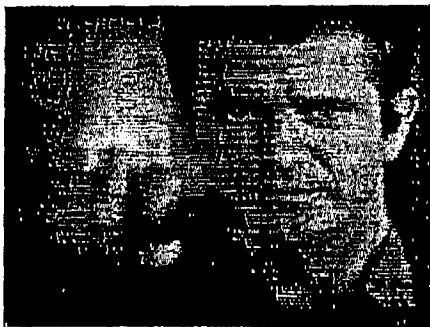

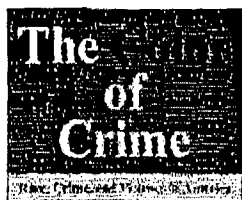

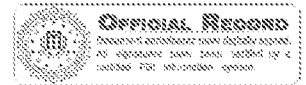

**Stormfront** is a white nationalist, white supremacist and neo-Nazi internet forum that was the internet's first major racial hate site.

Stormfront began as an online bulletin board system in the early 1990s before being established as a website in 1995 by former Ku Klux Klan leader and white nationalist activist Don Black. It received national attention in the United States in 2000 after being featured as the subject of a documentary, *Hate.com*. Stormfront has been the subject of controversy after being removed from French, German and Italian Google indexes, for targeting an online FOX News poll on racial segregation, and for having political candidates as members. Its prominence has grown since the 1990s, attracting attention from watchdog organizations that oppose racism and antisemitism.

The website is a theme-based discussion forum with numerous boards for topics including ideology, science, revisionism, homeschooling, and self defense. Stormfront also hosts news stories, a merchandise store, and extensive links to racist organizations. The site has a logo featuring the Celtic cross (which is common to neo-Nazi iconography) surrounded by the motto "White Pride World Wide".

## History

### Early history

Stormfront began in 1990 as an online bulletin board for white nationalist activist David Duke's campaign for United States Senator of Louisiana. The name "Stormfront" was chosen for its connotations of a political or military front and an analogy with weather fronts that invokes the idea of a tumultuous storm ending in cleansing. It was opened to the public in 1994, and the Stormfront.org website was founded in 1995, becoming the first website associated with white supremacy. Until this point, attempts at using the internet for the white pride movement met with limited success, but Stormfront quickly began to become popular with the growth of the internet at this time, according to owner Don Black. A former Grand Wizard of the Ku Klux Klan and in the 1970s a member of the National Socialist White People's Party, Black first received computer training while imprisoned for his role in an abortive 1981 attempt to overthrow the government of Dominica.



White nationalist politician and activist David Duke, whose 1990 campaign for United States Senator in Louisiana was the impetus for the first iteration of Stormfront.

### National attention

The site received considerable attention in the United States, such as in *Hate.com*, a 2000 CBS/HBO documentary television special which focused on the perceived threat of white nationalist and white supremacist organisations on the internet. Narrated by Morris Dees of the Southern Poverty Law Center, it featured interviews with Black and his son Derek as well as other white nationalist groups and organisations, and was criticised by Black as conflating Stormfront with unrelated websites and individuals. Carol M. Swain, assessing *Hate.com* and similar broadcasts of the period, found that the commentators "never seriously discuss the issues that have angered white nationalists", noting that *Hate.com* omitted any coverage of Stormfront's articles on crime, affirmative action and other social issues. She characterised the documentaries' approach as "typical of media policy" in emphasising racial hate against minority groups and avoiding mention of racially motivated attacks on white people, thereby reinforcing "white nationalists' claim of a double standard". Stormfront had previously been accused of citing crime statistics out of context in order to support claims of reverse discrimination in *I Found It on the Internet*, a 1999 book on internet content by Frances Jacobson Harris.

### Controversies

In 2002, search engine Google acted to remove Stormfront.org from their French and German indexes in order to comply with French and German legislation forbidding links to websites which host white supremacist, Holocaust-denying, historical revisionism or similar material. Stormfront returned to the news in May 2003, when its members targeted an online poll on a racial issue. Fox News Channel host Bill O'Reilly reported on a racially segregated prom being held in Georgia and posted a poll on his website asking his viewers if they would send their own children to one. A link to the poll was posted on Stormfront and messages subsequently posted there implied that a mass of readers had duly voted in order to skew the poll in favor of segregation. O'Reilly reported this the following week and refused to read the final results due to this, citing Stormfront as the culprit by name and referring to it as a "Neo-Nazi organization". Doug Hanks, a candidate for the Charlotte, North Carolina, city council, withdrew his nomination in August 2005 after it was revealed that he had posted on Stormfront. Hanks had posted more than

4,000 comments over three years, including one in which he described black people as "rabid beasts". Hanks said his postings were intended to gain the trust of Stormfront users to help him write a novel: "I did what I thought I needed to do to establish myself as a credible white nationalist."

In 2012 in Italy the police have blocked the website and arrested 4 people for allegedly inciting racial hatred. The measure was taken after the publication on the Italian section of the website of a blacklist of prominent Jews and people who support Jews and immigrants. Also a list of possible targets of violent attacks (including gypsy camps) was found. Italian police raided the homes of 35 Stormfront posters in November 2013. One man who was arrested in Mantua had two loaded weapons, a hand grenade casing, and a flag with a swastika in his possession.<sup>[4]</sup>

## Popularity and later history

In a 2001 *USA Today* article, journalist Tara McKelvey called Stormfront "the most visited white supremacist site on the net". The number of registered users on the site rose from 5,000 in January 2002 to 52,566 in June 2005, by which year it was the 338th largest internet forum, received more than 1,500 hits each weekday and ranked in the top one percent of internet sites in terms of use. By June 2008, the site was attracting more than 40,000 unique users each day. Operating the site from its West Palm Beach, Florida headquarters is Black's full-time job, and he is assisted by his son and 40 moderators. The popularity of the site attracted attention not only from racists, but also from groups such as the Simon Wiesenthal Center and the Anti-Defamation League (ADL), whose efforts against the site have been so far ineffective. The ADL describes Stormfront as having "served as a veritable supermarket of online hate, stocking its shelves with many forms of anti-Semitism and racism".

In 2006, the Southern Poverty Law Center reported a discussion on Stormfront in which white nationalists were encouraged to join the U.S. Military in order to learn the skills necessary for winning a race war. The 2008 United States presidential candidacy of African-American Democrat Barack Obama was a cause of significant concern for some Stormfront members; the site got 2,000 new members the day after Obama was elected as President, and went off-line temporarily due to the overwhelming amount of activity. Stormfront posters saw Obama as representing a new multicultural era in the United States replacing "white rule", feared that he would support illegal immigration and affirmative action, and would help make white people a minority group. During the primary campaigns, *The New York Times* mistakenly reported that Stormfront had donated \$500 to Republican presidential hopeful Ron Paul; in fact, it was site owner Don Black who had contributed the money to Paul. In an April 2009 shooting, Richard Poplawski, a poster on the site, was charged with ambushing and killing three Pittsburgh Police officers and attempting to kill nine others.

## Content

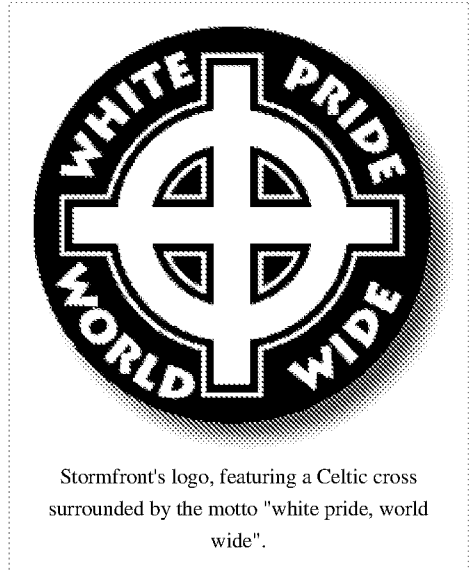
Stormfront is a resource for those courageous men and women fighting to preserve their White Western culture, ideals and freedom of speech and association—a forum for planning strategies and forming political and social groups to ensure victory.

—Stormfront mission statement.

Stormfront is notable for the white supremacist views of its members, a characterization that is contested by Don Black as an inaccurate description; Black believes the term "supremacy" implies a system which "isn't descriptive of what [the members] want". It is also a Neo-Nazi website, on which Nazi mysticism and the personality cult of Adolf Hitler are sustained and Nazi iconography is popular. The Stormfront.org website is organized primarily as a discussion forum with multiple thematic sub-fora including "News", "Ideology and Philosophy" ("Foundations for White Nationalism"), "Culture and Customs", "Theology", "Quotations", "Revisionism", "Science, Technology and Race" ("Genetics, eugenics, racial science and related subjects"), "Privacy", "Self-Defense, Martial Arts, and Preparedness", "Homemaking", "Education and Homeschooling", "Youth", and "Music and Entertainment". There are boards for different geographic regions, and a section open to unregistered guests, who are elsewhere unable to post, and even then, only under heavy moderation.

## Services

Stormfront.org is comprehensive and frequently updated, hosting files from and links to a number of white nationalist and white racist websites, an online dating service (for "heterosexual White Gentiles only"), and electronic mailing lists that allow the white nationalist community to discuss issues of interest. It also features a selection of current news reports, an archive of past stories, live streaming of *The Political Cesspool* radio show,<sup>[5]</sup> and a merchandise store featuring literature and music. Stormfront has published stories aimed at children. A 2001 study of recruitment by extremist groups on the internet noted that Stormfront came close to offering most of the standard services offered by web portals, including an internal search engine, web hosting, and categorized links, and lacking only in an internet search engine and the provision of free email for its members (though a limited email service was available at the price of \$30 a month).



## Design

Prominently featured on the homepage is a Celtic cross surrounded by the words "white pride, world wide." A mission statement praises courage and freedom. Stormfront states it discourages racial slurs, and prohibits violent threats and descriptions of anything illegal. Others state that only blatant hate and calls for violence are kept off the opening page.

## Funding

Black asks website visitors for \$7,500 each month for "basic expenses" and described early 2012 as the "slowest month" for donations. The website allows people to be "Sustaining Members" for as low as \$5 a month or \$1,000 to be a lifetime supporter.

## Character

### Purpose and appeal

Don Black has long worked to increase the mainstream appeal of white supremacy. His medium is Stormfront.org. Black established the website to heighten awareness of perceived anti-white discrimination and government actions detrimental to white people, and to create a virtual community of white extremists. Black owns the site's servers so he need not depend on website hosting providers.

Black's organization inculcates enough white pride to make "its worldwide aspirations meaningful and socially significant". Stormfront keeps the rhetoric in its forums muted, discourages racial slurs, and prohibits violent threats and descriptions of anything illegal. Site moderator Jamie Kelso is "the motivating force behind real community-building among Stormfront members" due to his energy and enthusiasm in organizing offline events. Black's positioning the site as a community with the explicit purpose of "defending the white race" has helped sustain the community over its long lifetime, as it attracts white men and women who define themselves in opposition to ethnic minorities, particularly Jews.

Stormfront established MartinLutherKing.org to discredit Martin Luther King, Jr.<sup>[6]</sup> In a 2001 study of white nationalist groups including Stormfront, academics Beverly Ray and George E. Marsh II commented that "Like the Nazis before them, they rely upon a blend of science, ignorance, and mythology to prop up their arguments".

## Ideology

Stormfront presents itself as engaged in a struggle for unity, identifying culture, speech and free association as its core concerns, though members of Stormfront are especially passionate about racial purity. It promotes a lone wolf mentality, linking to white nationalist theorist Louis Beam's influential work on leaderless resistance and offering a sympathetic assessment of Benjamin Nathaniel Smith, a white supremacist who committed suicide after a racially-motivated killing spree in June 1999. Scholar Violet Jones notes that Stormfront credits its mission to the founding myth of an America "created, built, and ideologically grounded by the descendants of white Europeans." Asked in 2008 by an interviewer for Italian newspaper *la Repubblica* whether Stormfront was a 21st-century version of the Ku Klux Klan without the iconography, Black responded affirmatively, though he noted that he would never say so to an American journalist.

## Activism

In 2009, roughly two dozen white supremacists demonstrated outside the St. Clair County, Illinois courthouse in response to a school bus beating which a police spokesman had initially said was racially motivated. The rally had been promoted and organized in part by Stormfront users. It lasted for roughly one hour before being broken up by police.

PICS The FBI will have your photo anyway. Once, when I was 17, a friend of mine was eating at a diner in Ohio (8 hours away from here!) with his girlfriend. My friend and I had not been in contact for some time. Suddenly, two men came and intruded upon their dinner, just sat right down with them. The agents began to produce a huge stack of photos depicting me and my friends here in NY. Some of the pics were taken from Helicopters. They were very revealing pictures of common skinhead activity in Queens, the motherlode! I was photographed walking a dog, going to the store, and even eating a hot-dog at a BBQ! There was even an arial shot of me giving the FBI cameraman the finger!

Obviously, their investigation did nothing but spend money and give a pilot a few hours flight time. It was all just harassment, which I found worth a 3 second chuckle before getting back on with my life.

Provocation Agents Here is the bread and butter of FBI activity. They will pull off the most underhanded stunt imaginable to try and jam you up. I'll give a few examples.

It usually all is planned out of sight. Meaning, they have profiled and planned the entire operation before any visual signs of an investigation or provocation operation become apparent. They watch a person and look up all his or her records and establish a tree of association that you are in contact with. They look into each of these individuals and do a threat assesment. Like someone had posted previously. Then they start showing their faces. I have noticed that it is the most unreliable and idiotic associates that will be approached first. The weak link, I guess. The FBI will tell them you are "going down" and threaten that the loser will go down too if he don't cooperate, among other methods.

In my case, Victor Arocho of the aptly named Terrorist Task Force (terrorism means 'to coerce by intimidation and threat' after all) began interviewing a kid I lost contact with over 2 years before. (Hi Victor) And Victor filled this Kid with stories that I was operating a Drug lab in my house and was the center of information. (I will sue you for that VIC). Then he started telling this kid that The FBI "needs" him to go to shows and get a SF signature so he can report on "worrisome" activities. Victor asked the kid for a photo so he can be identified by the other ZOG toadies in the area.

In this case, ZOG used someone from the bottom of the totem pole and made up stuff to make ruining my life seem like a civic

All their pictures and profiles are collecting dust.

I have been on the aptly named Joint Terrorist Task Force's list for about 10 years now. Having spent 3 years in federal prison for plastic paintball-gun silencers, (when they couldn't "get me" for my legally owned AK-47) I have plenty experience with their ways.

Given the pattern of events you reported here, I am willing to bet that the Regime defiling Washington's name already has an informant close to you. 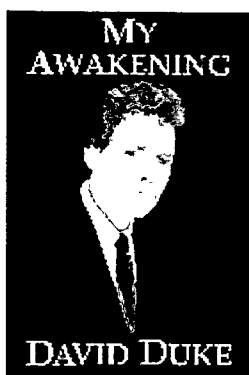

# White Nationalism FAQ

by Yggdrasil

**Q. What is White Nationalism?**

**A.** The idea that Whites may need to create a separate nation as a means of defending themselves.

**Q. Do White Nationalists feel they are superior to other races?**

**A.** No. The desire of White Nationalists to form their own nation has nothing to do with superiority or inferiority.

**Q. Do White Nationalists seek to dominate other races?**

**A.** Not at all. In fact, formation of a White nation removes any possibility of White dominance of other races, as well as the plausibility of the accusation that Whites wish to dominate others.

**Q. Do White Nationalists seek to insulate themselves from competition from other races?**

**A.** No. A separate White nation would establish a policy of free trade with its new neighbors. Labor markets are global, and the formation of a White nation would not protect Whites from economic competition.

**Q. Well if White Nationalists don't feel superior, don't want to dominate others, and don't seek protection from competition, then why would they want a separate nation?**

**A.** To avoid exploitation.

**Q. Exploitation? This is rich! So how is it that Whites are exploited?**

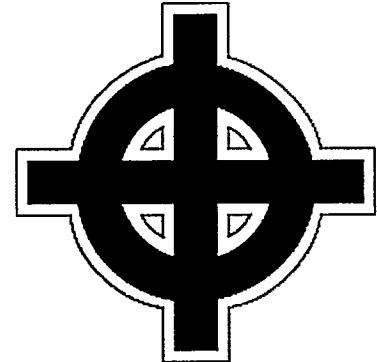
**A.** It is a long list. Burdensome racial preference schemes in hiring, racial preference schemes in university admissions, racial preference schemes in government contracting and small business loans. Beyond quotas there is the denial of rights of free speech and of due process to Whites who are critical of these governmental policies. We have special punishments for assaults committed by Whites if the motives might be racial. In addition, Whites pay a proportion of the costs of the welfare state that is disproportionate to what they receive in benefits.

But the most exploitative aspect of the situation is that neither the racial quotas, the business preferences, the loss of freedom of speech, nor the disproportionate contributions to the welfare state have managed to sate the appetites of non-Whites living in the United States.

The more Whites sacrifice, the more non-Whites demand. Many Whites are beginning to believe that no amount of tribute, other than mass suicide, would satisfy the non-White demands.

If our presence stirs up that much hatred in the hearts of non-Whites, then the only sensible course of action is to separate ourselves from them.

**Q. You claim that non-Whites are the aggressors and haters in race relations. Aren't you afraid that most Whites will think this is ridiculous?**



A. Not in the slightest. For the past 30 years most Whites have taken part in a mass migration or "White flight" away from neighborhoods inhabited by non-Whites. Aggressors don't flee. For example, on a per-capita basis, Blacks are 49 times more likely to assault a White than a White is to assault a Black. Assaults by Whites against Blacks are approximately 40 times scarcer than they would be if races were randomly mixed and assault rates did not vary by race. The best measure of racism is the number of non-economically motivated attacks. White score low in this regard, non-Whites high.

The fact is that non-Whites are clamoring to enter this country in droves. Whites are fleeing en masse to formerly uninhabited areas to escape these new arrivals.

Q. But how can Whites be exploited when it is Whites who have enacted these racial preferences, the taxation, the welfare payments and set immigration quotas?

A. Excellent question! It is true that Whites are exploited by their fellow Whites. In fact, we do not expect any resistance by non-Whites to the formation of a separate nation. We expect White integrationist elites to resist. They are the ones who have a great deal to lose.

Q. If life in America is so bad for Whites why don't you just move back to Europe?

A. We are a majority. We do not have to move back. We can resolve to defend ourselves against this onslaught. We have the option of peacefully ceding lands already inhabited by non-Whites to separate non-White nations. We would save money, and could restore our civil liberties and free ourselves from constant threats of violence by so doing.

Q. What would your separate state look like?

A. The truth is we don't know yet. Our separate state would follow the geographic outlines of White flight. The model for this state would be the modern gerrymander created by the Voting Rights Act to create majority non-White congressional districts. We would simply cede these to a separate nation. The mechanics of this process will be explained more fully later in a post entitled "sweating the details."

Q. Would all Whites be welcome in your separate state?

A. Absolutely. There would be no restriction by country of origin, and no genetic tests, skin color or hair color tests or any nonsense like that. The only restriction would be that those who would wish to recreate the present system by importing non-Whites and then encouraging their hostility would not be welcome. They would have to remain in or move to the lands ceded to the non-Whites.

Q. You are proposing that inclusion and exclusion be based on ideology and feelings. Won't your act of nation splitting turn into a witch hunt?

A. For White liberals it is definitely going to feel like a witch hunt! When the time comes, those who are guilty of "integrationism" should do the sensible thing and flee. It will spare us all a lot of pain.

Q. Is this White nation something that you intend to pursue right away?

A. No. The White nation is, by most accounts, about 20 years off. When the rest of the U.S. begins to look like Southern California it will happen more or less automatically, without much of a push from us.

Q. Why do you use the term "European-American?"

A. All Whites are descended from European immigrants, and we are not actually "White." The term European-American has political significance for two reasons. First, it recognizes that most people in the U.S. of European extraction have intermarried to such an extent that it is no longer possible to identify American Whites as "Irish" or "German" or "Italian." But more important, use of the term "European-American" is intended to recognize that White elites in the United States have exploited differences based on religion and European national origin to divide European-Americans, with the

intention of rendering us unable to defend ourselves against non-White demands.

**Q.** What is White separatism?

**A.** White separatists will agree on most points with White Nationalists, except that he may not see a need to establish a separate nation within the present territorial boundaries of the U.S.

**Q.** What is a White supremacist?

**A.** That is a White who wishes to subjugate other races by force, ordinarily by military conquest. White supremacists are very rare in 1997, and there is no visible trend or base of support which would allow them to carry such a political program into effect.

# Who Rules America?

There is no greater power in the world today than that wielded by the manipulators of public opinion in America. No king or pope of old, no conquering general or high priest ever disposed of a power even remotely approaching that of the few dozen men who control America's mass news and entertainment media.

Their power is not distant and impersonal; it reaches into every home in America, and it works its will during nearly every waking hour. It is the power which shapes and molds the mind of virtually every citizen, young or old, rich or poor, simple or sophisticated.

The mass media form for us our image of the world and then tell us what to think about that image. Essentially everything we know -- or *think* we know -- about events outside our own neighborhood or circle of acquaintances comes to us via our daily newspaper, our weekly news magazine, our radio, or our television.

It is not just the heavy-handed suppression of certain news stories from our newspapers or the blatant propagandizing of history-distorting TV "docudramas" which characterizes the opinion-manipulating techniques of the media masters. They exercise both subtlety and thoroughness in their management of both the news and the entertainment which they present to us.

For example, the way in which the news is covered: which items are emphasized and which are played down, the reporter's choice of words, tone of voice, and facial expressions; the wording of headlines; the choice of illustrations -- all of these things subliminally and yet profoundly affect the way in which we interpret what we see or hear.

On top of this, of course, the columnists and editors remove any remaining doubt from our minds as to just what we are to think about it all. Employing carefully developed psychological techniques, they guide our thought and opinion so that we can be in tune with the "in" crowd, the "beautiful people," the "smart money." They let us know exactly what our attitudes should be toward various types of people and behavior by placing those people or that behavior in the context of a TV drama or situation comedy and having the other TV characters react to them in the Politically Correct way.

## Molding American Minds

For example, a racially mixed couple will be respected, liked, and socially sought after by other characters, as will a "take charge" Black scholar or businessman, or a sensitive and talented homosexual, or a poor but honest and hardworking illegal alien from Mexico. On the other hand, a White racist -- that is, any racially conscious White person who looks askance at miscegenation or at the rapidly darkening racial situation in America -- is portrayed, at best, as a despicable bigot who is reviled by the other characters, or, at worst, as a dangerous psychopath who is fascinated by firearms and is a menace to all

law-abiding citizens. The White racist "gun nut," in fact, has become a familiar stereotype on TV shows.

The average American, of whose daily life TV-watching takes such an unhealthy portion, distinguishes between these fictional situations and reality only with difficulty, if at all. He responds to the televised actions, statements, and attitudes of TV actors much as he does to his own peers in real life. For all too many Americans the real world has been replaced by the false reality of the TV environment, and it is to this false reality that his urge to conform responds. Thus, when a TV scriptwriter expresses approval of some ideas and actions through the TV characters for whom he is writing, and disapproval of others, he exerts a powerful pressure on millions of viewers toward conformity with his own views.

And as it is with TV entertainment, so it is also with the news, whether televised or printed. The insidious thing about this form of thought control is that even when we realize that entertainment or news is biased, the media masters still are able to manipulate most of us. This is because they not only slant what they present, but they establish tacit boundaries and ground rules for the permissible spectrum of opinion.

As an example, consider the media treatment of Middle East news. Some editors or commentators are slavishly pro-Israel in their every utterance, while others seem nearly neutral. No one, however, dares suggest that the U.S. government is backing the wrong side in the Arab-Jewish conflict and that it served Jewish interests rather than American interests to send U.S. forces to cripple Iraq, Israel's principal rival in the Middle East. Thus, a spectrum of permissible opinion, from pro-Israel to nearly neutral, is established.

Another example is the media treatment of racial issues in the United States. Some commentators seem almost dispassionate in reporting news of racial strife, while others are emotionally partisan -- with the partisanship always on the non-White side. All of the media spokesmen without exception, however, take the position that "multiculturalism" and racial mixing are here to stay, and that they are good things.

Because there are differences in degree, however, most Americans fail to realize that they are being manipulated. Even the citizen who complains about "managed news" falls into the trap of thinking that because he is presented with an apparent spectrum of opinion he can escape the thought controllers' influence by believing the editor or commentator of his choice. It's a "heads I win, tails you lose" situation. Every point on the permissible spectrum of public opinion is acceptable to the media masters -- and no impermissible fact or viewpoint is allowed any exposure at all, if they can prevent it.

The control of the opinion-molding media is nearly monolithic. All of the controlled media -- television, radio, newspapers, magazines, books, motion pictures -- speak with a single voice, each reinforcing the other. Despite the appearance of variety, there is no real dissent, no alternative source of facts or ideas accessible to the great mass of people which might allow them to form opinions at odds with those of the media masters. They are presented with a single view of the world -- a world in which *every* voice proclaims the equality of the races, the inerrant nature of the Jewish "Holocaust" tale, the wickedness of attempting to halt a flood of non-White aliens from pouring across our borders, the danger of permitting citizens to keep and bear arms, the moral equivalence of all sexual orientations, and the desirability of a "pluralistic," cosmopolitan society rather than a homogeneous one. It is a view of the world designed by the media masters to suit their own ends -- and the pressure to conform to that view is overwhelming. People adapt their opinions to it, vote in accord with it, and shape their lives to fit it.

And who are these all-powerful masters of the media? As we shall see, to a very large extent they are Jews.

## Electronic News & Entertainment Media

Continuing government deregulation of the telecommunications industry has resulted, not in the touted increased competition, but rather in an accelerating wave of corporate mergers and acquisitions that have produced a handful of multi-billion-dollar media conglomerates. Whenever you watch television, whether from a local broadcasting station or via a cable or satellite dish; whenever you see a feature film in a theater or at home; whenever you listen to the radio or recorded music; whenever you read a newspaper, book, or magazine -- it is very likely that the information or entertainment you receive was produced and/or distributed by one of these megamedia companies.

The largest media conglomerate today, with 1997 revenues of \$23 billion, is the Walt Disney Company. Its chairman and CEO, Michael Eisner, is a Jew. The Disney empire, headed by a man described by one media analyst as "a control freak," includes several television production companies (Walt Disney Television, Touchstone Television, Buena Vista Television) and cable networks with more than 100 million subscribers altogether.

As for feature films, the Walt Disney Picture Group, headed by Joe Roth (also a Jew), includes Touchstone Pictures, Hollywood Pictures, and Caravan Pictures. Disney also owns Miramax Films, run by the Weinstein brothers, who have produced such ultra-raunchy movies as *The Crying Game*, *Priest*, and *Kids*.

When the Disney Company was run by the Gentile Disney family prior to its takeover by Eisner in 1984, it epitomized wholesome, family entertainment. While it still holds the rights to *Snow White*, under Eisner the company has expanded into the production of a great deal of so-called "adult" material. In addition to TV and movies, the corporation owns Disneyland, Disney World, Epcot Center, Tokyo Disneyland, and Euro Disney.

Disney also sells annually well over a billion dollars worth of consumer products -- books, toys, and clothing -- through 636 Disney stores. In August 1995 Eisner acquired Capital Cities/ABC, Inc, which owns the ABC Television Network, which in turn owns ten TV stations outright in such big markets as New York, Chicago, Philadelphia, Los Angeles, San Francisco, and Houston. In addition, it has 225 affiliated stations in the United States and is part owner of several European TV companies.

ABC's cable subsidiary, ESPN, is headed by president and CEO Steven Bornstein, who is a Jew. The corporation also has a controlling share of Lifetime Television and the Arts & Entertainment Network cable companies. ABC Radio Network owns 26 AM and FM stations, again in major cities such as New York, Washington, and Los Angeles, and has over 3,400 affiliates.

Although primarily a telecommunications company, Capital Cities/ABC earned over \$1 billion in publishing in 1997. It owns seven daily newspapers, Fairchild Publications (*Women's Wear Daily*), Chilton Publications (automotive manuals), and the Diversified Publishing Group.

Time Warner, Inc., with 1997 revenues of more than \$13 billion, is the second of the international media leviathans. Time Warner leapfrogged over the Walt Disney Company to first place among media giants when it acquired Turner Broadcasting System in 1996, but it slipped back into second place in 1997. The chairman of the board and CEO of Time Warner, Gerald M. Levin, is a Jew. Time Warner's subsidiary HBO is the country's largest pay-TV cable network.

Until the purchase in May 1998 of PolyGram by Edgar Bronfman, Jr., Warner Music was America's largest record company, with 50 labels, the biggest of which is Warner Brothers Record. Warner Music was an early promoter of "gangsta rap." Through its involvement with Interscope Records (prior to Interscope's acquisition by MCA) it helped popularize a genre whose graphic lyrics explicitly urge Blacks to commit acts of violence against Whites.

In addition to cable and music, Time Warner is heavily involved in the production of feature films (Warner Brothers Studio, Castle Rock Entertainment, and New Line Cinema) and publishing. Time Warner's publishing division (editor-in-chief Norman Pearlstine, a Jew) is the largest magazine publisher in the country (*Time*, *Sports Illustrated*, *People*, *Fortune*).

The deal which temporarily made Gerald Levin number-one media magnate -- the acquisition of Ted Turner's Turner Broadcasting System -- also took one of the few remaining Gentiles out of the top ranks of media bosses. When Ted Turner, the Gentile media maverick, made a bid to buy CBS in 1985, there was panic in media boardrooms across the nation. Turner had made a fortune in advertising and then had built a successful cable-TV news network, CNN. Although Turner employed a number of Jews in key executive positions in CNN and had never taken public positions contrary to Jewish interests, he is a man with a large ego and a strong personality and was regarded by Chairman William Paley and the other Jews at CBS as uncontrollable: a loose cannon who might at some time in the future turn against them.



Furthermore, Jewish newsman Daniel Schorr, who had worked for Turner, publicly charged that his former boss held a personal dislike for Jews.

To block Turner's bid CBS executives invited billionaire Jewish theater, hotel, insurance, and cigarette magnate Laurence Tisch to launch a "friendly" takeover of the company, and from 1986 till 1995 Tisch was the chairman and CEO of CBS, removing any threat of non-Jewish influence there. Subsequent efforts by Turner to acquire a major network have been obstructed by Levin's Time Warner, which owns nearly 20 percent of CBS stock and has veto power over major deals.

Thus, despite being an innovator and garnering headlines, Turner never commanded the "connections" required to be a true media master. He finally decided, if you can't lick 'em, join 'em, and he sold out to Levin.

Number three on the list, with 1997 revenues of just over \$13 billion, is Viacom, Inc, headed by Sumner Redstone (born Murray Rothstein). Viacom, which produces and distributes TV programs for the three largest networks, owns 13 television stations and 12 radio stations. It produces feature films through Paramount Pictures, headed by Jewess Sherry Lansing.

Its publishing division includes Simon & Schuster, Scribner, The Free Press, and Pocket Books. It distributes videos through over 4,000 Blockbuster stores. It is also involved in satellite broadcasting, theme parks, and video games.

Viacom's chief claim to fame, however, is as the world's largest provider of cable programming, through its Showtime, MTV, Nickelodeon, and other networks. Since 1989 MTV and Nickelodeon have acquired larger and larger shares of the juvenile television audience. Redstone, who actually owns 76 per cent of the shares of Viacom, until recently offered Beavis and Butthead as teen role models and currently is the largest single purveyor of race-mixing propaganda to White teenagers and sub-teens in America and Europe. MTV pumps its racially mixed rock and rap videos into 210 million homes in 71 countries and is the dominant cultural influence on White teenagers around the world.

Nickelodeon has by far the largest share of the four-to-11-year-old TV audience in America and also is expanding rapidly into Europe. Most of its shows do not yet display the blatant degeneracy which is MTV's trademark, but Redstone is gradually nudging the fare presented to his kiddie viewers toward the same poison purveyed by MTV.

The new boy on the megamedia block is Edgar Bronfman, Jr., president and CEO of Seagram Company, Ltd., the liquor giant. His father, Edgar Bronfman, Sr., is president of the World Jewish Congress. Seagram owns two large production companies, MCA and Universal Pictures (now merged under the name Universal Studios). Among its many other properties, MCA owns Interscope Records, the foremost promoter of "gangsta rap."

Bronfman became the biggest man in the record business in May 1998 when he also acquired control of PolyGram, the European record giant, by paying \$10.6 billion to the Dutch electronics manufacturer Philips. With the expected revenue from PolyGram added to that from MCA and Universal, Bronfman will have the fourth largest media empire, with annual revenues around \$12 billion. One especially unfortunate aspect of the PolyGram acquisition is that it gives Bronfman control of the world's largest producer of classical music CDs: PolyGram owns the Deutsche Grammophon, Decca-London, and Philips record companies.

With the top four media conglomerates in the hands of Jews, it is difficult to believe that such an overwhelming degree of control came about without a deliberate, concerted effort on their part.

What about the other big media companies?

Rupert Murdoch's News Corporation, which owns Fox Television Network, 20th Century Fox Films, and Fox 2000, is the fifth largest megamedia corporation in the country, with 1997 revenues of over \$11 billion. It is the only other media company which comes even close to the top four. Murdoch is a Gentile Australian, but Peter Chernin, who is president and CEO of Fox Group, which includes all of News

Corporation's film, television, and publishing operations in the United States, is a Jew. Under Chernin, as chairman of Fox 2000, is Laura Ziskin, a Jewess. Jew Peter Roth works under Chernin as president of Fox Entertainment. News Corporation also owns the *New York Post* and *TV Guide*, and they are published under Chernin's supervision.

Most of the television and movie production companies that are not owned by the largest corporations are also controlled by Jews. For example, New World Entertainment, proclaimed by one media analyst as "the premiere independent TV program producer in the United States," is owned by Ronald Perelman, a Jew who also owns Revlon cosmetics and offered a job to Monica Lewinsky when Bill Clinton was trying to keep her quiet.

The best known of the smaller media companies, DreamWorks SKG, is a strictly kosher affair. DreamWorks was formed in 1994 amid great media hype by recording industry mogul David Geffen, former Disney Pictures chairman Jeffrey Katzenberg, and film director Steven Spielberg, all three of whom are Jews. The company produces movies, animated films, television programs, and recorded music. Considering the cash and connections that Geffen, Katzenberg, and Spielberg have, DreamWorks may soon be in the same league as the big four.

It is well known that Jews have controlled the production and distribution of films since the inception of the movie industry in the early decades of this century. This is still the case today.

Films produced by just the four largest motion picture companies mentioned above -- Disney, Warner Brothers, Paramount (Viacom), and Universal (Seagram) -- accounted for two-thirds of the total box-office receipts for the year 1997.

The big three in television network broadcasting used to be ABC, CBS, and NBC. With the consolidation of the media empires, these three are no longer independent entities. While they were independent, however, each was controlled by a Jew since its inception: ABC by Leonard Goldenson, CBS first by William Paley and then by Laurence Tisch, and NBC first by David Sarnoff and then by his son Robert. Over periods of several decades these networks were staffed from top to bottom with Jews, and the essential Jewishness of network television did not change when the networks were absorbed by other corporations. The Jewish presence in television news remains particularly strong.

For example, the executive producers of all three of the main network news programs are Jews. The executive producer of ABC's *World News Tonight with Peter Jennings* is Paul Friedman. The executive producer of *NBC Nightly News with Tom Brokaw* is Neal Shapiro. The executive producer of *CBS Evening News with Dan Rather* is Al Oritz. If you prefer *CBS This Morning News* instead, the executive producer is Al Berman, who also is a Jew. Or if you get your news from CNN, the boss there is Rick Kaplan, also a Jew.

## The Print Media

After television news, daily newspapers are the most influential information medium in America. Sixty million of them are sold (and presumably read) each day. These millions are divided among some 1,500 different publications. One might conclude that the sheer number of different newspapers across America would provide a safeguard against minority control and distortion. Alas, such is not the case. There is less independence, less competition, and much less representation of majority interests than a casual observer would think.

The days when most cities and even towns had several independently owned newspapers published by local people with close ties to the community are gone. Today most "local" newspapers are owned by a rather small number of large companies controlled by executives who live and work hundreds or even thousands of miles away. The fact is that only about 25 per cent of the country's 1,500 papers are independently owned; the rest belong to multi-newspaper chains. Only 100 of the total number have circulations of more than 100,000. Only a handful are large enough to maintain independent reporting staffs outside their own communities; the rest must depend on these few for all of their national and international news.

In only 50 cities in America are there more than one daily newspaper, and competition is frequently nominal even among them, as between morning and afternoon editions under the same ownership. Examples of this are the Huntsville, Alabama, morning *News* and afternoon *Times*; the Birmingham, Alabama, morning *Post Herald* and afternoon *News*; the Mobile, Alabama, morning *Register* and afternoon *Press*; the Springfield, Massachusetts, morning *Union*, afternoon *News*, and Sunday-only *Republican*; the Syracuse, New York, morning *Post-Standard* and afternoon *Herald-Journal* -- all owned by the Jewish Newhouse brothers through their holding company, Advance Publications.

The Newhouse media empire provides an example of more than the lack of real competition among America's daily newspapers: it also illustrates the insatiable appetite Jews have shown for all the organs of opinion control on which they could fasten their grip. The Newhouses own 26 daily newspapers, including several large and important ones, such as the Cleveland *Plain Dealer*, the Newark *Star-Ledger*, and the New Orleans *Times-Picayune*; Newhouse Broadcasting, consisting of 12 television broadcasting stations and 87 cable-TV systems, including some of the country's largest cable networks; the Sunday supplement *Parade*, with a circulation of more than 22 million copies per week; some two dozen major magazines, including the *New Yorker*, *Vogue*, *Mademoiselle*, *Glamour*, *Vanity Fair*, *Bride's*, *Gentlemen's Quarterly*, *Self*, *House & Garden*, and all the other magazines of the wholly owned Conde Nast group.

This Jewish media empire was founded by the late Samuel Newhouse, an immigrant from Russia. When he died in 1979 at the age of 84, he bequeathed media holdings worth an estimated \$1.3 billion to his two sons, Samuel and Donald. With a number of further acquisitions, the net worth of Advance Publications has grown to more than \$8 billion today.

The gobbling up of so many newspapers by the Newhouse family was in large degree made possible by the fact that newspapers are not supported by their subscribers, but by their advertisers. It is advertising revenue -- not the small change collected from a newspaper's readers -- that largely pays the editor's salary and yields the owner's profit.

Whenever the large advertisers in a city choose to favor one newspaper over another with their business, the favored newspaper will flourish while its competitor dies. Since the beginning of this century, when Jewish mercantile power in America became a dominant economic force, there has been a steady rise in the number of American newspapers in Jewish hands, accompanied by a steady decline in the number of competing Gentile newspapers -- primarily as a result of selective advertising policies by Jewish merchants.

Furthermore, even those newspapers still under Gentile ownership and management are so thoroughly dependent upon Jewish advertising revenue that their editorial and news reporting policies are largely constrained by Jewish likes and dislikes. It holds true in the newspaper business as elsewhere that he who plays the piper calls the tune.

## Three Jewish Newspapers

The suppression of competition and the establishment of local monopolies on the dissemination of news and opinion have characterized the rise of Jewish control over America's newspapers. The resulting ability of the Jews to use the press as an unopposed instrument of Jewish policy could hardly be better illustrated than by the examples of the nation's three most prestigious and influential newspapers: the *New York Times*, the *Wall Street Journal*, and the *Washington Post*. These three, dominating America's financial and political capitals, are the newspapers which set the trends and the guidelines for nearly all the others. They are the ones which decide what is news and what isn't, at the national and international levels. They originate the news; the others merely copy it. And all three newspapers are in Jewish hands.

The *New York Times* is the unofficial social, fashion, entertainment, political, and cultural guide of the nation. It tells America's "smart set" which books to buy and which films to see; which opinions are in style at the moment; which politicians, educators, spiritual leaders, artists, and businessmen are the real comers. And for a few decades in the last century it was a genuinely American newspaper.

The *New York Times* was founded in 1851 by two Gentiles, Henry J. Raymond and George Jones. After their deaths, it was purchased in 1896 from Jones's estate by a wealthy Jewish publisher, Adolph Ochs. His great-great-grandson, Arthur Sulzberger, Jr., is the paper's current publisher and the chairman of the New York Times Co. The executive editor is Joseph Lelyveld, also a Jew (he is a rabbi's son).

The Sulzberger family also owns, through the New York Times Co., 33 other newspapers, including the *Boston Globe*, purchased in June 1993 for \$1.1 billion; twelve magazines, including *McCall's* and *Family Circle* with circulations of more than 5 million each; seven radio and TV broadcasting stations; a cable-TV system; and three book publishing companies. The New York Times News Service transmits news stories, features, and photographs from the *New York Times* by wire to 506 other newspapers, news agencies, and magazines.

Of similar national importance is the *Washington Post*, which, by establishing its "leaks" throughout government agencies in Washington, has an inside track on news involving the Federal government.

The *Washington Post*, like the *New York Times*, had a non-Jewish origin. It was established in 1877 by Stilson Hutchins, purchased from him in 1905 by John R. McLean, and later inherited by Edward B. McLean. In June 1933, however, at the height of the Great Depression, the newspaper was forced into bankruptcy. It was purchased at a bankruptcy auction by Eugene Meyer, a Jewish financier and former partner of the infamous Bernard Baruch, industry czar in America during the First World War.

The *Washington Post* is now run by Katherine Meyer Graham, Eugene Meyer's daughter. She is the principal stockholder and the board chairman of the Washington Post Co. In 1979 she appointed her son Donald publisher of the paper. He now also holds the posts of president and CEO of the Washington Post Co.

The Washington Post Co. has a number of other media holdings in newspapers, television, and magazines, most notably the nation's number-two weekly newsmagazine, *Newsweek*.

In a joint venture with the *New York Times*, the *Post* publishes the *International Herald Tribune*, the most widely distributed English language daily in the world.

The *Wall Street Journal*, which sells 1.8 million copies each weekday, is the nation's largest-circulation daily newspaper. It is owned by Dow Jones & Company, Inc, a New York corporation which also publishes 24 other daily newspapers and the weekly financial tabloid *Barron's*, among other things. The chairman and CEO of Dow Jones is Peter R. Kann, who is a Jew. Kann also holds the posts of chairman and publisher of the *Wall Street Journal*.

Most of New York's other major newspapers are in no better hands than the *New York Times* and the *Wall Street Journal*. In January 1993 the *New York Daily News* was bought from the estate of the late Jewish media mogul Robert Maxwell (born Ludvik Hoch) by Jewish real-estate developer Mortimer B. Zuckerman. The *Village Voice* is the personal property of Leonard Stern, the billionaire Jewish owner of the Hartz Mountain pet supply firm. And, as mentioned above, the *New York Post* is owned by News Corporation under the Jew Peter Chernin.

## News Magazines

The story is pretty much the same for other media as it is for television, radio, films, music, and newspapers. Consider, for example, newsmagazines. There are only three of any note published in the United States: *Time*, *Newsweek*, and *U.S. News & World Report*.

*Time*, with a weekly circulation of 4.1 million, is published by a subsidiary of Time Warner Communications, the new media conglomerate formed by the 1989 merger of Time, Inc, with Warner Communications. The CEO of Time Warner Communications, as mentioned above, is Gerald Levin, a Jew.

*Newsweek*, as mentioned above, is published by the Washington Post Company, under the Jewess

Katherine Meyer Graham. Its weekly circulation is 3.2 million.

*U.S. News & World Report*, with a weekly circulation of 2.3 million, is owned and published by the aforementioned Mortimer B. Zuckerman, who also has taken the position of editor-in-chief of the magazine for himself. Zuckerman also owns the *Atlantic Monthly* and New York's tabloid newspaper, the *Daily News*, which is the sixth-largest paper in the country.

## Our Responsibility

Those are the facts of media control in America. Anyone willing to spend a few hours in a large library looking into current editions of yearbooks on the radio and television industries and into directories of newspapers and magazines; into registers of corporations and their officers, such as those published by Standard and Poors and by Dun and Bradstreet; and into standard biographical reference works can verify their accuracy. They are undeniable, and when confronted with them Jewish spokesmen customarily will use evasive tactics. "Ted Turner isn't a Jew!" they will announce triumphantly, as if that settled the issue. If pressed further they will accuse the confronter of "anti-Semitism" for even raising the subject. It is fear of this accusation which keeps many persons silent who know the facts.

But we must not remain silent on this most important of issues! The Jewish control of the American mass media is the single most important fact of life, not just in America, but in the whole world today. There is nothing -- plague, famine, economic collapse, even nuclear war -- more dangerous to the future of our people.

Jewish media control determines the foreign policy of the United States and permits Jewish interests rather than American interests to decide questions of war and peace. Without Jewish media control, there would have been no Persian Gulf war, for example, and no continued beating of the drums for another war against Iraq.

By permitting the Jews to control our news and entertainment media we are doing more than merely giving them a decisive influence on our political system and virtual control of our government; we also are giving them control of the minds and souls of our children, whose attitudes and ideas are shaped more by Jewish television and Jewish films than by parents, schools, or any other influence.

The Jew-controlled entertainment media have taken the lead in persuading a whole generation that homosexuality is a normal and acceptable way of life; that there is nothing at all wrong with White women dating or marrying Black men, or with White men marrying Asiatic women; that all races are inherently equal in ability and character -- except that the character of the White race is suspect because of a history of oppressing other races; and that any effort by Whites at racial self-preservation is reprehensible.

We must oppose the further spreading of this poison among our people, and we must break the power of those who are spreading it. It would be intolerable for such power to be in the hands of *any* alien minority, with values and interests different from our own. But to permit the Jews, with their 3,000-year history of nation-wrecking, from ancient Egypt to Russia, to hold such power over us is tantamount to race suicide. Indeed, the fact that so many White Americans today are so filled with a sense of racial guilt and self-hatred that they actively seek the death of their own race is a *deliberate* consequence of Jewish media control.

Once we have absorbed and understood the fact of Jewish media control, it is our inescapable responsibility to do *whatever is necessary* to break that control. We must shrink from *nothing* in combating this evil power which has fastened its deadly grip on our people and is injecting its lethal poison into their minds and souls. If we fail to destroy it, it certainly will destroy our race.

Let us begin now to acquire knowledge and take action toward this necessary end.

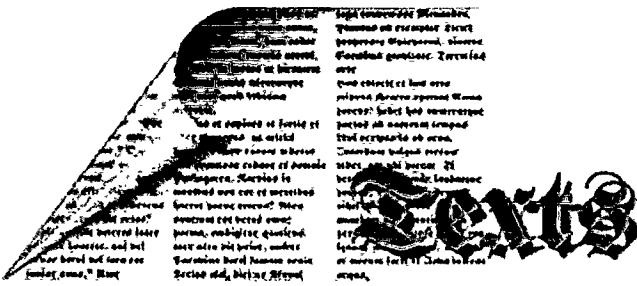

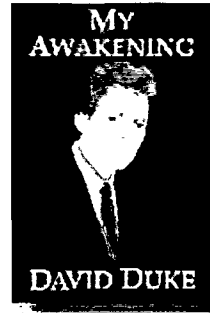

# Legal Defense Fund

The Internet has, for the first time, provided individuals and small organizations the means to effectively compete with the controlled media monopoly. The major television networks and the big publishing conglomerates no longer control what news the world will hear.

The backlash from those who have vested interests in suppressing the truth has been predictable. A United Nations committee has proposed a multinational agreement to outlaw "racist" ideas on the Net. Some countries have already thrown website owners in jail for not conforming to the Establishment Orthodoxy. One German website operator was arrested for merely including a link to Stormfront on his page.

Here in the United States, efforts to censor the Net have been impeded by a strong First Amendment tradition guaranteeing freedom of speech. Not yet ready to take on the Constitution, pressure groups such as the Simon Wiesenthal Center have launched hate campaigns against internet service providers who don't censor political content, attempting to blackmail them into yanking the plug on any customer whose views the Rabbis find "offensive." More recently, the Anti-Defamation League of B'nai B'rith announced agreements with both America Online and The Learning Company to develop filtering software. Sites not approved by the ADL, including Stormfront, David Duke Online, American Renaissance (which publishes research documenting racial differences), and many others are blocked on any machine using this software, and the customer is instead be taken to an ADL "re-education" page on "bigotry." Other filtering software such as Surfwatch and Cybersitter, usually purchased to block pornography, is also being used to censor political content, usually without the customer even knowing about it.

In a few cases, politically controlled police agencies simply trump up other charges against those whose real "crime" is exercising their First Amendment rights. "Hate crimes" statutes, which have been enacted at the behest of the ADL in many states, are also used to further distort justice by making one's political views "evidence" of criminal intent.

In light of this mounting threat to freedom, the Stormfront Legal Defense Fund has been established to pay legal expenses for selected First Amendment-related cases. The unfortunate reality in America today is that we can only maintain our Constitutional "rights" if we have the money to fight for them in the courts.

If you understand the need for an effective legal resource for patriots, please contribute as generously as your means permit. Unlike the ADL, Wiesenthal Center, and other left wing groups, we have no big corporate backers. We depend on small donations from people like you.

This precipitated an organized hate campaign by the Simon Wiesenthal Center and similar groups to pressure our providers into yanking our accounts. Since then, despite the best efforts of Rabbi Cooper and Company to censor "objectionable" ideas, dozens of new sites have appeared. It's becoming difficult for us to keep up with all of them, but we'll try to keep this list updated with the most substantial of the new entries, along with any URL changes for the old ones.

We've chosen these sites because we think they all offer something worthwhile for White Nationalists. This doesn't necessarily mean Stormfront endorses them, however. We know many of the authors of these sites personally, some for as long as three decades. Others, though, we know little about and can't vouch for their sincerity or commitment.

Please don't ask me to link sites at BHI's Geocities. This company offers free web pages, but it's adopted a policy of censoring pro-White pages as soon as it finds them. Listing them here would only hasten that process. America Online has also fallen into this category.

- **Church of the Creator.**  
RAHOWA! (Racial HOLY WAR). The White Race is the "Creator."
- **Civil War Two**  
Thomas Chittum, author of Civil War Two: The Coming Breakup of America, maintains this site. Includes articles and extensive links supporting his proposition that America's "multi-racial empire" will collapse into a Bosnia-style racial/ethnic war within twenty years.

We support the unity of our movement and the revolutionizing of our spirit into a combined force to take back control of our Race's destiny, by any means necessary." Includes regularly updated news section and large links page.

- The Occidental Pan-Aryan Crusader

"Uniting the European and European-American world for the preservation of the Aryan Race." Includes large text archive.

The e-zine for Nationalists. Articles, commentary, cartoons, book reviews. Edited by legendary White Nationalist illustrator, Dennis Nix. Note new URL.

- The Story of the AWB of South Africa

Online book by Arthur Kemp detailing the history of the Afrikaner Resistance Movement (AWB), South Africa's leading opposition to Black communist rule.

## Eugenics

Promoting quality over quantity.

- **Surrogate Mothers**

Service for those wanting to investigate the possibility of using a surrogate mother to add a child to their family. Also intended to promote procreation by those individuals who can provide a superior genetic endowment, excellent environment, love and support to a child.

- **Future Generations**

Promotes hope for humanity by improving our genetic heritage. Eugenics is "the organic betterment of the race through wise application of the laws of heredity."

- **Buchanan Brigade**

Pat Buchanan is a traditional populist conservative whose views frequently coincide with those of White Nationalists. He was outspokenly opposed to affirmative action and other anti-White programs long before it was fashionable to do so. He called Capitol Hill "Israeli-occupied territory." He unflinchingly defended John Demjanjuk, the retired Cleveland auto worker extradited to Israel for "Nazi war crimes," and he was later vindicated when the Israeli Supreme Court was forced to release Demjanjuk in the face of new evidence released after the fall of the USSR. Though he apparently does not understand the central importance of Race, his campaign attracted some good people. This site, formerly the Buchanan for President page, is now run by Linda Muller as a private project.

Christian Identity material from Pastor Pete Peters organization on race, law, and social issues. Information can also be found at the SFA's FTP Site.

## **Ku Klux Klan**

"The Klan" actually consists of dozens of separate organizations, each with varying goals, tactics, and quality of leadership. And, contrary to the media stereotype, few Klan groups today advocate illegal violence, though the Klan was originally founded after the Civil War as a guerrilla army which restored White majority rule and constitutional government to the occupied South.

- **Northwest Knights**

Affiliated with Thom Robb's Knights of the Ku Klux Klan. Also hosts other pages promoting the Northwest Territorial Initiative, the movement to establish a White Homeland in the Northwest United States. This site is run by two long-time comrades of ours.

- **KKK.com**

Intended as "a virtual museum of Ku Klux Klan history and artifacts. KKK.com does not represent any particular Klan group. We are Klan members who are interested in preserving and relaying the unadulterated truth about the Invisible Empire."

- **Knights of the White Kamellia**

Vidor, Texas-based group led by Darrell Flinn.

- **Knights of the Ku Klux Klan**

Another Knights of the Ku Klux Klan, formerly headed by Troy Murphy, now under different leadership. This was the first Klan group to recruit on the Net.

- **White Camelia Knights of the Ku Klux Klan**

Cleveland, Texas-based group led by Charles Lee.

---

## Skinheads

Any pro-White site calling itself this goes here.

- **Skinheads of the Racial Holy War**  
Skinhead-oriented World Church of the Creator site. "Based on the eternal laws of nature."

## White Power Music

- **Panzerfaust Records** NEW  
A distributor of White Power music CD's. Online orders and prompt delivery by dedicated fellow racialists.
- **Resistance Records**  
America's first pro-White record company.
- **Nordland**  
Pro-White Music from Sweden's Nordland. Includes English language pages for Svastika and Triskelion bands.

## International

These are sites written primarily in a language other than English.

- **Grupo NuevOrden**  
Miami's own Neo-Fascist Spanish group aimed at our comrades in Spain and Latin America.
- **Front National**  
Jean-Marie Le Pen is shaking up the treasonous French Establishment with this dynamic political party.
- **ThuleNet**  
"Third Position" European nationalist site. In German.

## The Other Side

These are sites opposing our use of the 'Net to promote our point of view. Some openly support censorship (though they don't call it that), while others claim they only want to "expose" us for "what we really are."

- **Hatewatch**  
Founded as a Harvard Law School Library project, this group is now funded primarily by corporate donations, with Lotus Development the biggest. While claiming they oppose censorship, Director David Goldman encourages his supporters to only do business with ISPs which deny access to pro-White activists.
- **Nizkor**  
Founder Ken McVay intended this site to be a counter to the growing tide of historical revisionism on the 'Net. It originally kept nearly complete archives of anyone posting politically incorrect material on Usenet. Claims to oppose censorship, but doesn't consider organized pressure against ISPs to be "censorship."
- **Simon Wiesenthal Center**  
The Rabbis at the Wiesenthal Center have been the most active in organizing hate

campaigns against ISPs hosting sites they find "offensive."

- **Anti-Defamation League**

This is the oldest organization fighting to suppress facts and ideas "harmful to Jewish interests." Recently, they have made arrangements with both America Online and The Learning Company to develop filtering software, which will block sites they don't like and redirect users to one of their own pages.

- **Jewish Defense Organization**

This one advocates outright terrorism against anyone considered an "enemy of the Jews."

After a while, you may find aggressive use of the "kill files" feature found on most newsreaders will make these forums more readable. You might also want to subscribe to the [Stormfront-L](#) discussion mailing list as an alternative or log on to the [Stormfront Interactive](#) message board.

With many or most messages now crossposted to both the above newsgroups, these have become very similar in content. The decibel level on the first, nevertheless, is still slightly lower. Alt.politics.white-power seems to be somewhat better known, however, having been mentioned in several national news media recently.

This group was formed by "anti-Revisionists" and is still dominated by those defending Holocaust Orthodoxy.

- **Alt.skinheads**

There are still a few White Power skins here, along with non-political or "traditional" skins. Most of what's posted here, though, is garbage. This is the noisiest and, incidentally, the most widely read of these newsgroups.

Not much message traffic on these two groups, but most of the anti-White bigots haven't found them yet.

Stormfront began its life as a private electronic bulletin board (BBS) with three users in 1990. On July 4, 1994, it was opened as a publicly accessible board.

"The Net is a resource, a BBS is a home," somebody said. BBBs provide their members with discussion conferences, downloadable files, online chat (if there's more than one node), games, and, of course, "bulletins." Dial-in boards today, though, unless they provide a gateway to the Net, are on the decline. 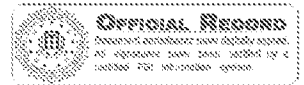
