Subject: ICE Detainer Update

Folks,

Attached is a description of the new program NSA negotiated with ICE for improving detention support for criminal illegal aliens.

Briefly it is a derivative of 287g (and available for 287 jails) to significantly reduce training of jail deputies so they may legally and constitutionally support detainee requests from ICE officials. It also protects Sheriffs from liability as well.

Tomorrow will mark the first phase with the announcement in Pinellas County Florida. Beside taking the lead in negotiating and designing the Program--Sheriff Gualtieri will be the first signatory joining the effort. The nationwide roll out will commence after Louisville where briefings and training starts.
