## **IX. Special Conditions for Grant Subaward with Forensic Science Improvement Act (FSIA) Funds**

### **1. Requirements of the Subaward; remedies for non-compliance or for materially false statements**

The conditions of this Subaward are material requirements of the Subaward. Compliance with any certifications or assurances submitted by or on behalf of the Subrecipient that relate to conduct during the period of performance also is a material requirement of this Subaward.

Failure to comply with any one or more of these Subaward requirements, whether a condition set out in full below, a condition incorporated by reference below, or a certification or assurance related to conduct during the Subaward period, may result in the Office of Justice Programs ("OJP") taking appropriate action with respect to the Subrecipient and the Subaward. Among other things, the OJP may withhold Subaward funds, disallow costs, or suspend or terminate the Subaward. The Department of Justice ("DOJ"), including OJP, also may take other legal action as appropriate.

Any materially false, fictitious, or fraudulent statement to the federal government related to this Subaward (or concealment or omission of a material fact) may be the subject of criminal prosecution (including under 18 U.S.C. 1001 and/or 1621, and/or 34 U.S.C. 10271-10273), and also may lead to imposition of civil penalties and administrative remedies for false claims or otherwise (including under 31 U.S.C. 3729-3730 and 3801-3812).

### **2. Applicability of Part 200 Uniform Requirements**

17. Reporting Potential Fraud, Waste, and Abuse, and Similar Misconduct

The Subrecipient must promptly refer to Cal OES any credible evidence that a principal, employee, agent, Subrecipient, contractor, subcontractor, or other person has, in connection with funds under this Subaward (1) submitted a claim that violates the False Claims Act; or (2) committed a criminal or civil violation of laws pertaining to fraud, conflict of interest, bribery, gratuity, or similar misconduct.

Potential fraud, waste, abuse, or misconduct involving or relating to funds under this Subaward should be reported to Cal OES.

18. Restrictions and certifications regarding non-disclosure agreements and related matters

- 2) percent reduction in the number of backlogged forensic cases (calculated by reporting the number of backlogged forensic cases at the beginning of the grant Subaward performance period versus the number of backlogged forensic cases at the end of grant Subaward performance period), if applicable to the Subaward; and
- 3) the number of forensic science or medical examiner/coroner's office personnel who completed appropriate training or educational opportunities with these Coverdell funds, if applicable to the Subaward. Subrecipients are required to collect and report data relevant to these measures.

23. The Subrecipient acknowledges that, as stated in the RFA for the Paul Coverdell Forensic Science Improvement Grants Program, Cal OES assumes that Subrecipients of Coverdell funds will make use of the process referenced in their certification as to external investigations and will refer allegations of serious negligence or misconduct substantially affecting the integrity of forensic results to government entities with an appropriate process in place to conduct independent external investigations, such as the government entity (or entities) identified in the grant application. The Subrecipient shall submit the following information as part of its final report: (1) the number and nature of any allegations of serious negligence or misconduct substantially affecting the integrity of forensic results received during the period of the Subaward; (2) information on the referrals of such allegations (e.g., the government entity or entities to which referred, the date of referral); (3) the outcome of such referrals (if known as of the date of the report); and (4) if any such allegations were not referred, the reason(s) for the non-referral. Should the project period for this Subaward be extended, the Subrecipient shall submit the above information as to the first twelve months of the Subaward as part of the first semi-annual progress report that comes due after the conclusion of the first twelve months of the project period, and shall submit the required information as to subsequent twelve-month periods every twelve months thereafter (as part of a semi-annual progress report) until the close of the grant Subaward performance period, at which point the Subrecipient shall submit the required information as to any period not covered by prior reports as part of its final report. Advance notice permits time for coordination of release of information by Cal OES where appropriate and to respond to press or public inquiries.
27. Copyright; Data rights

The Subrecipient acknowledges that OJP reserves a royalty-free, non-exclusive, and irrevocable license to reproduce, publish, or otherwise use, and authorize others to use (in whole or in part, including in connection with derivative works), for Federal purposes: (1) any work subject to copyright developed under Subaward; and (2) any rights of copyright to which a Subrecipient purchases ownership with Federal support.

### **Budget Narrative**

The funding from this grant will be utilized in three main areas in order to improve laboratory timeliness and quality. These areas include:

1. Procurement of GrayKey tools to bypass encrypted iPhones. The Laboratory's current technology does not allow our digital evidence examiners to enter modern password protected iPhones. These tools will allow access to these devices in support of criminal investigations in a timely manner. This item will be purchased using the County of Alameda approved sole source written procurement policy.
2. Procurement of Forensic Light Sources and associated materials. Effective visual examination of forensic evidence, particularly sexual assault evidence, is a vital step in the screening process of victim clothing and other materials which may have bodily fluids on them. These Forensic Light Sources will allow for the ability to visualize these stains utilizing multiple light wavelengths and photography to a higher standard than the laboratory's current technology can meet. These items will be purchased through the County of Alameda approved procurement policy which requires three quotes be obtained by different vendors.
3. Training of Forensic Examiners. The laboratory currently only has one full-time firearms examiner and requires funding to complete the training of a second, and possibly third, examiner. The Crime Laboratory will utilize an independent contractor as determined through a competitive bid process. Additionally, the laboratory has new staff in the forensic biology section who require training in biological evidence screening, DNA analysis, and DNA interpretation. Utilizing this funding, the laboratory will be able to reduce backlogs and turnaround times in support of criminal investigations. All training is to be conducted within the State of California.

### **Project Narrative**

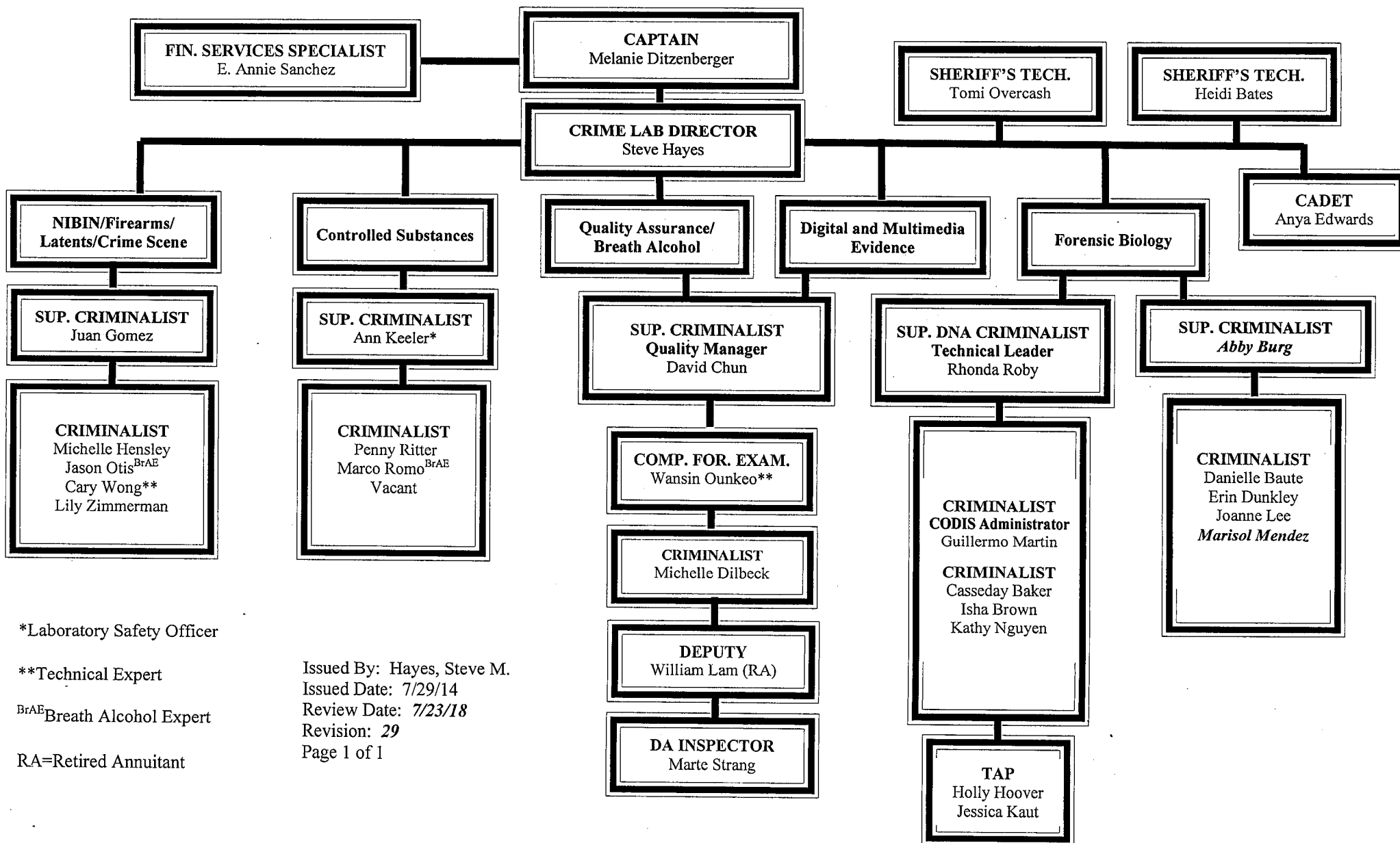
The Alameda County Sheriff's Office Crime Laboratory is a full service forensic laboratory providing services to the 1.5 million citizens of Alameda County in addition to providing controlled substances testing for the city of San Francisco. This grant proposal will address three areas in which the Laboratory needs to improve timeliness and quality in its forensic services. These areas include forensic biology testing, digital evidence examinations, and firearms examinations.

The Forensic Biology section of the Laboratory currently maintains a large backlog of cases and significant turn-around times. One phase in the analytical scheme causing these testing delays is in the initial screening of clothing and other evidence items which may contain bodily fluids. This screening involves the visual examination of evidence with traditional lighting and alternative lighting (i.e. light of different wavelengths which can oftentimes improve the visibility of body fluid stains through fluorescence or quenching). The Laboratory currently only has one alternate light source which is more than ten years old and in need of replacement in order to give examiners the best possibility of visualizing potential biological evidence. This grant funding will be used to purchase three such alternative light sources and associated supplies in order to allow Laboratory staff to simultaneously screen multiple cases and not have to wait for equipment to become available.

The Laboratory's Digital and Multimedia Evidence section is responsible for the forensic examination of digital evidence including cell phones. As encryption of these devices becomes more sophisticated, the Laboratory's tools and software are experiencing significant difficulties in bypassing passwords, thus limiting our ability to provide information to investigators. A relatively new tool which has been introduced to law enforcement agencies is the GrayKey device. This device has been demonstrated to be able to bypass encryption on iPhone devices and the acquisition of this tool will enable the Laboratory to provide investigators with useful information in support of their investigations. Currently, without the ability to bypass these security measures, our staff are unable to provide investigatively useful information.

The third area that the Crime Laboratory needs to increase its capabilities in is in the examination of firearms evidence. Currently, the Laboratory only has one full-time firearms examiner which often results in delays in the processing of firearms casework. This grant funding will be used to provide training to a criminalist to perform this important type of forensic casework.




