Thank you for meeting with us previously to discuss your documentary. Your investigation was enlightening.

Attached hereto is a copy of the Protective Order issued by the Court in our case. Natalia: Here is what has been happening.

1. Rinat has told us that Senator Jeff Sessions is willing to start an investigation into how the Magnitsky Law came about. He would explore Browder's role and presumably expose his misrepresentations to the US government, including Congress. If Sessions asks for an investigation, that fact alone would be explosive. 
