Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed <u>and</u> (2) the defendant is the one who committed it:

On November 15, 2016 at approximately 8:29 PM, officers from the Pleasantville Police Department responded to the Pleasantville High School football field for a shooting, which occurred in the home stands. As a result, Ibn Abdullah and a 10-year-old juvenile sustained life-threatening gunshot wounds. Both Abdullah and were transported to the AtlantiCare Regional Medical Center, Atlantic City Division in critical condition. was later flown to Cooper hospital in Camden, New Jersey. A second juvenile victim was also treated at the AtlantiCare Regional Medical Center, Atlantic City Division for a single gunshot wound in the forearm and was subsequently released.

Prior to being transported to the hospital, Abdullah identified the shooter as "Alvin Wyatt". The information was broadcast to all responding officers. Alvin Wyatt was stopped by officers who observed him running away from the scene. Wyatt was wearing a hooded dark jacket and grey sweatpants.

Video recording of the shooting shows a male wearing the same clothing description as Wyatt holding a handgun in his left hand and shooting at Abdullah. and were seated in the vicinity of Abdullah and were also struck. The male suspect is then seen running away from the bleachers, toward the handicap ramp. This was the same direction in which Wyatt was observed running by the officers who subsequently stopped him.

A semi-automatic handgun was recovered from underneath the bleacher's handicap ramp where Wyatt was observed running toward after the shooting.
