NARRATIVE

On Friday October 25, 2019 at approximately 2010 hours, I responded to 943 15th Place (Hurricane Grill) in reference to a disturbance. Upon arrival, I made contact with Robert Youngblood and his friends Richard Cobb and Dana Okeefe.

Youngblood stated he was sitting at the bar wearing his red "Make America Great Again" hat and a white male approached him and stated " You should go back to Russia you fucking communist." After this statement the male then slapped the brill of Youngblood's hat. The male then walked around the gate, leaned over it, spit on Youngblood and then left the scene. Both Cobb and Okeefe were sitting next to him and witnessed the altercation.

Youngblood was able to copy the tag to the vehicle he left in (Y27YML). I ran the tag, to which it came back to being registered to Laura Torres at 4130 Chardonnay Place SW. I sent a secondary unit to the address to make contact with her and the gentlemen she left the bar with, so that I can conduct a show-up.

I then made contact with the Manager of Hurricanes. The manager was able to replay surveillance video of the incident. In the video, it clearly shows the gentlemen slapping the brill of Youngblood's hat and leaning over the gate to spit on him.

I conducted a show up at 4130 Chardonnay Place SW. Upon my arrival, I made contact with Laura Torres. Torres stated she and her husband were at Hurricane's and saw the gentlemen sitting at the bar. Torres stated that she told her husband (who was later identified as Matthias Ajple) to tell Youngblood to go back to Russia as a joke, however, she did not see the altercation.

I then made contact with Matthias Ajple and conducted the show-up. Youngblood positively identified the suspect. I read Ajple Miranda, and he refused to provide a statement. However, post Miranda he utterly stated "I was just trying to protect you guys because I support Law Enforcement, trump supporters are communist and racist" Ajple also stated "I don't even care that I'm going to jail, this is actually exciting , plus I have more time on this earth then he does anyway, he probably feels so good about himself."

Ajple was placed under arrest and transported to the Indian River County Jail without incident.
