Upon information and belief, Defendant Tappan Zee Constructors LLC., entered into a contract with Defendants State of New York and New York State Thurway Authority, by which, for the consideration set forth therein, Tappan Zee Constructors LLC. agreed to supply labor and materials sufficient to perform work on a public improvement project discribed as the "Tappan Zee Hudson River Crossing Project," Contract No:"D214134". Plaintiff begs leave to refer to said contract for all its terms and conditions as if the same were set forth fully and in their entirety herein, as the same will be produced upon the trial of this action.
- 10. Thereafter, on or about July 24, 2018, Plaintiff and Defendant Tappan Zee Constructors LLC., entered into a purchase order (hereinafter the "Purchase Order"), under and by which Plaintiff agreed to provide portable toilet service required to be used or by Defendant Tappan Zee Constructors LLC., in the work to be performed under public improvement project discribed as the "Tappan Zee Hudson River Crossing Project."
- 11. Thereafter, between on or about November 2013 and on or about May 2019, Plaintiff delivered such protable toiltet service as ordered by Defendant Tappan Zee Constructors LLC., for said Defendant's consumption and use on the project.

- 13. The total amount due and owing to Plaintiff under its Purchase Order with Defendant Tappan Zee Constructors LLC., for materials and services sold and delivered is the sum of One Hundred Sixty Nine Thousand Two Hundred Ninty Six and 13/100 Dollars (\$169,296.13), no part of which has been paid although duly demanded.
- 14. That the materials furnished by the Plaintiff were actually provided for and used and consumed in the construction of the public improvement hereinbefore described, pursuant to the aforesaid contract between Plaintiff and Defendant Tappan Zee Constructors LLC., and the State of New York and the New York State Thurway Authority.

A true and correct copy of said lien is annexed hereto as Exhibit A and Plaintiff begs leave to refer to same as if set forth fully and in its entirety herein.

- 16. Pursuant to Lien Law § 11-c simultaneously with the filing of said notice of lien, in accordance with Section 12 of the Lien Law, Plaintiff served a copy of said notice of public improvement lien by certified mail, return receipt requested, on Defendant Tappan Zee Constructors LLC.
