In his initial interview, Officer Curtis lied to investigators and denied any knowledge of this ticket or ever being on I-93S. Further investigation, however, increasingly pointed to Curtis as the responsible party. Cell Site Location Information placed him on 93S in the approximate time period of this road rage incident. Detectives learned that the defendant owned 2014 white Toyota Tundra, and received insurance records showing that it had a damaged front grill. Further, all of the citations filed at C-6 from this particular ticket book were issued by Curtis.

During his second interview with the Anti-Corruption Division, the defendant affirmed that all of his previous answers were truthful. When confronted with evidence from the investigation, however, he "remember[ed] completely" and became absurd in his explanations. He described a different version of events on March 1st, and acknowledged later querying the victim's information through CJIS while on duty. The defendant admitted to writing the ticket, using a fake officer identification number, scribbling a signature, and mailing it to the victim while destroying the other copies. While he also admitted to writing the menacing note, the defendant claimed he did not intend to mail it with the ticket; it was meant to be a joke sent to another officer with a gift card.


Based on his actions, Curtis was indicted for (1) Forgery, M.G.L. ch. 267, s. 1; (2)
Uttering, M.G.L. ch. 267, s. 5; (3) False Report by a Public Employee, M.G.L. ch. 268, s. 6A;
(4) Witness Intimidation, M.G.L. ch. 268, s. 13B(b); (5) Misleading an Investigation, M.G.L. ch. 268, s. 13B(b), and; (5) Unlawfully Obtaining CORI, M.G.L. ch. 6, s. 178.

operator, he remembered that the Tundra had a damaged/missing front grill. After roughly 10 minutes, the altercation ended abruptly when the truck took an exit before entering the City of Boston.

A week later, the victim received a traffic citation in the mail inside of an envelope bearing the Boston Police Department Logo. It cited the victim \$790 for several violations, and included the following handwritten note:

WATCHED YOU GO in
And out of Traffic,
Tried Pushing my fruck
OFF the Road Just to
get into the left lane
Clocked you going over 90
in a 65. I have a 6 min
Video of You driving like an
ASS HAT, And Pulled up next
to you and took your picture,
TRY Fishtly this. I DARE YOU!



After the victim appealed the ticket to Woburn District Court, court personnel noticed irregularities with the ticket and alerted the State Police who, in turn, referred the matter to the Boston Police Anti-Corruption Division. First, the citation had an illegible signature and an untraceable officer identification number. Further, the ticket listed "State" in the agency code box, making it appear that it was issued by a State Police trooper. This particular citation, however, came from a ticket book signed out by Officer Curtis, and it was determined that Curtis queried the victim's plate through CJIS at 21:47 on the night of the incident when he was working the C-6 Last Half Shift.

COMMONWEALTH'S STATEMENT OF THE CASE


Now comes the Commonwealth in the above-captioned matter and, for the purposes of the Court's edification only, respectfully files the following Statement of the Case:

Defendant Christopher Curtis has been a police officer with the City of Boston since

2017. Following an off-duty road rage incident in Middlesex County on March 1, 2019, he later
used his CJIS access to query the victim's information, forged a traffic citation purporting to be
from the State Police, and mailed it to the victim with a menacing note provoking him to
challenge the ticket. Officer Curtis lied to detectives during an initial interview, but later
admitted to forging and sending the ticket to the victim, offering nonsensical explanations for his
actions.

* *

On March 1, 2019, the victim was driving on Interstate 93 South shortly north of Boston when, somewhere in the vicinity of Stoneham, a white Toyota Tundra approached his vehicle from behind and came dangerously close to his rear bumper. This Tundra continually honked its horn and accelerated towards the victim's vehicle before veering into the adjacent right lane and merging towards the victim. This forced the victim's vehicle halfway over the pavement grooving and within inches of the median barrier. Although the victim could not see the
