She has since traveled by plane and by car to GA, SC, NC, RI, MA, CT and has plans still to travel to VT and then NY, where our 70 year old mother resides. All of this is occurring despite our attempts to convince her that the threat from COVID-19 is very real; she has also been seen by a [REDACTED] in RI to no avail. We are deeply concerned that she could be doing this willfully despite the dangers, and that she is a danger to herself and others at this time. When confronted by authority, she will relay the appropriate "buzzwords" (social distancing being one), but to us she is denying any danger and existence of a virus whatsoever, saying that we have all been misinformed. She currently has permanent residence in Seattle, WA but is refusing to return. We do not believe that she has been practicing any social distancing whatsoever and know that she has quarantined herself away from others a total of never. We are at a loss as to what to do and are hopeful that some effort could be made to urge her strongly to return to Seattle until this is all over with. She will enter VT today, April 4, 2020, crossing the border to head for Brattleboro, VT from Meriden, CT. They are not building a surge facility. Construction The construction sector must suspend most in-person operations under the Governor's Executive Order. Only construction needed to support the COVID-19 response, maintain critical infrastructure, or for the safety, sanitation and operations of residences or businesses is allowed. As an example, replacing a failing roof, failed electrical system, or broken waterline would be acceptable. On 4/8/2020 I contacted [REDACTED] and [REDACTED] and educated them to include that they were in violation of the Governor's order and could face a \$1000.00 fine and possible criminal charges. I spoke with [REDACTED] who told me three times that he was a [REDACTED] and explained he did [REDACTED], and he was not in Vermont to work in the hospitals. I reminded him that Doctors and Nurses were coming to Vermont to care for the sick and dying and him telling me this information was not an excuse for him violating the Governor's order. [REDACTED] told me he wanted a timeline for the eviction and I advised the Dover Police were not evicting him, as such no time line would be given. I also educated him about quarantining himself and his wife. A short time later a male, believed to be [REDACTED] called the State Police to report the Dover Police were evicting him. Up until last week there were still four guys riding in the same truck. The only compromise that they were willing to make was switching the schedule around so that everyone works twenty hours. However even that is underhanded because they will only make up ninety percent of the difference. We still have to pay for insurance and taxes but now we have to do so on thirty eight hours rather than forty... We are a hardworking group up here and normally very dedicated to [REDACTED]. This situation is far from normal for us and we are feeling like we are backed into a corner. They have already fired two long time employees over this and the rest of us fear that if we don't do what they ask we will be next. There is a wastewater guy up here who would gladly come up once a day to do his duty for the state. There are also a couple people who would be willing to carry a pager in case of emergency. There is no reason for ten people to be here daily at a time like this. We would not send this email if we thought we had any other choice. We are all very hard working and would rather be working than sitting home. If the situation was normal we would be happy to have folks here and carry on with our normal routine. Staff improperly handling food items to be microwaved as clients individually wait for a single staff person to obtain and heat food. For example, not changing gloves between handling phones, keyboards, touching face/pants/belt and door then taking personal dishes. Cordless phones to be taken during responding to room in same hands as plunger and biohazard bags. No rooms have microwaves. Food donations provided nearly everyday served on floor of lobby. Left from early afternoon sometimes overnight. Toilet paper provision has been irregular for weeks. Now staff is requiring people bring used/empty roll to switch out. This is disgusting and I was redirected by the Health Dept. to complain here. That is also disgusting because exposure from cross-contamination should be addressed by the health department. *That means hundreds of sick, elderly and disabled people being temporarily housed here are REQUIRED to bring used bathroom items to lobby. Touch surfaces of room, several door handles, elevator buttons, lobby doors and hands of staff are unnecessarily exposing clean covered toilet replacement rolls? Manager informed staff, then telling me today, that people are "selling the rolls". That makes no sense. They are subsidized at exorbitant rates by Vermont state government. [REDACTED] dismisses complaints, blames rotting food smells on scientifically ignorant and nonsensical sources instead of taking responsibility and ignores requests/complaints via e-mail. [REDACTED] offered refund and gave no means of follow-up upon explanation of temporary subsidized placement by public assistance. Good Samaritan Laws absolve the service provider/charity bringing the food but does not protect recipients, nor does it hold this housing facility responsible for food recipients consuming products. They drag the mop bucket and housekeeping cart around the items on the floor, mopping with food on the floor. After 3 calls to the Health Dept. about food being left to rot on the floor, nothing has changed. As of today, the toilet paper replacement has taken effect. The GM is typically unavailable, has an irregular schedule and does not give realistic answers. She told me the only food [REDACTED] serves is breakfast, after I complained about food being put on the floor. It's disturbing to be ignored, dismissed and insulted by well-paid professionals with secure employment. Collecting food from the floor is inhumane, filthy and unhealthy. Walking around with used toilet paper rolls during a pandemic, where safe-handling instructions have been clearly outlined is dangerous. It is additionally insulting knowing that they are guaranteed weekly subsidized rates at high costs for people to live without basic cooking appliances and bathroom items.
