<b><u>About this report:</u></b>							
To avoid double-counting, recovered cases are moved to those columns from the "Positive" columns.							
<i>Testing of inmates and residents reflects decisions by facility medical providers, following appropriate guidance and in collaboration with local public health authorities.</i>							
<b><u>Total:</u></b> cumulative tests; refers to number of tests performed and completed, NOT the number of inmates or residents tested as some may have multiple samples taken.							
<b><u>Pending:</u></b> all inmates/residents awaiting test results remain in medical isolation.							
<b><u>Quarantine:</u></b> inmates/residents NOT showing symptoms but separated because they are new intakes, back from a hospital for unrelated reasons, etc.
