## About this report:

Positives are current (active) cases and not cumulative. All positive inmates are placed in isolation.

<u>Total</u>: cumulative tests; refers to number of tests performed and completed, NOT the number of inmates or residents tested as some may have multiple samples taken.

<u>Pending</u>: all inmates/residents awaiting test results remain in isolation.

<u>Quarantine</u>: inmates/residents NOT showing symptoms but separated because they are new intakes, back from a hospital for unrelated reasons, etc.

The testing of adult inmates and juvenile residents reflects decisions by DCR leadership and facility medical providers, following appropriate guidance and in collaboration with state and local public health authorities.
