



Dear Mr. Ehrenfreund

This letter confirms your retention of Kasowitz Benson Torres LLP ("Kasowitz") in connection with government and regulatory affairs services involving the federal Freedom of Information Act.

We have agreed to represent you beginning on August 26, 2020, in connection with these services. Clarine Nardi Riddle, Ann M. St. Peter-Griffith, and Matthew Greenberg will primarily be responsible for the engagement and may be assisted by other Kasowitz colleagues as necessary and advisable to meet agreed upon objectives. Kasowitz bills for its services based on the hourly time charges of its attorneys and legal assistants.
